### 1. PURPOSE

A. B. The player has neither any legal, contractual or equitable obligation to any CLUB/ ASSOCIATION/ ACADEMY, as may come into conflict with these presents, at the time of signing of this agreement.

C. It is agreed that MAXIMUS PRIME SPORTS LLP (club) will not be liable in the event of death of the player, falling sick or any injury sustained.

D. In order to ensure respective compliance, performance and due observance of the mutually agreed terms, conditions and considerations, the Parties hereto have decided to enter into this Agreement recording therein the agreed terms, conditions, stipulations and consideration.

### 2. DEFINITIONS

As used in this Agreement (including within these paragraphs) the following terms shall have these meanings:

- "MPS" shall mean Maximus Prime Sports LLP and its successor
- "AIFF" shall mean the All India Football Federation, and its successor.

- "Governing Football Rules" shall mean any and all present or future legislation, rules, regulations, directives, written policies, bylaws and constitutions, and official or authoritative interpretations thereof, and any and all amendments, Supplements, or modifications thereto, promulgated hereafter by the AIFF.
- "MPS Rules" shall mean any and all present or future legislation, rules, regulations, directives, written policies, bylaws, and constitution, and official or authoritative interpretations thereof, and any and all amendments, supplements, or modifications thereto promulgated hereafter by the Maximus Prime Sports LLP.

### 3. TERM

- F.** Not use alcohol, drugs, or foul language at any time, whether during practices, games, or otherwise. Not use physical violence or threats at any time, whether during practices, games, or otherwise.
- G.** Notify the coach or administrator in advance if you will be absent from a game or practice.
- H.** Photographic Consent - I hereby consent to and authorize the use and reproduction by MPS or anyone authorized by MPS on any photographs and/or videos that have been taken of me for any purpose, without compensation to me. MPS reserves the right to use these photographs and/or video in any of its print or electronic publications.

### 5. ROLE OF MAXIMUS PRIME SPORTS LLP (CLUB)

During the term of this agreement, the Academy / Club agrees to:

- Be ethical, honest, and honor its commitments to players and parents. Through its coaching staff, provide proper training and game coaching to players. Secure and provide a soccer facility for games and training.
- Make payments on behalf of players for the following fees and other costs:
  - Team coaching fees
  - DFA, RFA, AIFF fees.
  - Insurance coverage Facility costs

- Various types of Academy / Club training equipment
- Injury Recuperation Program (Available if need)

## **6. Undertaking by Parents (applicable if player is minor)**

During the term of this agreement, the MPS team member parent agrees to:

- Be ethical and honest, and to honor all commitments to the Academy / Club its teams, coaches, & players.
- Always behave in a sportsman like manner while attending and watching games. Treat all referees, members of the coaching staff, team administrators, and MPS with respect.
- Never interrupt or interfere during a team's training time together. Parent/coach discussions are to be held in private, not before, during, or immediately following practice sessions or game times, unless a prior appointment has been made. In all instances, the head coach shall make the final decision regarding players' position, strategy, and playing time.
- Make prompt payment to the Academy / Club and the team when all Academy / Club related fees are due and payable.
- Support and participate in fund-raising and other activities for the team and the Academy / Club. Ensure that all requirements of the player contract are fulfilled.

## **7. Disciplinary Action**

- A main goal of MPS is to have player participation be a positive experience, while each team develops its capacity to compete at the highest level possible. Towards that end, players are expected to follow the rules, regulations, and the policies of MPS. If, in the opinion of a coach or management, disciplinary action is necessary for any player, the following steps may be taken:
- Player Conference
- The team coach will discuss the situation with the player privately, in order to suggest ways to correct the problem.
- Parent Conference
- If the problem continues, the player's parents will have the opportunity to be involved with the correction of the problem, along with the coach and/or the management of MPS.
- Suspension Management Review
- If the problem continues, the coach shall refer the matter to the management which shall consider a temporary suspension of the player from all practices and games or, when appropriate, proceed with the permanent expulsion of the player from the Academy / Club.

## **8. Transfer Policy**

Inter-Academy / Club Transfer (between MPS and another Academy / Club or Organization)  
The player's may leave the club and/or transfer in accordance with AIFF academy/club rules. When a player leaves the Club prior to the end of the season, a checkout procedure with the team manager must be followed. Initially, all outstanding Club fees for the entire season must be paid. Also, any and all outstanding team fees must be paid and up to date.

## **9. Fund Raising**

All member teams are expected to participate in MPS fundraising events, and are required to provide volunteer workers in support of such functions. These events include, but are not limited to, tournaments, hosting State Cup tournament events, and other Academy / Club fundraising functions. Such events create a better Academy / Club soccer environment for MPS players and help the Academy / Club to become more financially independent. The Academy / Club's goal in

## 10. Early Termination

The Academy / Club may terminate this Agreement earlier than the date set forth in section 3. Term, as follows: Failure to comply with the MPS Code of Conduct which has been explained to player in detail, as set forth in section 7. Disciplinary Action.

The player can also be terminated because of his bad performance or ill - behavior. If the player leaves the Academy / Club upon termination of this Agreement, all outstanding player annual registration fees, player monthly dues, and player team fees and expenses shall become immediately due and payable to MPS.

## 11. Signatories to this Agreement

This agreement is to be signed by player and parent both when the player is below the age of 18 years on the date of signing this contract. In case the player has attained the age of 18 years on the date of signing this contract players signature will be sufficient for entering into a contract and parents signature shall not be required in this case.

## 12. Agreement

I have read the terms of this Academy / Club, Player, Parent Contract Agreement and I agree to be bound by them in their entirety.

**13. MPS promotes a healthy player atmosphere.** The management asks that all parents refrain from smoking tobacco and e-cigarettes (electronic cigarettes) near all player training sessions and games. This includes sidelines and practice areas. Any difference, dispute, controversy or claim "DISPUTE" which may arise between Parties out of or in relation to or in connection with this agreement, or enforcement of any clause or breach, interpretation or application shall be settled by the Parties in the first instance by conciliation amongst themselves. If the dispute can't still be resolved it is to be referred to AIFF.
