

**Georgetown – Scott County Parks and Recreation
Scholarship Application Guidelines**

Purpose: To allow residents of Georgetown/Scott County the opportunity to participate in recreational activities regardless of household financial conditions.

Who Qualifies: Any Georgetown/Scott County resident who meets the qualification standards set forth by the Georgetown – Scott County Parks and Recreation Board/Department. All applicants must present a valid picture ID to verify residency. All scholarship applications will be valid for 6 months from date of approval. Upon completion of the application and supporting documentation the applicant will be notified if the scholarship is approved or not approved.

How to Apply: Complete The Georgetown – Scott County Parks and Recreation Scholarship Application form. All Scholarship Applications must be completed during regular Parks and Recreation hours of operation Monday – Friday 8:00 am -5:00 pm. All applicable documentation must accompany the application form: Approved Reduced Lunch Program form, W-2 form, Medical Benefits form, Food Stamp Form, Social Security and/or Unemployment Statements.

Total family annual income must include the following before deductions for taxes:

- Monetary compensation for services, including wages, salary, commissions for fees;
- Net income from self-employment
- Social Security
- Public Assistance or Welfare Payments
- Alimony or Child Support Payments
- Regular contribution from persons not living in the household
- Other cash income
- Deadline for all application is at least one week prior to registration deadline for activity
- Scholarship funds cannot be applied toward late fees

Important Facts to Know

- Scholarship amounts are based on total family size and total family annual income level.
- Reduced fees will only be granted for recreation programs solely sponsored by Georgetown – Scott County Parks and Recreation Department. Youth sports scholarships are awarded by each individual sport. Please contact the sport of your choice to inquire about scholarship availability.
- Completing a Scholarship form DOES NOT register an individual for a program. Please complete the required registration for each individual activity as necessary.
- All participants are expected to pay at least 15% of an activity (this amount will vary depending on scholarship amount awarded). The percentage of the registration fee not covered by scholarship must be paid at time of registration.
- There will be a set scholarship amount available to each applicant based on the number of members in the household.
- Scholarships will be provided on a first-come, space available basis.
- Applicant's must reapply for scholarship funds every six months from the date of the initial application.
- Scholarship discounts may not be applied to 20-visit, six month, or annual Pavilion Passes. Anyone receiving a scholarship will receive 50% off the regular daily admissions fee for those listed on the approved form.
- The Georgetown – Scott County Parks and Recreation Department reserves the right to audit any household awarded a scholarship.
