Rules & Regulations

All relatives & members of Tamiami Colts, also known as "TC" and Xtreme All-Stars LLC., also known as "XA" are to comply with all Codes of Conduct at all times.

1. Only registered athletes are allowed in the practice area. (Family, friends, etc. are not allowed in the practice area).
2. Arrive at least 15 minutes early to ALL activities, unless instructed otherwise.
3. No food or gum are permitted in the practice area.
4. No body jewelry is to be worn at practice or at any competitions. (E.g. Ears, Nose, Navel, etc.).
5. Keep nails shorter than fingertips.
6. Keep hair up in a ponytail out of the athlete's face, unless instructed otherwise.
7. All trash must be disposed in the appropriate trash bins.
8. All electronics must be put on silent mode or left outside of the practice area.
9. Shoes must be worn at all times at any cheer event.
10. "TC & XA" is not responsible for any personal items lost or stolen.
11. "TC" athletes are to wear "TC" attire during all activities including practices & all external events, unless instructed otherwise. (E.g. Shirt, hair bow, etc.).
12. "TC & XA" has a NO tolerance policy on Bullying or Disrespectful behavior.
13. "TC & XA" DOES NOT tolerate athlete's being under any influence of any kind at any event.
(E.g. an illegal substance, alcohol, etc.).
14. "TC & XA" decides the roles/positions an athlete will have/play on their team.
(E.g. base, flyer, backspot, tumbler, dancer, alternate, etc.).
15. "TC & XA" may add additional practices/competitions throughout the season. If needed.
16. "XA" may move, replace, add, and/or suspend an athlete for a period of time or indefinitely from a team or the entire program.
17. Notify "XA" immediately of all expected tardiness or absences. Also providing "TC & XA" with Physician documentation. If needed. (A successful season requires all athletes present at practice).
18. Attend all "TC" activities, "TC & XA" has the right to alter routines, approach an athlete & guardian regarding numerous of absences.
19. Notify "TC & XA" immediately when an injury occurs, the athlete's safety is our top priority.
20. All athletes/parents must check their WhatsApp messages & emails daily for all updates.
21. All choreography including dances, stunts, transitions, tumbling, music selections, editing, etc. are the exclusive property of "TC & XA" & shall not be shown or discussed with others. NO VIDEOS of routines/choreography should be uploaded to any online site or social media platform!
22. If for any reason a competition item is misplaced or lost you are responsible for all fees to reorder the item(s) & notify "TC & XA" immediately.
23. If any item ordered for the athlete does not fit properly, we will reorder but you are entitled to provide all additional fees & you have 24 hours to notify "TC & XA" to adjust the item.
