- o Grounds maint. Overage (46,000) due to electrical repairs and flood.
- Concessions manager over budget due to longer fall season and flood repair and cleanup time.
- Water bill high because of the leak and water company is giving us a credit on our bill

He is working on getting a contract signed. Should have rough draft of this at next board meeting and is looking to have a 2 year commitment. Also wants contract to plainly state tournament guidelines and inclusions. Chemical inclusions will be discussed as well.

- D. Sponsorship: Mandy Clay said renewal email was sent out and we got 10,000 in renewals in 24 hours. We need more sponsors!!
