If Masters decide A.M. play, then an additional umpire will be needed to provide coverage to all divisions. In addition, if A.M. games are approved, all divisions will play 2 games a week with Veterans division playing on Monday and Wednesday: Open & Masters divisions will playing on Tuesday and Thursday.
