It is further agreed and understood that this consent shall remain in full force and effect until such time as the undersigned parent or legal guardian shall notify the South Miami Youth Baseball League in writing of the abrogation or cancellation of this consent.

I understand and agree to abide by the Rules of the South Miami Youth Baseball League, as promulgated by (SMYBL) & (Omar Diaz Sports LLC, OD Tornadoes), a Florida limited liability company, the sole and exclusive owner and operator of the South Miami Youth Baseball League, and to conduct myself in a manner consistent with the objectives of the league. The South Miami Youth Baseball League is an independently operated league which uses the facilities of Tropical Park, Miami Dade County Parks per the terms and conditions of a separate agreement between (SMYBL) & (Omar Diaz Sports LLC), and the Miami Dade Division of Parks and Recreation. The Miami Dade Division of Parks and Recreation does not have any affiliation, responsibility, liability or otherwise in connection with the South Miami Youth Baseball League and any and all matters are to be directed and addressed solely to (OD Tornadoes) & (Omar Diaz Sports LLC), . Any misconduct, profanity, or other actions detrimental to the spirit of good sportsmanship and fair play can result in expulsion from the league and park premises during the time of league play!

Covid-19 Guidelines for Sport Skills & Drills

SMYBL and Omar Diaz Sports LLC with the City Parks and Rec Dept has been working in collaboration with Miami Dade County and City of South Miami for the Following Guidelines for Sports skills/drills and practice.

1. Non-Contact Skills Training and Conditioning
 - a. Small groups-no more than 10 Athletes/coaches to a group
 - b. Adequate spacing 6 to 10 feet per person
 - c. Some sharing of sporting equipment permitted such hitting Baseball or baseball pith and catch
 - d. Maxime use of outdoor space.
 - e. NO MOCK, PICK-UP FOR SCRIMMAGE GAMES OF ANY KIND. COMPETITION IS PROHIBITED AT THIS TIME IN DADE COUNTY PARKS.

- f. FACIAL COVERING MUST BE WORN DURING PASSIVE TRAINING ACTIVITIES . FACE COVERING MAY BE ONLY REMOVED WHEN PERFORMING HIGHLY SPRINTING OR AGILITY TRAINING. COACHES WILL ADVISE.
- g. Sports skills /drills/practices are limited to participants, coaches and staff only. To avoid large gatherings, Family Spectators shall observe social distancing both within groups and with others. City Staff or Police may remove individuals or close parks at any time based on concerns of maintaining public health..
- h. Temperature checks for coaches and participants shall be done before skills training begins. Temperature of 100 or above, the participant or coach will not be able to attend the training.
- i. All players are encourage to bring their personal equipment. Minimize players contacts of handshakes and High fives.
- j. Athletes to bring water bottles ,gatorade to refill in the water fountains since concessions stand is temporally close.
- k. The CDC advises that adults and children with Covid-19 who experienced symptoms or those who DID NOT have COVID-19 symptoms but tested positive should not return to the program until they have met CDC's criteria to discontinue home isolation.
- l. Omar Diaz, owner of Omar Diaz Sports and President of SMYBL should be notified at smybl12@aol.com immediately if anyone involved in the program becomes sick with COVID-19 symptoms, test positive for Covif-19, or have been exposed to someone with symptoms. Anyone who fails to do so will not be allowed to enroll their child or ward in the program in the future.
- m. In accordance with state and local laws and regulations, the Academy/OD Sports LCL will notify local health officials, staff and families immediately of any case of COVID-19 while maintaining confidentiality in accordance with Americans with Disabilities Act (ADA) or applicable laws.
