As of the date below, the undersigned applicant or applicants jointly, each being duly sworn, make the following statements under oath—and under penalty of perjury—in connection with a loan they are applying for through the Keep My Tennessee Home Principle Reduction w/Recast and Lien Extinguishment Program (“PRRPLE”) or the Reinstatement Only Program (ROP) from the Tennessee Housing Development Agency (“THDA”) to applicant or applicants:

1. All of the representations, certifications and agreements made by me in each of the following KMTH documents, which are incorporated into this Affidavit by this reference, are true and correct as of the date below and are hereby ratified and affirmed by me:  
  
Terms and Conditions, Online Application, Hardship Affidavit, Form 4506-T, Third Party Authorization, and all other documents utilized by THDA in administering the PRRPLE and ROP.
2. All information provided to THDA in or with respect to the following items, which are incorporated into this Affidavit by this reference, is true and correct as of the date below, and is hereby ratified and affirmed by me:  
  
Bank Statements, Pay Stubs, Tax Returns, W-2 Forms, and all other information relied on by THDA in administering the PRRPLE and ROP.

10. I am not violating any contract or court order by closing the PRRPLE or ROP loan.
11. All persons who have executed or will execute documents conveying or encumbering the Property are at least 18 years old and are legally able to execute the PRRPLE or ROP documents.
12. The Affidavit is given for the benefit of THDA knowing that THDA will rely upon all statements I have made in it in connection with the PRRPLE or ROP loan. I am aware that I am obligated to amend or supplement the information provided in this Affidavit if any of the facts that I have stated above should change prior to closing of the loan. These statements shall survive the closing of this loan.
13. I agree to indemnify and hold THDA harmless against all loss or expense on account of any matter or thing which is misstated in this Affidavit.
