## 2014 Transitional Reinsurance Contribution Filing Deadline Extended

On Friday, November 14, the Centers for Medicare and Medicaid Services (CMS) extended the November 17, 2014 deadline for contributing entities (employers with self-insured medical plans) to submit their 2014 enrollment counts for the transitional reinsurance program. The deadline has been extended until 11:59 p.m. on Friday, December 5, 2014. The January 15, 2015 and November 15, 2015 payment deadlines remain the same.

As a reminder, employers that sponsor self-insured major medical plans must report their annual enrollment count to the U.S. Department of Health and Human Services via the [pay.gov](http://www.pay.gov) website by December 5, 2014, as part of the Affordable Care Act's transitional reinsurance program.
