NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. ELIGIBILITY: The Sweepstakes is open to individuals who (a) are legal U.S. residents residing in Texas, (b) possess a valid driver's license, and (c) are twenty-five (25) years of age or older at the time of entry. Void where prohibited. Employees, officers and directors of The Southern Region Advertising Council, Inc. ("Sponsor"), BMW of North America LLC ("BMW NA"), participating BMW dealerships, Genesco Sports Enterprises ("Administrator"), their respective parent, subsidiary and affiliated companies, Web design, advertising and promotion agencies involved in the administration, development, fulfillment and execution of this Sweepstakes (collectively "Sponsor and Promotion Parties"), IMG College/Longhorn Sports Properties ("IMG"), the University of Texas Athletics Department ("University"), their respective IRS dependents, immediate family members (spouse, parent, child, sibling and their respective spouses), and individuals residing in their same household are not eligible to participate or win. The Sweepstakes is subject to applicable federal, state, and local laws and regulations. Sponsor reserves the right, at any time, to verify eligibility requirements in any manner it deems appropriate. By participating, participants agree to these Official Rules, which are final and binding in all respects.
- **2. SWEEPSTAKES TIMING:** Sweepstakes begins on August 2, 2021, at 8:00:00 a.m. Central Time ("CT") and ends on September 20, 2021 at 11:59:59 p.m. CT ("Sweepstakes Period"). The time clock of the computer administering this Sweepstakes is the official time-keeping device of the Sweepstakes.
- **3. TO ENTER:** During the Sweepstakes Period, visit bmwhookemonthehighway.eventsbmw.com ("Website") and follow the online instructions to register and submit an online entry to receive one (1) entry into the random drawing. Individuals may also enter by visiting the BMW display at the Texas Alumni Center during a football game on either September 4, 2021 or September 18, 2021. At the game, eligible individuals may use Administrator's mobile device or their own mobile device to register and submit an online entry to receive one (1) entry into the random drawing. To receive one (1) bonus entry into the Sweepstakes, visit your local Austin BMW Center and take a test drive. **Limit one (1) entry and one (1) bonus entry per person/email address for the entire Sweepstakes Period.**

Participant's submission must be manually keystroked or entered by the individual participant. Multiple participants may not share the same email address. A potential winner may be requested to provide Sponsor with proof that he/she is the authorized account holder of the email address associated with the winning entry and/or an eligible participant. Automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or sweepstakes service) will be disqualified and transmissions from these or related email addresses/IP addresses may be blocked. Additionally, if it is discovered that a participant used multiple identities, email addresses, phone numbers and/or mailing addresses or manipulated such

- **4. The University will determine the date of the one (1) night stay, in its sole discretion, once the game time is determined. No other date shall be offered. Winner will also receive the use of a BMW to drive to and from the game ("Extended Test Drive") and a \$200.00 gift certificate to University Co-op (subject to terms and conditions as set by issuer). **Parking, meals, gratuities, and all other expenses not specified herein are solely the winner's responsibility.** Approximate Retail Value ("ARV"): \$900.00.

Extended Test Drive conditions: The winner shall be required to sign a standard BMW Liability Waiver and a standard BMW NA lease or loan agreement. Terms and conditions apply; gasoline, taxes, destination and insurance (if applicable) are extra and are not covered by Sponsor. Other terms, including but not limited to, mileage limits and condition of car upon return, apply and other costs associated with the vehicle, including, but not limited to, any travel and transportation costs associated with collecting and returning the vehicle (the designated BMW dealership closest to winner's home) are solely the responsibility of the winner. Winner is required to present a valid driver's license and proof of insurability prior to accepting the vehicle. Except where legally prohibited, winner grants (and agrees to confirm such grant in writing) permission to Sponsor and those acting under its authority the right to the use of his/her name, picture, likeness, voice, and biographical information and statements, at any time or times, for advertising, trade, publicity, and promotional purposes without additional compensation, in all media now known or hereafter discovered, worldwide and on the Internet, without notice, review or approval.

information. Released Parties are not responsible for any incorrect or inaccurate information, caused by any equipment or programming associated with or utilized in this Sweepstakes; and assume no responsibility for any error, omission, interruption, deletion, defect or delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or tampering with or hacking of any equipment used for Sweepstakes. portion that is deemed invalid, unenforceable, or illegal is that claims will not be arbitrated on a class or representative basis, then the entirety of this arbitration provision shall be null and void, and neither claimant nor Sponsor shall be entitled to arbitrate their dispute. Upon filing a demand for arbitration, all parties to such arbitration shall have the right of discovery, which discovery shall be completed within sixty days after the demand for arbitration is made, unless further extended by mutual agreement of the parties. THE ARBITRATION OF DISPUTES PURSUANT TO THIS PARAGRAPH SHALL BE IN THE PARTICIPANT'S INDIVIDUAL CAPACITY AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING. THE ARBITRATOR MAY NOT CONSOLIDATE OR JOIN THE CLAIMS OF OTHER PERSONS OR PARTIES WHO MAY BE SIMILARLY SITUATED. DO NOT ENTER THIS SWEEPSTAKES IF YOU DO NOT AGREE TO HAVE ANY CLAIM OR CONTROVERSY ARBITRATED IN ACCORDANCE WITH THESE OFFICIAL RULES. By entering, participants consent to the jurisdiction and venue of the federal, state, and local courts located in Greenville County, South Carolina, USA.
