I warrant and represent that the Minor is not a member of ACTRA or any other performer's union and agree that neither I nor the Minor shall not have any right of approval, claim to additional compensation or benefit, or claim (including, without limitation, claims based upon invasion of privacy, defamation, or right of publicity) arising out of any use or any blurring, distortion, alteration, optical illusion, or use in composite form of the Information, whether or not intentional.
- 5. I am over the age of majority in my province or territory of residence and am the parent or legal guardian of the Minor and I have the authority to enter into this Consent and Release of Liability Agreement on behalf of the Minor.
