All cancellations must be received at least 24h before your training session in order to avoid being charged.

You will be able to reschedule this appointment when it works for you and your coach. Subsequent short notice cancellations will be missed. The free short-notice cancellation only applies if Attain Health or your trainer is given notice prior to the session start time. No shows are not eligible for the free cancellation.
