In your personal and private capacity.

Take Notice that;

- 1. We, the 'soul', 'Alex', and the living being we are incarnated into, 'Trevor John', of the family Alexander, are Non-alien & Non-citizen.
- 2. The living being we are incarnated into, 'Trevor John', of the family Alexander, was born on the land known as Terra Australis.
- 3. The 'soul', 'Alex', and the living being we are incarnated into, 'Trevor John', of the family Alexander, are not in any way or definition the legal 'person' or 'natural person' TREVOR JOHN ALEXANDER, nor TREVOR J ALEXANDER, nor TREVOR ALEXANDER, nor any such CAPITAL-LETTERED variation of such, in any way. The 'soul', 'Alex', and the living being we are incarnated into, 'Trevor John', of the family Alexander, renounce, rebut, disassociate and reject that the corporate entity POLICE DEPARTMENT (VIC) ABN 63 446 481 493 and/or all of its trading names has any authority or jurisdiction over us in any way. (refer unchallenged Affidavit signed, witnessed and sealed 8 August 2019, served on Minister of Police and Chief Commissioner, 13 Aug 2019. Paragraph 44)
- The 'soul', 'Alex', and the living being we are incarnated into, 'Trevor John', of the 6. family Alexander, unless we specifically contract, and that written and signed contract can be produced as proof on demand, do not acknowledge or consent that the corporate entity POLICE DEPARTMENT (VIC) ABN 63 446 481 493 and/or all of its trading names, and/or all of its employees, has any authority or jurisdiction over us in any way. The 'soul', 'Alex', and the living being we are incarnated into, 'Trevor John', of the family Alexander, renounce, rebut, disassociate and reject that the corporate entity ROADS CORPORATION ABN 61 760 960 480 and/or all of its trading names, and/or all of its employees, has any authority or jurisdiction over us in any way. (refer unchallenged Affidavit signed, witnessed and sealed 8 August 2019, served on Secretary ROADS CORPORATION trading as Vic Roads, 13 Aug 2019. Paragraph 46)
 - 8. The 'soul', 'Alex', and the living being we are incarnated into, 'Trevor John', of the family Alexander, unless we specifically contract, and that written and signed contract can be produced as proof on demand, do not acknowledge or consent that the corporate

and/or all of its employees, has any authority or jurisdiction over us. (refer unchallenged Affidavit signed, witnessed and sealed 8 August 2019, served on Secretary ROADS CORPORATION trading as Vic Roads, 13 Aug 2019. Paragraph 47)

- 9. The 'soul', 'Alex', and the living being we are incarnated into, 'Trevor John', of the family Alexander, has the unalienable right to free and unrestricted travel on the land.
- 10. The 'soul', 'Alex', and the living being we are incarnated into, 'Trevor John', of the family Alexander, often travels on the land of Terra Australis in a 1999 Gold Nissan Pathfinder owned by the 'soul', 'Alex', and the living being we are incarnated into, 'Trevor John', of the family Alexander, that ownership registered, pursuant to the Statute of Monopolies 1623, the Australian Consumer Law, and Competition and Consumer Act 2010, with the PPSR, The International Common Law Court, and THE MOOT COURT OF TERRA AUSTRALIS INCOGNITO, ABN 70 623 896 376.

Unlawful engagement and detention or to attempt to coerce business by any member of the corporation POLICE DEPARTMENT (VIC) trading as VICTORIA POLICE incurs fees; starting with an engagement fee of Fifty Thousand Dollars AuD (\$50,000) per employee/member of VICTORIA POLICE

- 13. You, members/employees/"officers", are given **Notice to Cease and Desist** from any and all unlawful stops, and detentions of the above identified 1999 Gold Nissan Pathfinder, especially if those unlawful stops and detentions are committed with the fraudulent intent to coerce the 'soul', 'Alex', and the living being we are incarnated into, 'Trevor John', of the family Alexander, into business negotiations and/or contract.
- 14. Any and all unlawful stops, engagements and/or detentions, and/or any attempts to coerce business or contract by any member of the corporation POLICE DEPARTMENT (VIC) ABN 63 446 481 493 trading as VICTORIA POLICE will incur fees; starting with a non-negotiable engagement fee of Fifty Thousand Dollars AuD (\$50,000) per employee/member of VICTORIA POLICE who is a party to, and complicit in, the unlawful detention and attempt to coerce contract.
- 15. Additional fees incurred will be, depending on the actions undertaken by the members/employees/"officers" present, as listed in the attached schedule.

16. Your failure to carry out, and/or abide by the Notice of Cease and Desist in any

irrevocable Estoppel by Acquiescence, forevermore barring any member/employee/"officer" of the corporation POLICE DEPARTMENT (VIC) ABN 63 446 481 493, trading as VICTORIA POLICE, in your personal and private capacity, or any and all of your agents, or principals, from bringing any and all claims, legal actions, orders, demands, lawsuits, charges, levies, penalties, damages, interests, liens or expenses, whatsoever, against the 'soul', 'Alex', and/or the living being we are incarnated into, 'Trevor John', of the family Alexander.

- 17. You have seven (7) days (until 10 July 2020) to dispute, with hard evidence annexed as part of a sworn affidavit of rebuttal, and signed under penalty of perjury, any statement made on this Notice.
- 18. Your tacit acquiescence in this matter and/or failure to respond in the allotted time, will be taken as your full acceptance and compliance of this **Notice to Cease and Desist** and means your full acceptance and agreement herein of the terms of this **Notice to Cease and Desist** and the full acceptance of the ramifications if any member/employee/"officer" of the corporation POLICE DEPARTMENT (VIC) ABN 63 446 481 493, trading as VICTORIA POLICE, in your personal and private capacity, or any and all of your agents, or principals, fail to adhere to the terms as stated in this **Notice to Cease and Desist**.

In addition, the 'soul', 'Alex', and the living being we are incarnated into, 'Trevor John', of the family Alexander, 'reserve all rights to take lawful and/or legal remedy, in any manner in which I/we choose, against any member/employee/"officer" of the corporation POLICE DEPARTMENT (Vic) trading as VICTORIA POLICE, in your personal and private capacity, who breaches this, or who is a party to, and complicit in, the breaching of this **Notice to Cease and Desist.**

Schedule of Fees for Unlawful Stop and/or Detention

We rebut any and all claims that POLICE DEPARTMENT (Vic) ABN 63 446 481 493, and/or any and all of its employees, has any authority over us, note that you are now, in effect, acting without authority as a private citizen.

As State and territory general duty police officers carry on their person any or all of: a loaded pistol (particularly Glock or Smith & Wesson semiautomatic), OC spray, baton, handcuffs, and a taser. You only have authority to carry these weapons whilst rostered on duty <u>and</u> when you are acting with your claimed authority as an Officer of POLICE DEPARTMENT (Vic) ABN 63 446 481 493, particularly when acting against a citizen who has committed a Common Law crime or a living being that has has consented to your authority.

- We are not a citizen, nor an alien. We are a Non-citizen, and a Non-alien.
- We are a national of Terra Australis
- We do not consent to your authority.
- We rebut any and all presumptions of law.

You have no authority over us and are now an illegally-armed private civilian detaining us. Any actions you take from this point onward makes you personally and privately liable to criminal and civil charges, I.e. Unlawful Detention, Conspiracy to Defraud, Kidnap, Armed Robbery, Assault and Battery, etc.

False imprisonment occurs whenever one person acts, without lawful authority, to intentionally cause the detention and/or confinement of another living being and the law recognises that the shock of being told one is under arrest is important to assessing the impact of an unlawful arrest. Therefore, if you continue to unlawfully detain us against our will, it is taken that you understand, consent to, and are personally, and in the private, liable to, the fees as outlined in the schedule included in this Notice. Note that any action you take from this moment may also be in breech of our claim of Diplomatic immunity.
