

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.montessori-courses.com and Montessori Courses and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Montessori Courses include www.montessori-courses.com. The Montessori Courses website is a educational courses site. By using the Montessori Courses website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Montessori Courses may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address

If you purchase Montessori Courses's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. Sharing Information with Third Parties
