3 RESOLUTION OF ADVISABILITY AND AUTHORIZATION NO. 7321

5 A RESOLUTION introduced by Mayor Harry Felker authorizing Street
6 Improvement Project No. 60427-02, located at approximately
7 SW Colly Creek Drive and SW Moundview Drive, as more
8 specifically described herein.

9
10 WHEREAS, the City Council has received a petition, pursuant to K.S.A. 12-6a04,
11 containing the signatures of the owners of 100% of the area in the improvement district
12 hereinafter described; and

13 WHEREAS, seven (7) days have elapsed since the filing of said petition.

14 NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Topeka,
15 Kansas, that it finds the Street Improvement Project No. 60427-02, hereinafter described,
16 to be advisable and does hereby authorize and order said improvement to be made in
17 accordance with its findings as follows:

18 A. GENERAL NATURE OF IMPROVEMENT:

19 To pave SW Colly Creek Drive to SW Moundview Drive from North end of
20 existing pavement of SW Colly Creek Drive to South end of pavement of SW
21 Moundview Drive.

23 To improve drainage channel and construct a reinforced concrete box culvert
24 under Colly Creek Drive.

26 B. PROPOSED IMPROVEMENT DISTRICT:

27 Lots 6 through 18, Block "E", Lots 50 through 63, Block "C", all in Colly Creek
28 Subdivision No. 3.

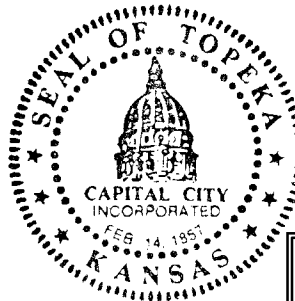
