3 RESOLUTION OF ADVISABILITY AND AUTHORIZATION NO. 7405

5 A RESOLUTION introduced by Deputy Mayor Duane Pomeroy authorizing
6 Street Improvement Project No. 60389-03 H, located at
7 approximately SE 44th Street and SE Oakview Lane, as more
8 specifically described herein.
9

10 WHEREAS, the City Council has received a petition, pursuant to K.S.A. 12-6a04,
11 containing the signatures of the owners of 100% of the area in the improvement district
12 hereinafter described; and

13 WHEREAS, seven (7) days have elapsed since the filing of said petition.

14 NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Topeka,
15 Kansas, that it finds the Street Improvement Project No. 60389-03 H, hereinafter
16 described, to be advisable and does hereby authorize and order said improvement to be
17 made in accordance with its findings as follows:

18 A. GENERAL NATURE OF IMPROVEMENT:

20 To pave:

22 SE Oakview Lane from the existing pavement at the south line of Lot 8,
23 Block "A", Oakwood Hills Subdivision northerly to the existing at the north
24 line of Lot 12 Block "A", Oakwood Hills Subdivision and SE 44th Street from
25 the west line of Lot 1, Block "C", Oakwood Hills Subdivision easterly to the
26 westerly line of Lot 7, Block "C", Oakwood Hills Subdivision with 29 foot wide
27 pavement and cul-de-sac including concrete curb and gutter, sidewalk
28 ramps, storm drainage facilities, engineering, and all other contingencies
29 needed to complete the project.

31 B. PROPOSED IMPROVEMENT DISTRICT:

33 Lots 8 through 13, Block "A"; Lots 1 through 15, Block "C"; Oakwood Hills
34 Subdivision, in the City of Topeka, Kansas.

C. ESTIMATED OR PROBABLE COST:

\$163,800.00

D. METHOD OF ASSESSMENT:

On a unit basis for all lots or parcels which are included in the improvement district.

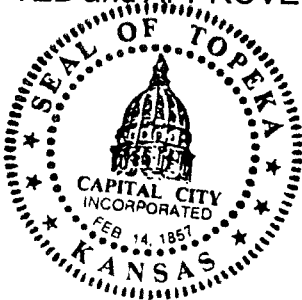
E. APPORTIONMENT OF COSTS:
