3 RESOLUTION OF ADVISABILITY AND AUTHORIZATION NO. 7419

5 A RESOLUTION introduced by Deputy Mayor Duane Pomeroy authorizing
6 Street Improvement Project No. 60598-01 H, located at
7 approximately SE 22nd Terrace and SE Croco Road, as more
8 specifically described herein.
9

10 WHEREAS, the City Council has received a petition, pursuant to K.S.A. 12-6a04,
11 containing the signatures of the owners of 100% of the area in the improvement district
12 hereinafter described; and

13 WHEREAS, seven (7) days have elapsed since the filing of said petition.

14 NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Topeka,
15 Kansas, that it finds the Street Improvement Project No. 60389-03 H, hereinafter
16 described, to be advisable and does hereby authorize and order said improvement to be
17 made in accordance with its findings as follows:

18 A. GENERAL NATURE OF IMPROVEMENT:

20 To construct SE 22nd Terrace from SE Croco Road east approximately 365
21 feet and SE Aspen Court from SE 22nd Terrace to north end of cul-de-sac.
22 This project will provide for concrete curb and gutter, asphalt pavement,
23 storm drainage facilities, and all other contingencies needed to complete the
24 project.

26 B. PROPOSED IMPROVEMENT DISTRICT:

28 Lots 1 through 8, Block "A"; Lots 1 through 4, Block "B"; Woodglen
29 Subdivision, in the City of Topeka, Kansas.

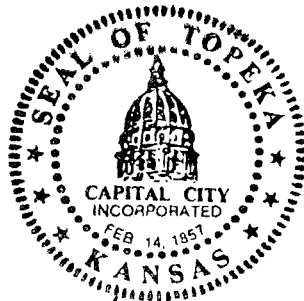
