8	WHEREAS, Ordinance No. 17796 directs that expenditures from this fund be for
9	crime prevention services and be specifically authorized by resolution of the City Council;

11	WHEREAS, the City Council previously passed Resolution Nos. 7268, 7574, 7575
12	and 7693 authorizing certain expenditures from the Crime Prevention Fund; and
13	WHEREAS, the City Council and the Chief of Police desire to make expenditures
14	from the Crime Prevention Fund in addition to those set forth in Resolution Nos. 7268,
15	7574, 7575 and 7693; and
16	WHEREAS, the Weed & Seed project promoted a "peace camp" at Washburn
17	University on or about February through June, 2005; and
18	WHEREAS, the Weed & Seed project reimbursed Washburn University for the
19	camp attendees from Weed & Seed areas; and
20	WHEREAS, Weed & Seed grant money cannot be used to fund projects or events
21	involving participants from non Weed & Seed areas; and
22	WHEREAS, many participants who attended the peace camp were from non Weed
23	& Seed areas, but were benefited by their attendance at the camp; and
24	WHEREAS, camp participants from non Weed & Seed areas received training
25	designed to prevent them from being victims of crime; and

26	WHEREAS, the City of Topeka desires to reimburse washburn University for camp
27	participants from non Weed & Seed areas;
28	NOW, THERFORE, BE IT RESOLVED, the Chief of Police is authorized to expend
29	monies from the Crime Prevention Fund for the following purpose: To reimburse Washburn
30	University with funds not to exceed \$4,500.00 to pay for the attendance of peace camp
31	participants from non Weed & Seed areas.
32	BE IT FURTHER RESOLVED that any expenditures from the Crime Prevention
33	Fund shall not be used for personnel or operating costs of any agency receiving such
34	funds.
