

2023 City of Topeka Annual Water Quality Report Covering Calendar Year 2022

This report is a snapshot of the quality of the water we provided last year. It includes details about where your water comes from, what it contains, and how it compares to Environmental Protection Agency (EPA) and state standards. The City of Topeka withdraws water from the Kansas River using two intakes on the south bank. The intakes are capable of pumping up to 110 million gallons of untreated water per day and Topeka consumes an average of 21 million gallons per day. Contaminants may be present in the source water before it is treated. These contaminants may include: <u>Microbial contaminants</u>, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife. <u>Inorganic contaminants</u>, such as salts and metals, which can occur naturally or result from storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming. <u>Pesticides and herbicides</u>, which may come from a variety of sources such as storm water runoff, agriculture and residential users. <u>Radioactive contaminants</u>, which are by-products of industrial processes and petroleum production, may come from gas stations, urban storm water runoff and septic systems. In order to ensure that tap water is softe to drink, the Environmental Protection Agency (EPA) provides regulation which limits the amount of certain contaminants in water provided by public water systems. We treat our water according to EPA's regulations.

During the 2022 calendar year, we had the below noted violation of drinking water regulations. We monitor for turbidity twenty-four hours per day and seven days per week. This tells us whether we are effectively filtering the water because turbidity can interfere with disinfection and provide for microbial growth. Turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses, and parasites which can cause symptoms such as nausea, cramps, diarrhea, and associated headaches. Water samples for March 2022 showed that 6 percent of turbidity measurements were over 0.3 turbidity units. The standard is that no more than 5 percent of samples may exceed 0.3 turbidity units units or granic matter into the river. Our filtering process was impacted by these high turbidity levels and was unable to treat the water to the full compliance levels for approximately 13 hours. We continue to monitor the quality of water in the Kansas River and make appropriate chemical and plant process changes to produce drinking water that meets or exceeds water quality standards.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as those with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers.

The sources of drinking water (both tap and bottled water) include rivers, lakes, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. Food and Drug Administration regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

EPA/CDC (Centers for Disease Control and Prevention) guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the EPA's Safe Drinking Water Hotline (1-800-426-4791). *Cryptosporidium* is a microbial parasite found in surface water throughout the United States. Although filtration removes *Cryptosporidium*, the most commonly used filtration cannot guarantee 100% removal. Monitoring of our source water indicates the presence of these organisms. Current test methods do not allow us to determine if the organisms are dead or if they are capable of causing disease. Symptoms of infection include nausea, diarrhea, and abdominal cramps. Most healthy individuals can overcome the disease within a few weeks. However, immuno-compromised individuals are encouraged to consult their doctor regarding precautions to take to avoid infection. *Cryptosporidium* must be ingested to cause disease, and it may spread through other means than drinking water. Our water system collects and tests a minimum of 100 samples per month in accordance with the Revised Total Coliform Rule for microbiological contaminants. Coliform bacteria are usually hamless, but their presence in water can be an indication of disease-causing bacteria. When coliform bacteria are found, special follow-up tests are done to determine if harmful bacteria are present in the water supply. If limits are exceeded, the water supplier must notify the public.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Your water system is responsible for providing high quality drinking water, but cannot control the variety of material used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. The following tables list all of the drinking water contaminants which were detected during the 2022 calendar year. The presence of these contaminants does not necessarily indicate the water poses a health risk. Unless noted, the data presented in this table is from testing done January 1– December 31, 2022. The state requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year. Some of the data, though representative of the water quality, is more than one year old. **The bottom line is that the water provided to you is safe.**
