FACT SHEET 2019 Host Cities and Venues

PROLOGUE – Monday, Aug. 12

Snowbird Resort

- 12th consecutive year as host venue, most recently 2018
- First year to host the overall start of the Tour, including the Team Presentation
- Snowbird Resort sits in the Uinta-Wasatch-Cache National Forest. The resort is accessible through Little Cottonwood Canyon using a famous six-mile climb with gradients between 8-12 percent
- Snowbird Resort is well known for its steep free-skiing terrain and abundant powder in winter and its mountain coaster, alpine slide and the Big Mountain Trail, an 8-mile mountain bike trail, in summer. Year round it features four award-winning mountain restaurants and the Cliff Spa
- Located 20 miles southeast of Salt Lake City
- Base elevation 7,760 feet; Snowbird is part of unincorporated Salt Lake County

STAGE 1 – Tuesday, Aug. 13

North Logan City

- First-time host venue
- Located in the Cache Valley, 86 miles north of Salt Lake City and 26 miles south of Idaho State line
- A suburban community next to Logan City, which has hosted the Tour twice before
- The city is in the Cache Valley on the western slopes of the Bear River Mountains
- Elevation 4,692 feet; population 10,646

STAGE 2 – Wednesday, Aug. 14

Brigham City

- Second-time stage start venue (2017)
- Located in Box Elder County just 25 miles north of Ogden, the city sits on the western slope of the Wellsville Mountains, part of the Wasatch Range
- Elevation 4,436 feet; population 18,000

Powder Mountain Resort


- Second-time host venue (2014)
- The year-round resort, known as Pow Mow, sits on the Weber and Cache county lines, 25 miles northeast of Ogden and 10 minutes east of Eden
- Largest ski area in the U.S. with 8,464 acres of skiable terrain
- In summer the resort offers more than 25 miles of cross-country mountain bike trails
- Elevation 8,900 feet at Hidden Lake Lodge

STAGE 3 – Thursday, Aug. 15

Antelope Island State Park

- Fourth-time host venue (2015, '16, '18)
- Antelope Island State Park is located in Davis County, accessible by a seven-mile causeway from Syracuse
- Largest of 10 islands in the Great Salt Lake at 15 miles long and five miles wide
- Elevation at shoreline 4,200 feet; highest peak on Antelope Island is Frary Peak, 6,596 feet

North Salt Lake



- First-time host venue
- Located in Davis County next to Bountiful on the western slopes of the Wasatch Range, 24 miles north of Salt Lake City
- Elevation 4,334 feet; population 20,507

STAGE 4 – Friday, Aug. 16

Salt Lake City

- 12th year as a host city, most recently 2018
- Has hosted a circuit race seven times (2006, '08, '11, '13, '15, '17, '18)
- State Capital of Utah, located in Salt Lake County
- Elevation 4,226 feet; metropolitan area population 1.1 million

STAGE 5 – Saturday, Aug. 17

Canyons Village at Park City Mountain

- Second-time host venue (2018)
- Canyons Village at Park City Mountain is a celebrated four-season destination that includes golf, mountain biking, hiking, scenic gondola rides, skiing, snowboarding and world-class lodging and amenities
- This is one of two base areas at Park City Mountain, the largest ski destination in the U.S. with more than 7,300 acres, 348 trails and 41 lifts
- Base elevation 6,800 feet

STAGE 6 – Sunday, Aug. 18

Park City

- 10th year as a host city, most recently in 2018
- Seventh time as the overall finish host city
- The town is home to two year-round resorts, Deer Valley Resort and Park City Mountain Resort
- Within the city limits, elevation ranges from 6,720 feet to 8,460 feet, with surrounding Wasatch Mountains rising to 10,000 feet; population 8,378
