BASIC WARRANTY - 24 MONTHS 2,400 HOURS

Toyota Material Handling, U.S.A., Inc., 5559 Inwood Drive Columbus, IN 47201 (hereinafter: "Toyota"), warrants that each new Toyota AWP listed above shall be free, under normal use and maintenance from defects in material or workmanship for a period of twenty-four (24) months from the date of first use or the first 2,400 key on hours, whichever occurs first.

MAIN HYDRAULIC PRESSURE PARTS WARRANTY - 36 MONTHS 3,600 HOURS

For a period of thirty-six (36) months from the date of first use or the first 3,600 key on hours, whichever occurs first. Toyota warrants the following main oil pressure parts. Main oil pressure parts include pump, cylinder, valve and motor.

MAIN STRUCTURE PARTS WARRANTY - 60 MONTHS 6,000 HOURS

For a period of sixty (60) months from the date of first use or the first 6,000 key on hours, whichever occurs first. Toyota warrants the following main structure parts only Main structure parts include boom, turntable, frame, outrigger, rotation bearing, rotation gear box, mast, scissors arm, aerial tower booms and elevation posts. The rotation bearing will only be covered for sixty (60) months provided maintenance services are performed in accordance with operation manual issued by Toyota. **Labor, travel or any other costs incurred are not covered under the main structure parts warranty.**

DIESEL ENGINE WARRANTY - 24 MONTHS 2,000 HOURS

For a period of twenty-four (24) months from the date of first use or the first 2,000 key on hours, whichever occurs first.

For TNV Series Engines only, an extended limited warranty of thirty-six (36) months from the date of first use or the first 3,000 key on hours, whichever occurs first, is provided for these specific parts only: the cylinder block, cylinder head, crankshaft forging, connecting rods, flywheel, flywheel housing, camshaft, timing gear and gear case.

COVERAGE

During the specified warranty period, any defect in material or workmanship in any warranted item in a Toyota AWP shall be repaired or replaced at Toyota's option without charge by any authorized Toyota Material Handling, U.S.A., Inc. AWP dealer located within the Continental United States of America and Canada.

EXCLUSIONS AND LIMITATIONS

The warranties contained herein shall not apply to or include any of the following.

1. Repair or replacement required as a result of: (i) accident; (ii) misuse or neglect; (iii) lack of reasonable and proper maintenance; (iv) repairs improperly performed or replacements improperly installed; (v) use of replacement parts or accessories not conforming to Toyota's specifications which adversely affect performance and/or durability; (vi) alterations or modifications that are not recommended or approved in writing by Toyota; and/or (vii) wear or ingestion of dirt into engine or hydraulic system due to lack of appropriate maintenance in normal or severe service operating conditions, such as foundries, lumber yards, cement plants or other dusty or severe uses, and deterioration of appearance items due to normal use or exposure.
2. Normal replacement of service and consumable items, such as, but not limited to, tune-up parts, lubricants, oil filters, fuel filters and air filters that are listed in the scheduled maintenance table of the Service Manual.

3. All normal maintenance adjustments and services, such as, but not limited to: wheel, brake and load handling systems that are listed in the scheduled maintenance table of the Service Manual.
4. Items subject to normal wear and tear, noise, vibration, or deterioration, such as, but not limited to brake linings, brake pads, motor brushes, contact tips, belts, slider, roller, sub boom, safety belt attachment, winch ropes, rope wire, chain, oil pressure hose, wheel stop, jack base, light bulbs, fuses, brush for charge, name plate, clutch, gaskets, grease oil seals and paint.
5. Tires and tubes.
6. Batteries
7. Options, accessories or attachments not manufactured by Toyota.
8. Vehicles operated outside the Continental United States of America and Canada.
9. Vehicles not registered in the Toyota Warranty System.

LIMITED REMEDY

- 1.0 The remedy under the warranties contained herein is limited solely to the repair of defects in material or workmanship by an authorized Toyota Material Handling, U.S.A., Inc. AWP dealer at its place of business or, at Toyota's option, at the place where such AWP is maintained, during customary business hours. Toyota will not be liable for incidental or consequential damages such as inconvenience or loss of use of the Toyota AWP to the user, resulting from breach of the written warranty or any implied warranty.
- 2.0 THE WARRANTIES CONTAINED HEREIN ARE EXPRESSLY IN LIEU OF ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, AND OF ANY OTHER OBLIGATION OR LIABILITIES ON THE PART OF THE AWP MANUFACTURER AND DISTRIBUTORS OF TOYOTA MATERIAL HANDLING, U.S.A., INC., INCLUDING EXPENSE, LOSS OR DAMAGE WHETHER DIRECT, INCIDENTAL, CONSEQUENTIAL OR EXEMPLARY, ARISING IN CONNECTION WITH THE SALE OR USE OF OR INABILITY TO USE THE TOYOTA MATERIAL HANDLING, U.S.A., INC. EQUIPMENT FOR ANY PURPOSE.
- 3.0 No authorized Toyota AWP dealer is permitted or authorized to change, modify, or amend any term of the Limited Warranty.
Some states prohibit exclusion or limitation of implied warranty of merchantability or fitness for a particular purpose, and/or of incidental or consequential damages, so you may have additional rights.
