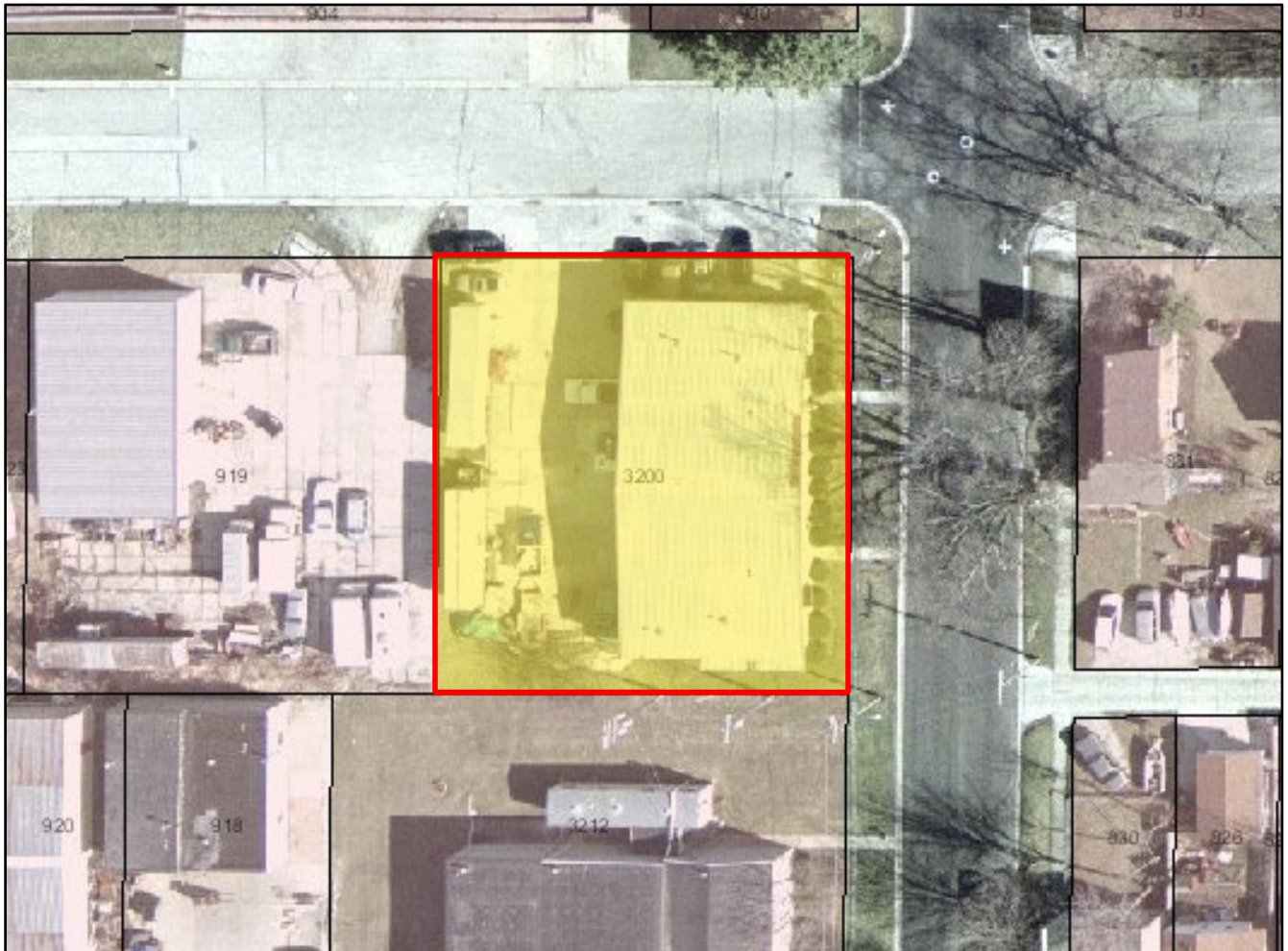

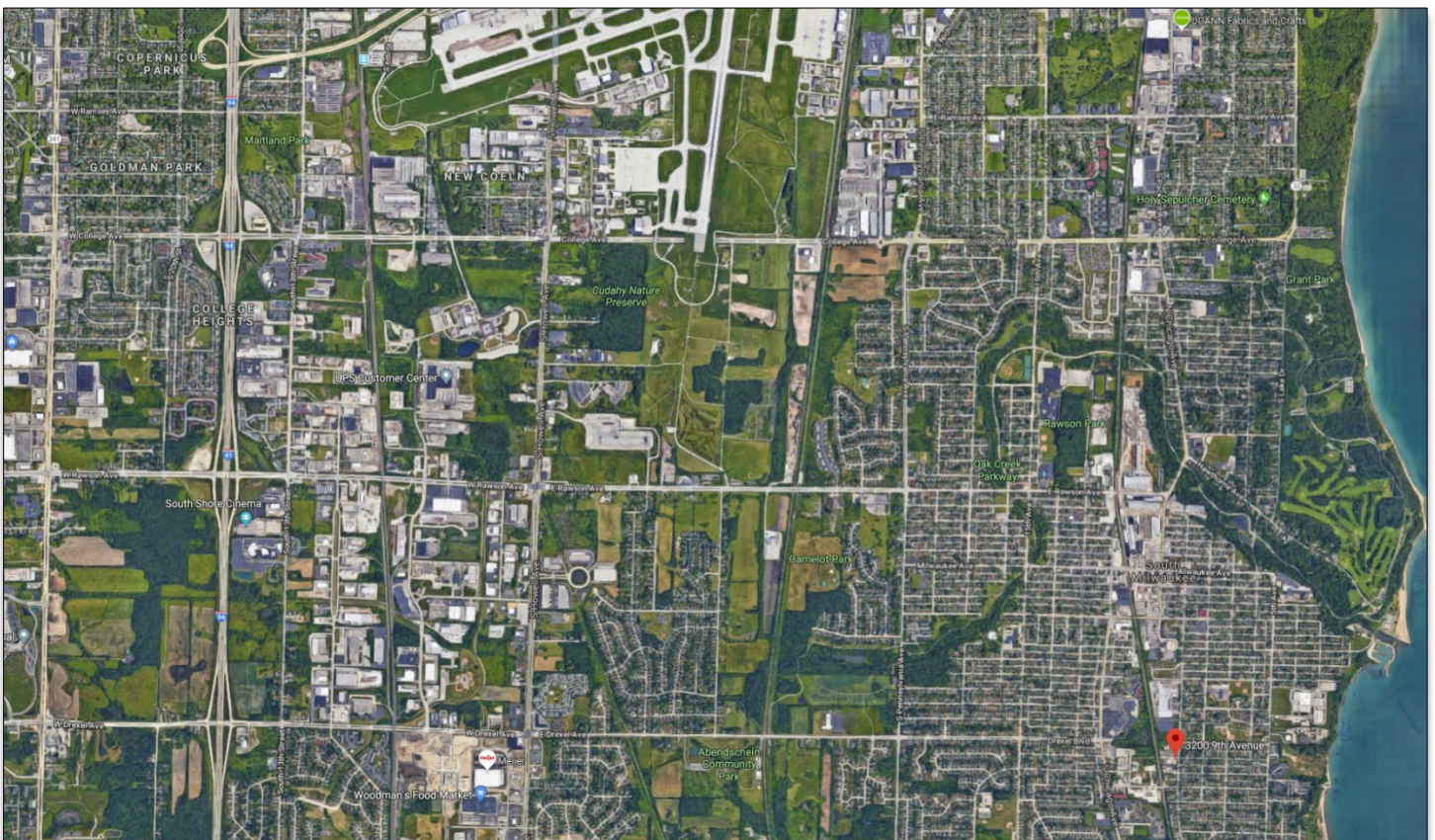

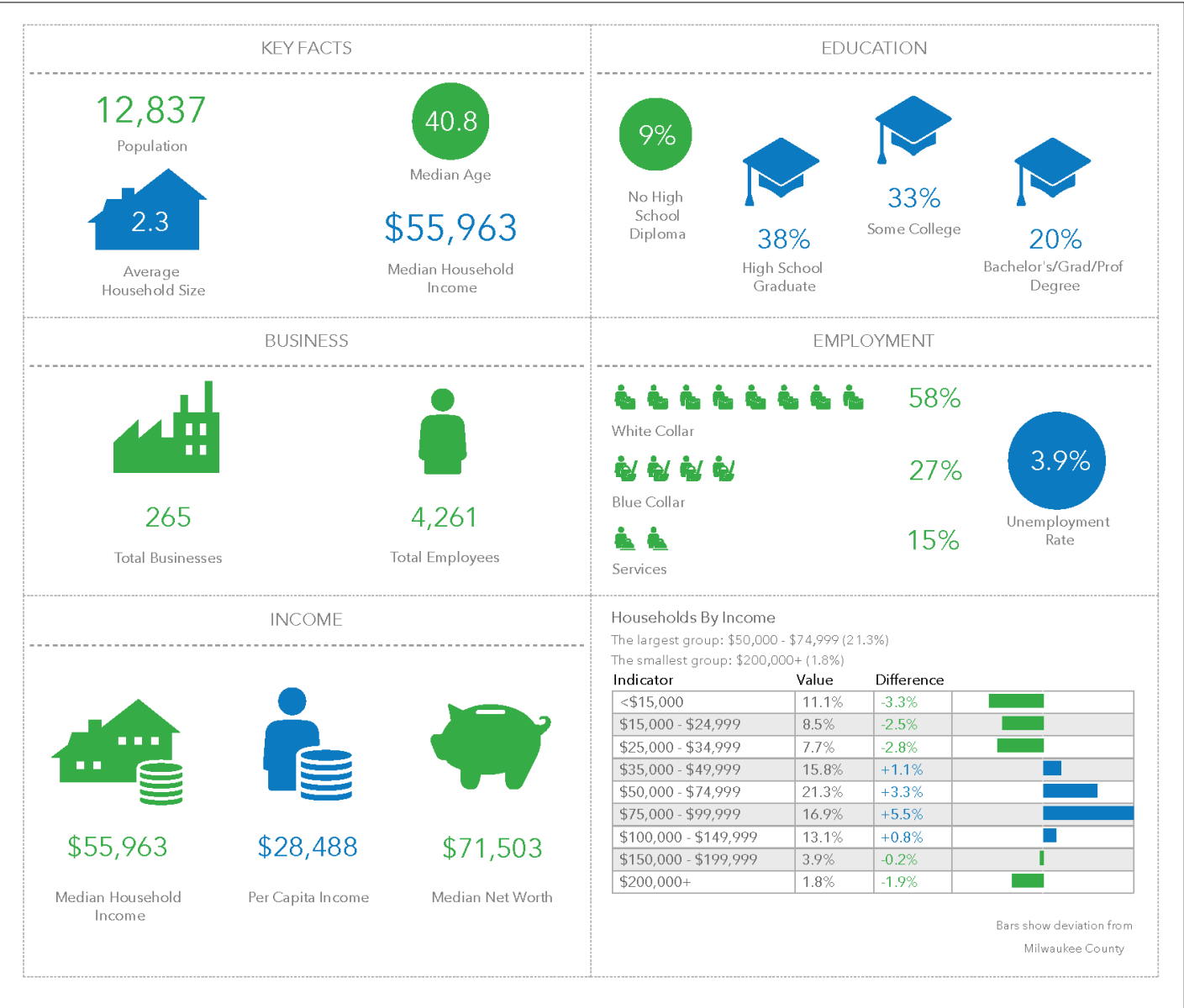

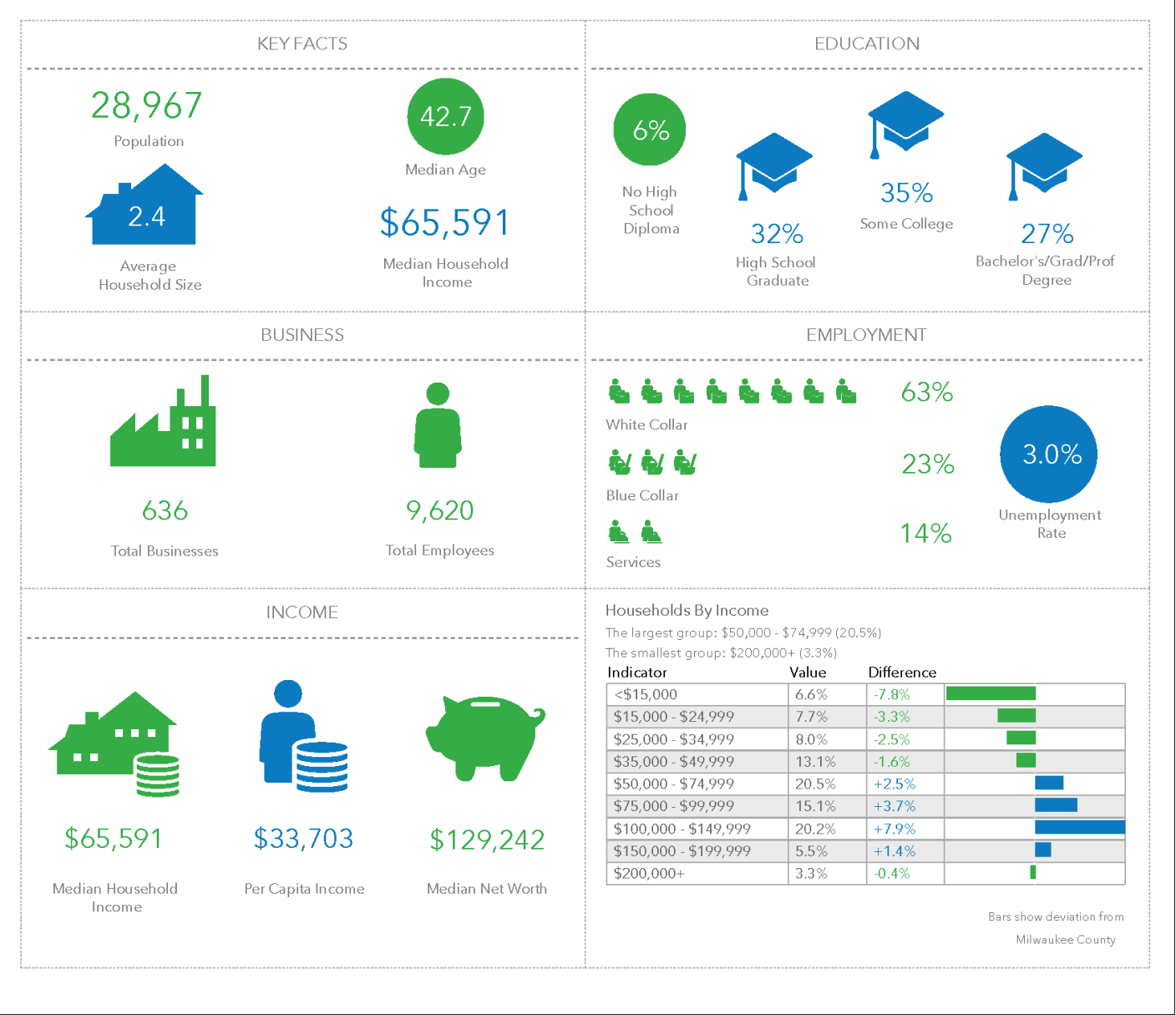

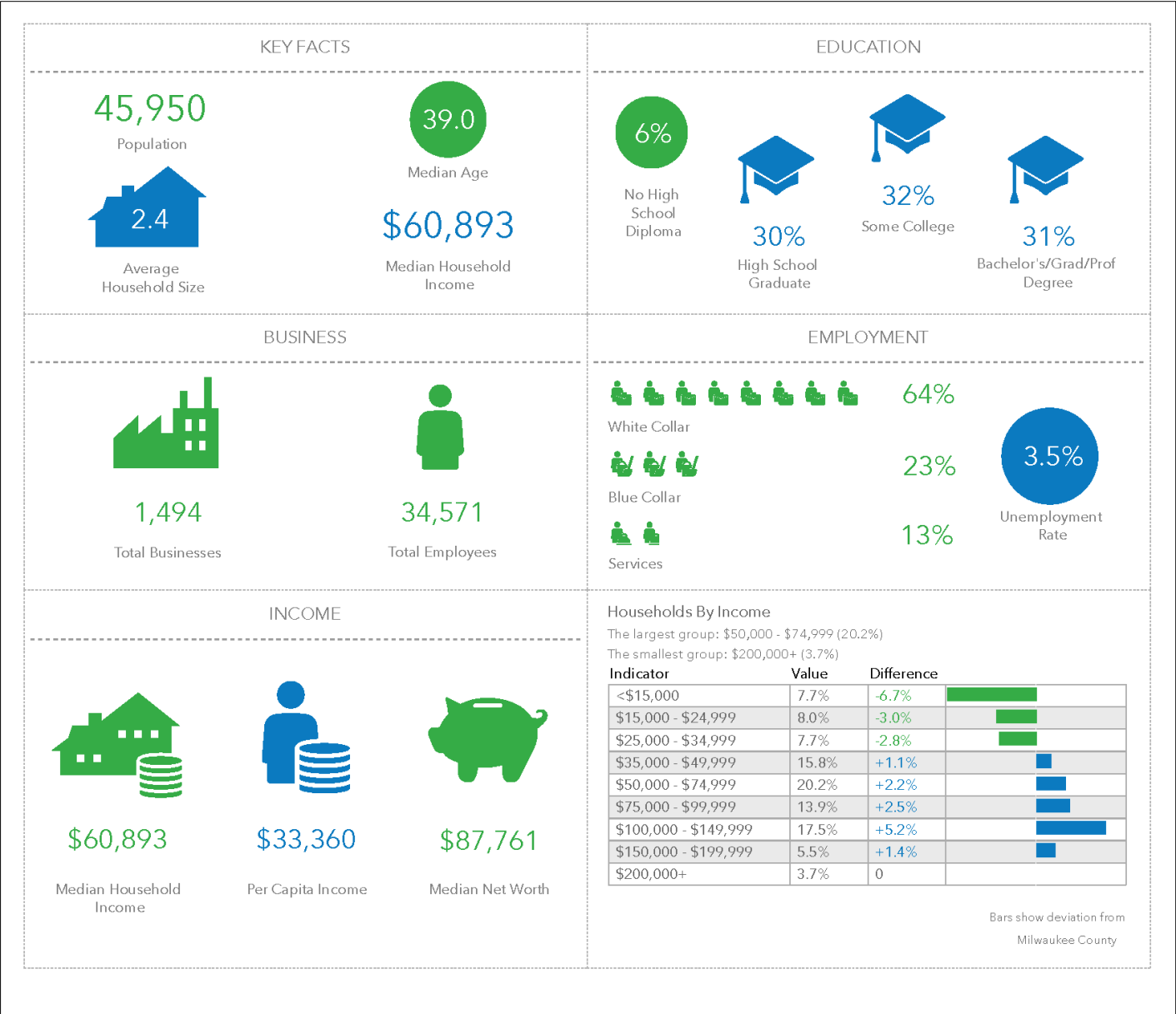
KEY FACTS – 1 MILE RADIUS

Traffic Count Map

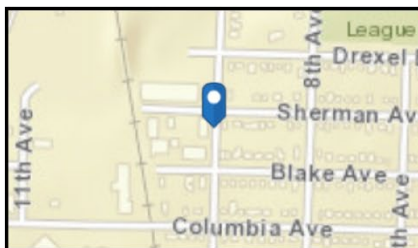
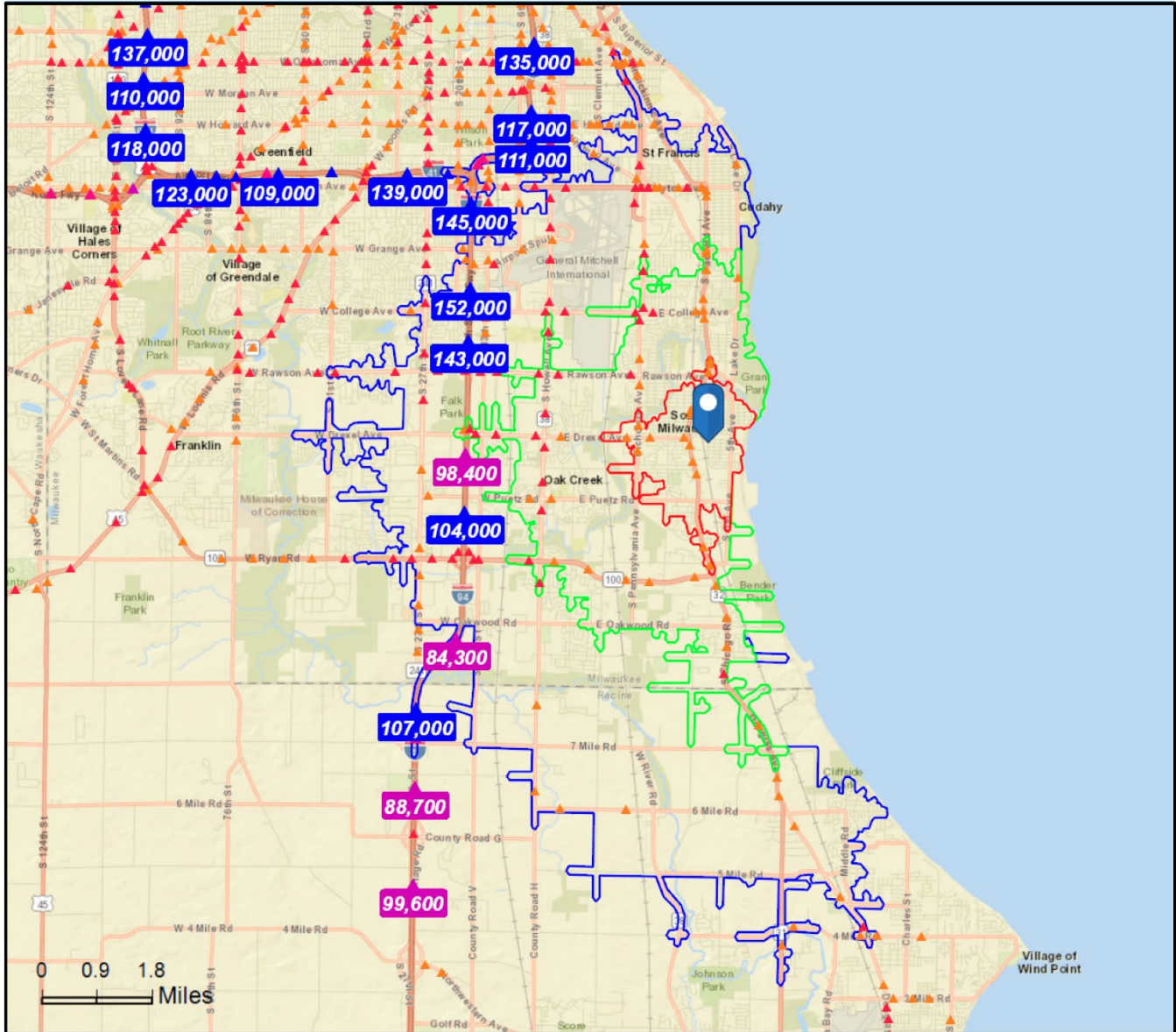

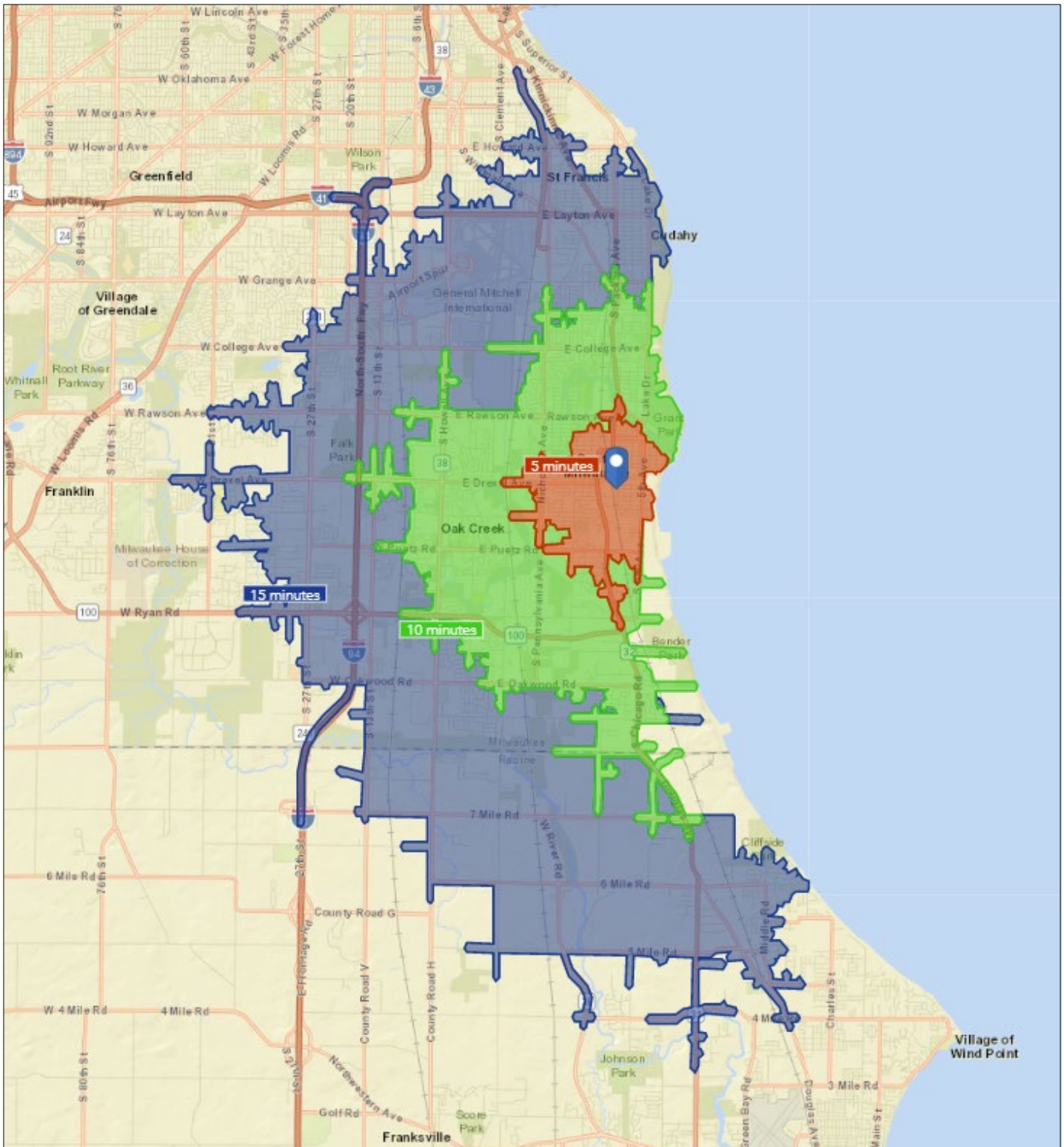
