




CORNER UNIT – 1,715 SF 153 N MILWAUKEE STREET








INLINE RESTAURANT UNIT – 2,112 SF 300 E. MENOMONEE STREET



APPROXIMATE LOCATION OF PREMISES







LOCATION MAP




AERIAL – AREA RETAILERS







DEMOGRAPHICS - .5 MILES












DEMOGRAPHICS - 1 MILE
