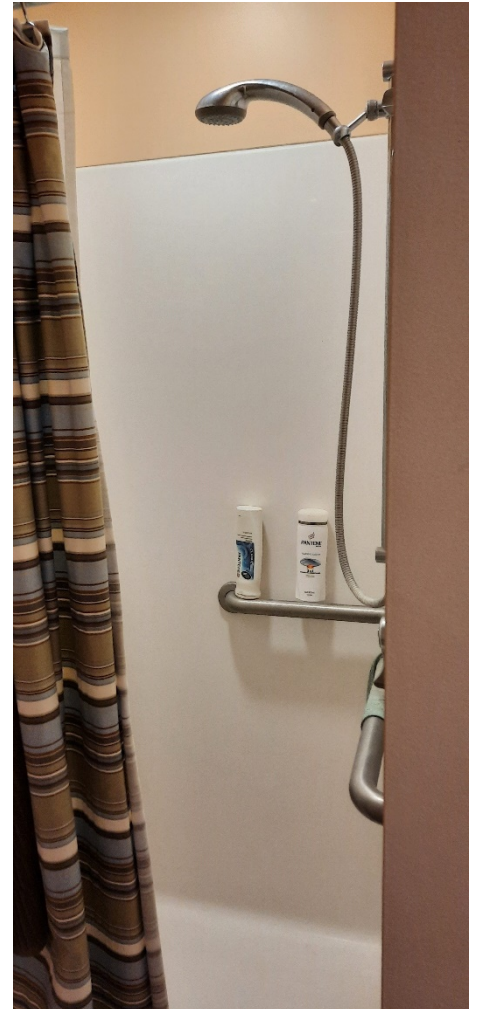

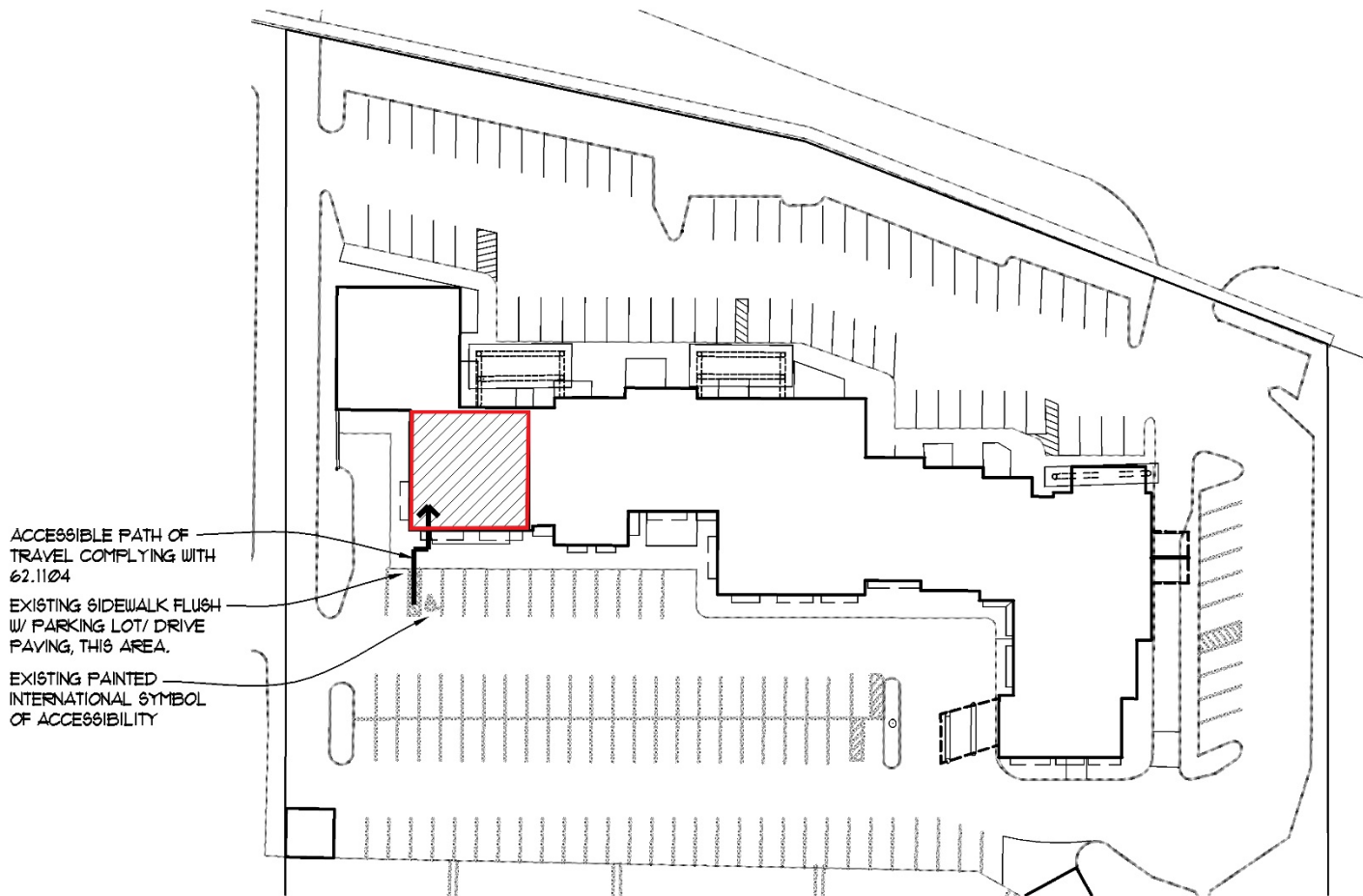

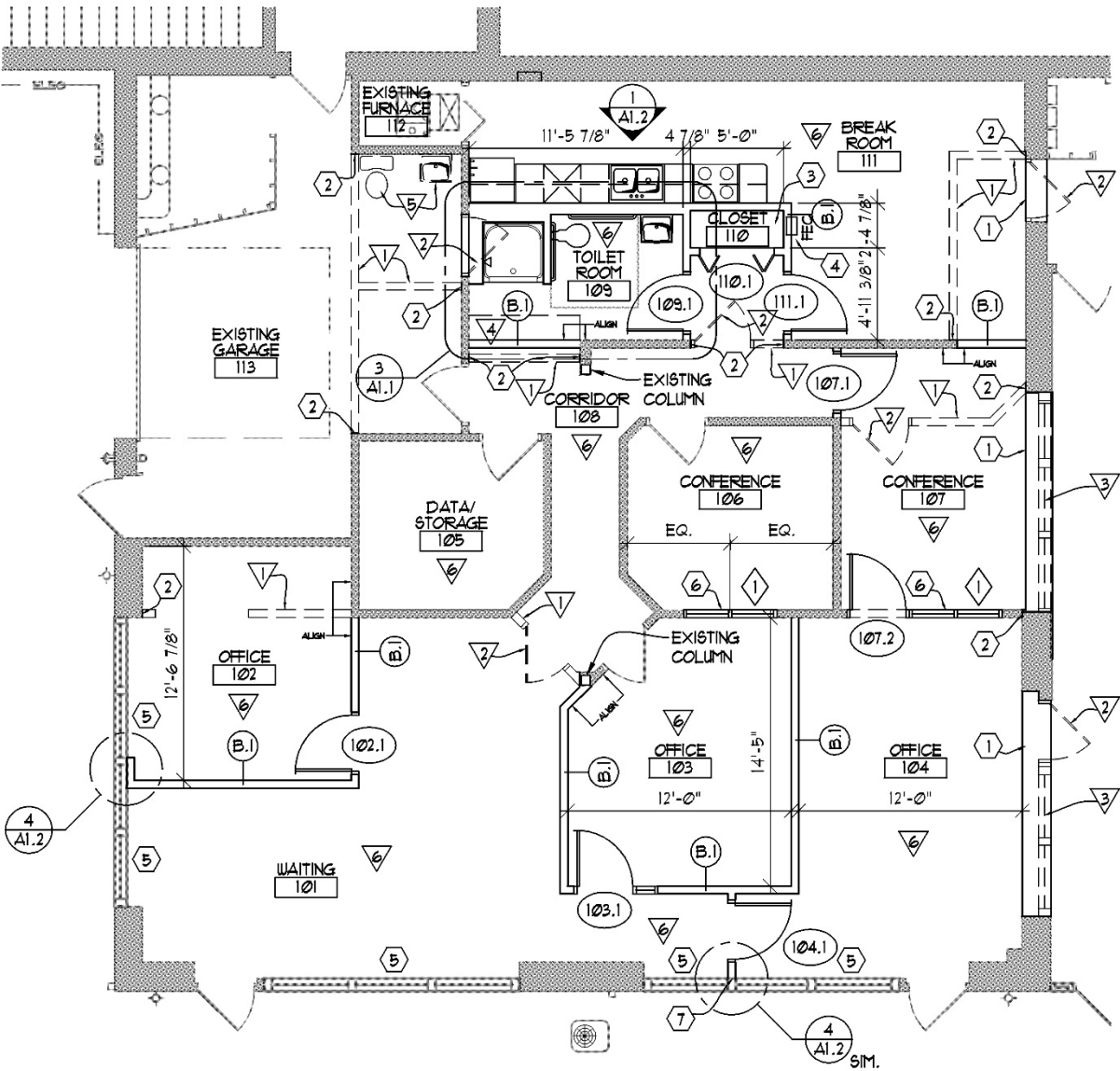

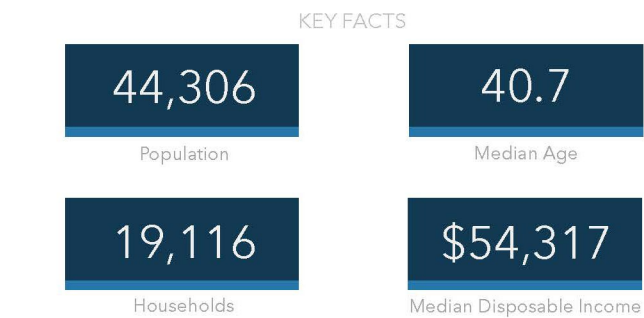

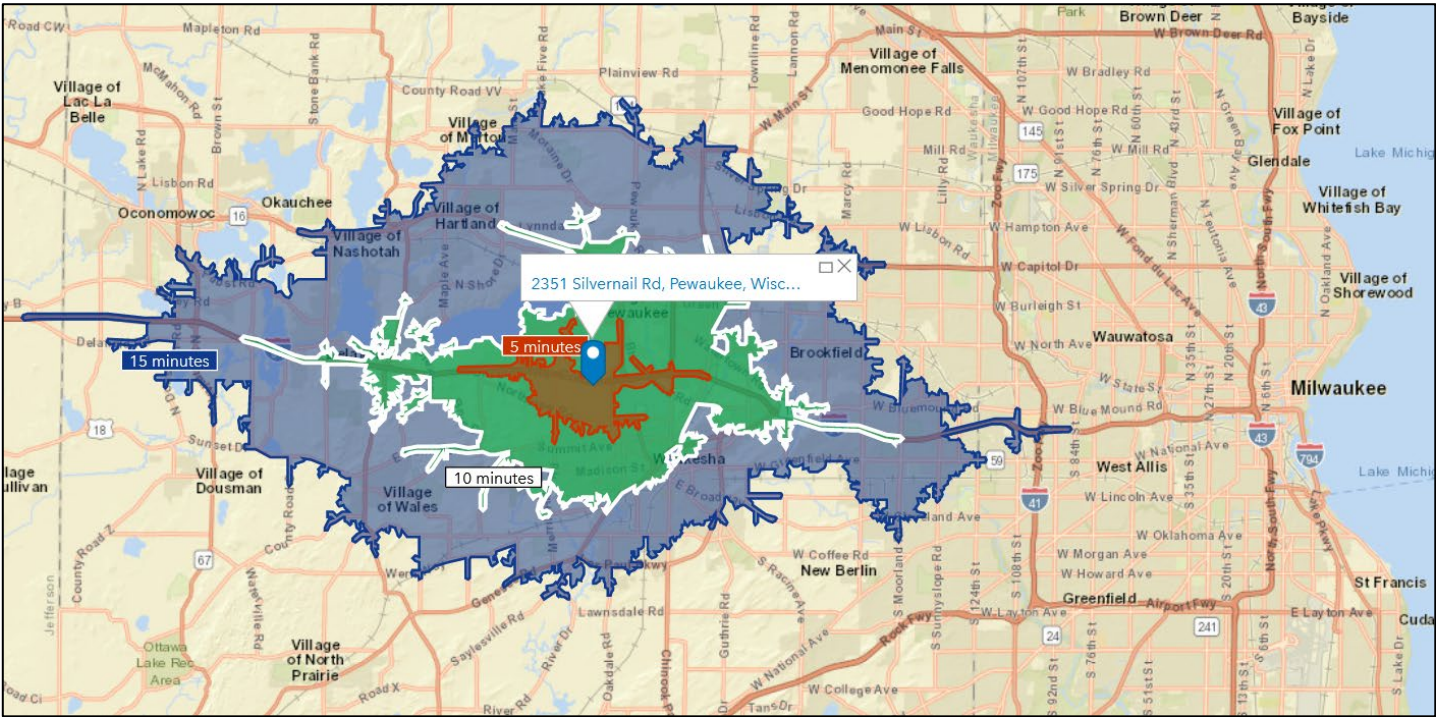
RADIUS DEMOGRAPHICS – 1 MILE

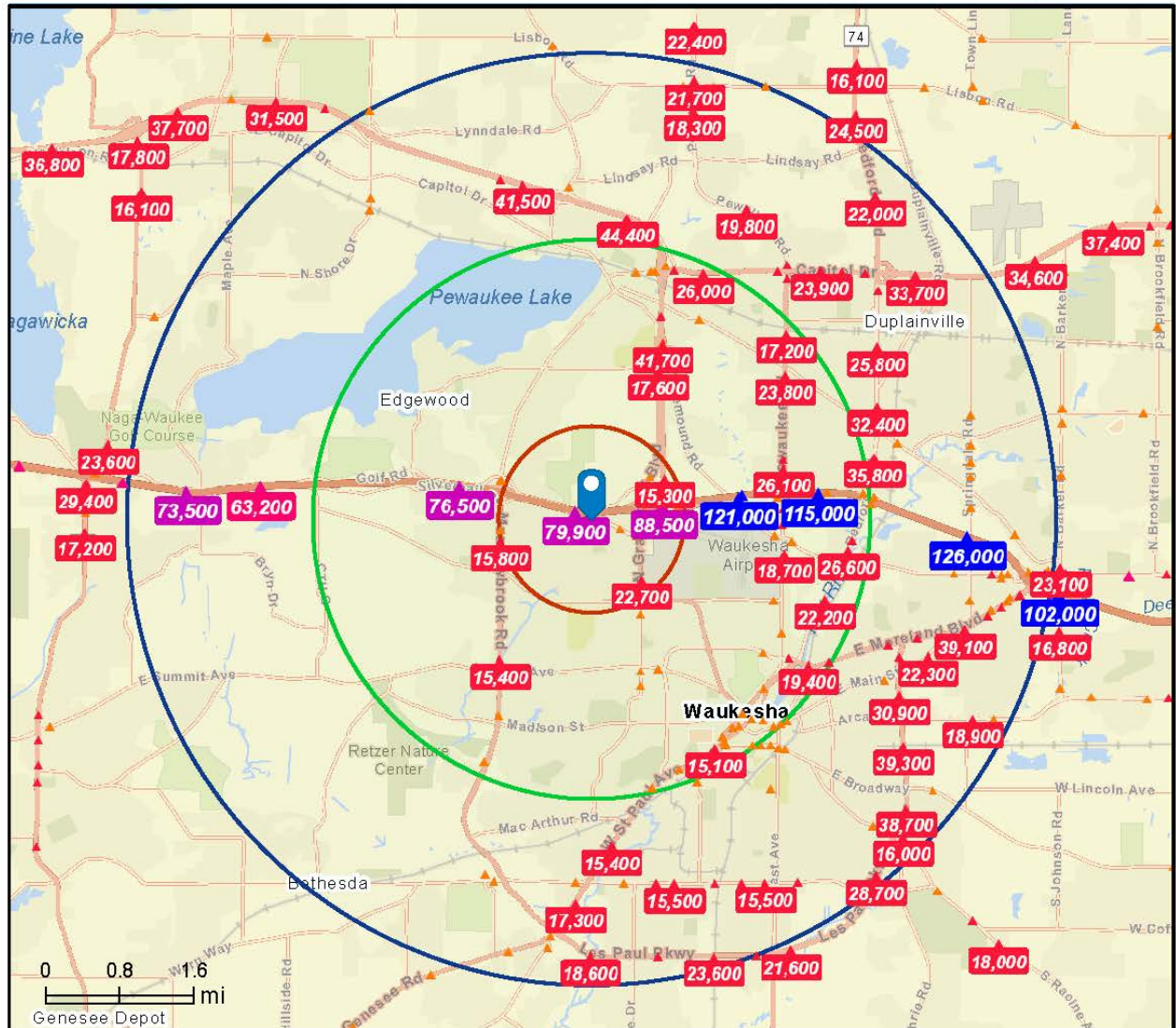
