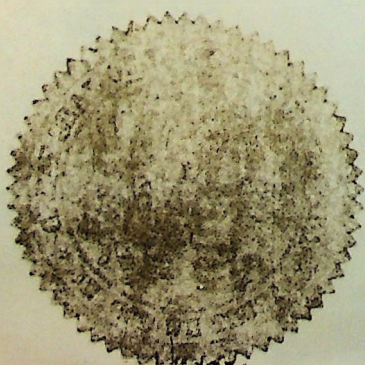

● ARTICLES OF INCORPORATION ●  
ASSOCIATION OF UNITY CHURCH CENTERS, INC.

The undersigned subscribers to these Articles of Incorporation each a natural person competent to contract, hereby associate themselves together to form a Corporation Not for Profit under the provisions of Florida Statutes 617.01.

ARTICLE 1.

The name of the Corporation shall be "Association of Unity Church Centers, Inc."

ARTICLE 2.

The purposes for which the Corporation is organized are:

- a. To receive and attract property by way of gift or any other legal means and to expend it for the purpose of aiding and abetting the Unity Movement as a whole throughout the World.
- b. To promote property and substance to flow into the Corporation so that the Corporation may strengthen Unity Centers, Unity School expansion programs, Unity Minister's Association, Silent Unity, College oriented undergraduate training programs, Unity Teachers and Curricula, Lee's Summit Activities, Printing Programs, Radio and Educational Media or any other means which in the opinion of the Board of Trustees would result in a strong World-Wide movement devoted to the spread of practical Christianity and the development of strong, vital, individuals, Unity Students, Unity Centers and Unity Ministers.
- c. To engage in any business endeavor or to take advantage of any tax advantage given to Churches by the Federal Government which in the opinion of the Board of Trustees would further the foregoing general purposes.
- d. To aid in the evolution and expansion of the Charles Fillmore consciousness at the Field level.

ARTICLE 3.

To qualify as a member the Center or Church or School must be an accredited Unity Center, Church or School. Such Center, Church or School shall be held and deemed to be the member. Members may be admitted to the Association by application for membership upon approval of the Advisory Boards of the Center, Church or School and upon a majority vote of the Membership Council as provided in the By-Laws. No member or its property shall be liable for the acts of or liabilities of the Association.



ARTICLE 4.

The Corporation shall have perpetual existence.

ARTICLE 5.

The names and residences of the subscribers are:

ARTICLE 6. The affairs of the Corporation are to be managed by a Board of Trustees who shall hold office for life, or until they attain the age of 65 which ever event first occurs. Thereafter vacancies on the Board of Trustees shall be filled by appointment by a majority of the surviving Trustees. Trustees may be appointed who are over 65 years of age, but their office shall expire each three years and be filled as aforesaid, provided that no Trustee shall be appointed or shall serve who is over 74 years of age.

ARTICLE 8. The Trustees shall make or alter the By-Laws.

ARTICLE 9. The Membership Council may recommend changes in the By-Laws and these Articles and these Articles and these Articles by majority vote, but the By-Laws may be changed or altered only by a majority vote of the Trustees.

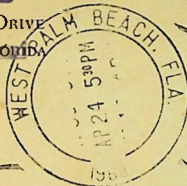
