ORDINATION OF ELVIRA GIL CACERAS At our January meetings of the Board of Trustees, the decision was made to confer ordination upon Elvira Gil Caceras of Santo

Domingo in the Dominican Republic. Elvira who does not speak English took her training in the Unity work under Luis and Maria Molinary at Unity Pan Americano in New York City. During the period of time that she lived in New York, she was active in every part of the Unity ministry, from housekeeping to Truth teaching. Upon her return to the Dominican Republic she established the Unity ministry that has grown in exciting proportions to being a stabilizing influence on the community as a whole.



EXEMPTION FROM FEDERAL TAX ON TRANSPORTATION

In order to clarify the regulations concerning tax exemption on air travel for ministers, we contacted our attorney and the Internal Revenue Service.

The Internal Revenue Service states that this exemption is provided for educational institutions only, and its primary purpose is to grant exemption from the payment of Federal Transportation Tax for the transportation of athletic teams. and groups of people as a part of an educational institution's program. It applies to teachers only if travelling on official business of the educational organization. Individually, it does not apply to ministers as such. It is not legally allowable for a minister to use the exemption when travelling to and from conferences, conventions, vacations, etc.

We realize that many ministers have been using the exemption for practically all travel, but according to the IRS this is not a legal exemption. Most Airlines. Travel Agencies, etc. have accepted Form 731 (certificate which accompanies payment for tax exempt travel) without question. Since the Airlines, Travel Agencies, etc. bear no responsibility in the transaction by accepting Form 731, they, of course, are not concerned. The person signing the certificate is legally responsible for its proper and legal use.

In view of the information received from IRS it is our opinion, and our attorney's as well, that this exemption should not be used.
