
# CONTACT

A Report from the Association of Unity Churches

November, 1969

You will recall at Conference in June that a very last minute decision was made regarding the planning of the Convention to be held in 1970 in the Municipal Auditorium in Kansas City. Though everybody picked up the initial enthusiasm shared at the time the announcement was made, there certainly were serious questions in the minds of many of us about whether or not this was an effort in which we wished to become involved. During July and August and September there have been a number of inquiries about the Convention because there have been those among our leadership in the movement who have caught the vision. At your Executive Office, it has simply been necessary for us to seek the indulgence of those writing about the Convention until further information was available.

Your Executive Committee met several weeks ago and a great deal of prayerful consideration was given to this matter. There was talk of the sort of outside speakers we could invite, but very quickly the brainstorming lead us into other areas of consideration. We began by determining why we would be having a Convention in 1970. We feel, with great conviction, that we in Unity have the greatest message on earth. We do not have to go to anyone anywhere to find a greater or more effective Truth. We see Convention 1970 as a reaffirmation of the great

power that Unity is and can be in the world. This will be a Unity Convention with Unity speakers, Unity participants, Unity students from all over the world who will be presenting the Unity message. The consciousness that they will draw together can be the consciousness to change the world.

Quite a number of years back Charles Fillmore said, "One day the world will be ready for the Truth that Unity has to offer and when that

time comes they will stand in line for the Truth." The theme for our convention, the Unity International Convention 1970, will be "The World Is Ready." At the commencement of this new decade on every hand there is evidence that the world is ready for change. Unity will be ready to offer the great blessings that it has to offer for mankind. The dates for the convention will be June 25th through 28th, 1970. We hope that you will have the opportunity to get this information out to your people as soon as possible so

that as additional promotional material comes your way your folks will be prepared to join with you in this great endeavor.

Pre-Conference this year will begin with Committee Meetings conducted on Monday and Tuesday and possibly Wednesday morning, the 15th, 16th, and 17th of June. The Board of Trustees Meetings will be held on the 17th and 18th and possibly the 19th of June. The weekend will be free, the 20th and the 21st. Our AUC Conference will be held on Monday, Tuesday, and Wednesday morning the 22nd, 23rd, and 24th of June. The plan at this time is to have a late lunch in lieu of a banquet so that we might be free to welcome our folks who will be arriving in Kansas City that afternoon.

The first meeting of and for the Convention for the benefit of those who will by that time have arrived, will be held at Unity Temple on the Plaza. We visualize filling the sanctuary when Ernest Wilson speaks and utilizing our closed-circuit television equipment so that the overflow can also fill the Charles Fillmore Chapel and the Fellowship Hall.

The Convention will commence with the Thursday morning meeting. On the Thursday, Friday, and Saturday there will be a two and one-half hour meeting each morning and a two hour meeting each afternoon, plus the big name entertainment program each evening. Our most outstanding Unity ministers and speakers will be asked to be a part of the program charged with the responsibility of presenting the tremendous Truth message that Unity has to offer to the world.

On Sunday, June 28th, transportation will be provided for the more than 5,000 people who will want to have the opportunity to visit Unity Village to arrive there in time for Sig and Janie Paulson's devotional service which on this occasion of perfect weather will be held in the amphitheater. You should understand that the amphitheater will not hold that many people but the overflow will sit comfortably outside of the amphitheater looking through the trees. Unity School is making arrangements for tours of Unity friends to see around Unity Village. Catering service will be offered for a meal and the open house will be a highlight of the whole Convention activity for our visitors from around the world.

Communication is on its way to you sharing the many details of the Unity International Convention 1970. Arrangements are being made for promotional material to be developed and distributed to you at the earliest possible date. The responsibility for the tremendous success that we envision rests with you as a Unity leader. We want, as the AUC Office to assist you in any way possible to fulfill the goal that you set for yourself and for your students in participation in Unity International Convention 1970.

Any way that we can increase the effectiveness of our service to you through your ministry in making a success of Unity International Convention 1970 will be deeply appreciated. Drop us a line or pick up the phone. This is your movement; this is your ministry; this is your Convention. You have what the world is ready for and indeed, the world is ready!

SCHOOL FOR MINISTERIAL AND RELIGIOUS STUDIES

The Fall Trimester in Unity's School for Ministerial and Religious Studies is now fully underway. We thought you would be interested in knowing some of the courses that are being offered to the students this year. We have

instigated a "Remedial English" course to help our students in their effectiveness with the presentation of ideas. All students continue with Speech courses throughout their entire training period. All incoming students are continuing to study "Unity Fundamentals" and second year students are engaged in a class entitled "Dialogue on Metaphysics." Center Administration continues to be taught and both first and second year students are engaged in their continuing study of the Bible. We are teaching a course in contemporary ministry and also, one designed to help the student grow as an individual which is entitled "The Growing Student." In the past we had an opportunity for students to be engaged in the work of Silent Unity. Inasmuch as this is no longer possible because of the changes in the work arrangements in Silent Unity, we are now having Silent Unity bring a course entitled "Prayer and Healing" to the students. This is under the direction of James Freeman who has selected special Silent Unity workers to assist him.

All of us are encouraged with both the quality of our students and the number of students that we have in SMRS this year. We hope that in your forthcoming visits to Unity Village (for conferences, retreats, and the like) that you will plan sometime to come by the School and have an opportunity to meet the fine students that we have this year in SMRS. If, at any time, any of you ministers in the field have any specific questions that you wish to ask pertaining to the AUC participation in the Ministerial Education Program, please direct your inquiries to William L. MINISTER'S FEDERAL INCOME TAX GUIDE Last year we were able to obtain copies of the MINISTER'S FEDERAL INCOME TAX GUIDE for those who wanted them.

The cost last year was \$2.95 and it is presumed that it will be the same this year.

CENTRAL ORGANIZATION FUND

As of October 28, fifteen organizations have deposited \$27,000.00 in the Central Organization Fund.

A tentative commitment of \$20,000.00 to purchase furniture and fixtures for one church has been made. Presently two requests for loans totaling \$65,000.00 are awaiting sufficient deposits to cover.

We see this fund as being a definite help in the expansion and development of Unity, and we trust that you will give this matter your very serious consideration. If you want more information about the Central Organization Fund just let us know.

NEW HOSPITAL Here in the AUC office we are always seeking ways in which we may help you in your ministry of service. The enclosed hospital-ministry leaflets are our latest effort in this endeavor.

You will note that one of these is to be given to a person upon his admission to a hospital. The other is to be given or sent to him upon his return home. Please note also that there is a line at the lower right-hand corner of the inside of the leaflet. This is the place for you to sign your name as the visiting minister, to give this your personal "touch."

Beneath the signature line enough space has been left for you to put the stamp of your church or center. This, of course, identifies the material with your local organization.

These leaflets are now available for distribution to you as a Unity minister. There is no charge for them, as they are being sent out on a love offering basis. Please let us know the number of each leaflet you desire, and they shall be sent to you promptly.

YOUTH EDUCATION September and October have been exciting, busy, fruitful, growing months for our Youth Education Department. As you know, our new teacher-oriented youth education material is now in production. Orders are being received from virtually all of our centers who have a youth education program. The success of this material is dependent to a very great extent upon our ability to inspire and infuse our superintendents and teachers.

During September and October, Dan Perin has conducted 30 seminars in 27 cities. Most of these have been attended by representatives of more than one center. To date, attendance has been over 700, mostly teachers, superintendents and ministers; however, more and more parents are attending. Between November 1st and the end of February another 20 seminars are scheduled. Tremendous strides are being taken in our youth education and rich blessings reach out to Dan for his abundant, generous giving in this way.

RETIREMENT PLANS More than 60 ministers are participating in the BANKERS LIFE ANNUITY PLAN. This Plan was put in force in 1963, and is currently earning in excess of 5% interest. Under the ANNUITY PLAN you:

deposit a fixed amount each month, which amount is not included as income. (You can deposit up to 20% of your income.)

can make the full deposit yourself or your center or church can share the cost with you in any proportion you desire.

The more people in the plan, the less cost per person, and the more benefits that will accrue to each participant.

Here is an illustration of what this plan will do for you with a deposit of \$100. per month to age 65.

There are now 10 centers in addition to the Central Office Staff - 21 persons involved - participating in the MONEY PURCHASE PENSION PLAN. This plan became effective as of January 1, 1969. Under the Money Purchase Pension Plan you

contribute 3% of your salary (not including your manse or other allowances).

Your church or center contributes 8% of your salary.

You are not taxed currently on the 8% contribution made by your church.

The 3% is made with after-tax dollars, but your contribution compounds on a tax-free basis.

The Plan provides not only for ministers but also includes (under certain conditions) all full-time paid employees of the church or center.

There is no guaranteed return since the amount you deposit and the amount that is deposited on your behalf by your church or center may fluctuate according to increases in salary. Plans of this type have a history of excellent return (some in excess of 10%).

COSTS: Several leaders have asked for estimates on prices for convention attendance; estimates follow:

Participation ticket for all convention activities.....\$25.00

PARTICIPATION TICKETS: Now being prepared. Should be in your hands not later than 1 December. Cost will be \$25.00 each.

CHARTER TRANSPORTATION: Several centers have already negotiated with airlines individually. We have also obtained some tentative commitments for flights from other areas. Savings over commercial fares are about 35-40%. Information on how to go about getting an air charter will be forwarded to each region, as well as bus charter information.

CORRESPONDENCE: All convention correspondence addressed to you will be prominently marked for easy identification.

SPECIAL ACCOUNTS: Several centers have begun special prosperity accounts into which individual members may deposit savings for convention expenses. Sounds like a good
