UNITY VILLAGE, MISSOURI — A successful and highly productive South Central Sub-Regional Board/Minister meeting was held in Unity Village on October 5, 1974. Hosted by the Unity Ministerial Alliance of the Greater Kansas City Metropolitan Area, the Saturday meeting was attended by 40 persons representing seven Unity ministries from Independence, Kansas City, St. Joseph, and Unity Village, Missouri. **Mauritz Erhard**, minister of Unity Northeast Church, Kansas City, served as Chairperson for the meeting. Commenting on the gathering, Mauritz stated, "It was a rewarding as well as an informative time. We all received fresh insights into the way we can serve and be served by the AUC. Blessings and thanks to each Board member, representative, minister, and AUC office staff member who participated in this meeting."

Charles Korfhage reporting for the NORTHERN CALIFORNIA REGION:

SACRAMENTO, CALIFORNIA — Christ Unity Church in Sacramento, where **Phillip** and **Dorothy Pierson** and **Charles Korfhage** serve as ministers, has now completed the refurbishing of their church facilities. The remodeling accomplished the final phase of a six-year project transforming a former bowling lane establishment into a sleek, ultramodern church structure. A new front of glass and tile has replaced

the outdated glass, brick, and stucco facade, and brass lettering now proclaims the building as "Christ Unity Church." The new look continues inside the handsome paneled-wood front doors, through the wide, tile-floored foyer and beyond to the sanctuary, meeting rooms, and offices. To the immediate left of the entrance is a shelf-lined book store which dispenses literature and related study items. On the right, a rock planter reaches up the wall, with a bank of potted greenery set in bark chips at the base. A cascade of water falling into a pool adds a soothing "wooded glade" sound. Further along on the right are large-scale meeting rooms, with generous space for seating. During the period when the main sanctuary was being finished, the congregation held services in this area. The sanctuary utilizes the same low-key contemporary interior theme used throughout and has beautifully grained wood-paneled walls surrounding comfortable pews. Behind the pulpit and altar is a rock wall which matches the planter in the foyer. The wall is topped by more thriving greenery and a skylight which floods the area with daylight. The organ is situated on a balcony to the right, next to a sound-proof control room for the audio (or recording) engineer.

Phil Pierson estimates the new facility to now be worth about \$800,000, considerably more than the \$125,000 invested in the property and the \$400,000 for the changes. He shares these figures in the hope that other ministries will be encouraged to consider the possibilities of similar projects to solve their expansion or updating needs. "There are lots of unused old buildings available," Phil points out. "In these days of prohibitive costs, using them is good business—for everyone concerned."

PORTLAND, OREGON — Unity Center of Portland recently completed an additional parking facility. Nine-tenths of an acre was purchased at a cost of \$56,000 and the land developed at a cost of an additional \$25,000. The parking facility will accommodate 93 cars and has been beautifully landscaped with over 400 shrubs and trees. The Department of Environmental Quality and the Portland Planning Commission have some very stringent regulations about new parking lot developments. The Unity Center has been one of the few organizations able to design a parking area that would meet their standards and then obtain their approval. **Leslie D. Saunders**, minister of this Oregon ministry, reports that the new parking lot was used for the first time on Sunday, October 6, and that with these additional facilities the Unity Center is now able to provide off-street parking for 120 cars. Following a taped class, the teacher is always present to answer any questions. Presently we are offering four different credit courses and have 50 people taking credit work, in addition to the others who come to audit. The vidio recorder enables us to do more with the same amount of time, as our 'Lessons in Truth' class is taught 'live' one evening and then presented on vidio tape during the day at another time of the week."

Using plates made from an original in the Unity School Heritage Room, the AUC office now prints, binds, and stocks the reprint as a salable item. Bound in a brown cover to match the original, the booklet is approximately the same size as the first issue and contains the full 36 pages of Volume I, Number I of DAILY WORD.

The July 1924 reprint is priced at ten cents each (\$.10) to cover out-of-pocket costs of paper and supplies, and may be ordered from the AUC office in any quantity at this nominal price plus postage.

UNITY WORLD HEADQUARTERS ACTIVITIES CENTER

Last month's issue of CONTACT contained an aerial photo showing the Unity Village building complex as viewed from the west and visually depicted how beautifully the new Activities Center harmonizes with the architecture of the present buildings. This month, the Activities Center is shown as viewed from the Bridge of Faith. The open walkway beneath the towering arches along the sides of the



new building provide an awe inspiring vista for persons approaching the building. From the walks along the esplanade between the Silent Unity and Administration buildings, this magnificent scene is truly breathtaking.



In addition to the erecting of the Activities Center and the new Unity Inn, the master plan for the construction currently in progress at Unity Village calls for the modification of the east end of the Administration Building. Housing the present Unity Inn, this section of the building is being refaced to provide arched windows and a sloping tiled roof.

The steel framework shown in the lower right portion of the photograph is the structural skeleton of the

covered walkway which will connect with the Activities Center.

The space vacated by the move of the Inn to their new facilities will be utilized as additional office and classroom areas. This move will also allow more orderly and efficient use of facilities for many of the activities of the Unity Village Chapel and the Education Department of Unity School.

Book Rack

A NEW CHILDREN'S BOOK

Inside Me, Outside Me is an exciting new Unity book for children by **Elizabeth Searle Lamb**. Why is it considered exciting? Read the following review by **Hugh R. Horne** and see if you do not agree that Ms. Lamb's book is indeed one which will be treasured by all young readers.

"During recent years some publishers have apparently neglected the responsibility and opportunity of producing books designed primarily for children. It is therefore gratifying to see this good book from the prolific pen of Elizabeth Searle Lamb, prominent poet and essayist. It is generally agreed that writers must possess a special talent in order to appeal to the reading interests of children. The material in this book offers ample proof that the writer knows this wonderful gift that lends itself to sustain the interest not only of children but teachers and parents as well. The book possesses three general themes that will appeal to children of all ages, as well as to adults who are interested in children (and who isn't!).

"Twenty-five think poems and essays are beautifully and interestingly presented in such fashion that the impressions will be long-lasting. For instance: 'Let's think about people, think them sharp and clear as if they were right here. Can you think of your dad when he leaves for his work, what he's wearing, what he's carrying, maybe what he's saying? Can you think-your mother when you get home from school—her voice that answers your shout at the door, the way her hair looks, the color of her eyes? Can you think-not this year's teacher, but the one you had the first day you went to school? Can you think-a friend you made last summer, who lives in a faraway town, or the policeman waving his arms to signal cars to go or stop, or a little old woman you see in her garden on warm days when you walk to school? If you can think people, you will never be lonely!'

"Also featured in the book are games, rhymes, puzzles and 'thinkers.' This is where the beautiful illustrations, done by Cheri Wright, lend credence and appeal to the material presented. Ms. Wright also designed the cover for the book. One such 'thinker' goes like this: 'If I were building a log cabin, I would probably make it of just one kind of wood. This cabin, however, is different. Every log comes from a different kind of tree. Make a list of all the different trees you know. Then see if you can fit names to the logs in the cabin.'

"Some other puzzlers and games include 'Music Makers,' 'The Bird Perch,' 'Balloons,' 'The Jungle Land,' and 'A Kitchen Fill-In,' to mention a few. Last, but certainly not least, the book contains words and music for songs to sing, such as 'Dove's Lullaby,' 'Who Knows Birds?' 'Thanksgiving Prayer,' and others. My copy of this book will be treasured, not only for my eleven-year-old son but also for my young granddaughter and (who knows?) perhaps for those grandchildren I'm still looking for!"

Inside Me, Outside Me will be a welcome gift for children ages 3 to 10. It is priced to retail at \$3.50 and may be ordered from Unity School at your dealer's price of \$2.10.
