#### REORGANIZATION COMMITTEE REPORT - by Charles Roth, Chairman

(Results of the questionnaire have been included in CONTACT as an insert.)

As you begin reading this report, orient your thinking to January 3, 1978; for that is the date it was written.

On January 3rd 65% or 205 of the 315 voting members of the AUC have responded. This would probably be considered an exceptionally good response in an ordinary national organization. However, I feel a bit disappointed.

The questionnaires were sent out early in October. In November the Regional Committee members were sent a listing of their Region with check marks after those who had responded. Each Committee member made an attempt to contact those who had not replied. Then in December a postard was sent to ALL voting members reminding them to return the questionnaires.

I would estimate that about 5% or possibly 10% of the voting ministers didn't answer because of physical challenges, moving from one center to another, and other extenuating

circumstances. That still leaves about 25% to 30% who for one reason or another didn't send back their questionnaire.


No doubt some, or perhaps many, are genuinely interested in the affairs of the AUC but for personal reasons didn't go along with the "questionnaire approach" that the Committee took. Two of such ministers were thoughtful enough to reply stating their interest but did not submit the filled-in questionnaire.

The Reorganization Committee will be meeting on January 16 and 17 to study the results of the "grassroots survey" and to begin to formulate proposals that reflect the thinking of the ministers who responded to the questionnaire.

As per your motion at Conference, you will receive a copy of the minutes of the January meeting. These minutes will, of course, inform you of the next step in the Committee's attempt to carry out your directive.

RESIGNING

A

MINISTRY"

There are many questions concerning how to resign and when to resign a ministry. There are many important considerations about resignation however it is caused: duress, retirement, call to progress, or personal growth.

Sometimes when things are going badly a minister is tempted to just resign and hope for the best. However, many ministers and many congregations have found over a period of time that this is not the most productive way. A minister can find a new church more easily while currently employed. Also, since a church can go for a period of time without a minister much more easily than most ministers can be without employment, it is best to not resign until another position is secured.

If there is a large faction within a congregation wanting the minister to resign, it is often wise to go ahead and do so. To fight such a request will usually do the minister and the ministry a great disservice. Usually it is better to realize that time and consciousness will heal the wounds, and it is more orderly for the minister to move on rather than marring the image of the church in the eyes of the community by fighting for his rights. However, there are also other times when obviously the best interest of the church is to keep the minister and to invite some people within the congregation to back off, change their consciousness, or to move on themselves. Because you are so close to the situation it is often impossible to determine which course of action is most appropriate without someone from the outside giving you his perspective. Of course, this is when liaison serves everyone involved best.

Whenever a minister decides to resign, he should do so in a normal length of time. Usually, 30 to 60 days is an adequate time to alert a Board and congregation. Any less time seems abrupt and suggests foul play. Also, it is not wise to use the threat of resignation as a means of control or to try to secure a raise in salary. Manipulative types of resignations most often backfire.

After securing a new position and deciding to resign, do everything possible to get the church and its records in order. To leave an orderly organization behind is not only helpful to the person who follows you, but good for consciousness to create smooth transitions. You can graciously leave and gently close the door behind you rather than burning bridges.

Once you have resigned it is necessary to keep your word. There is no way you can retract a resignation once it has been established. Otherwise, it is apparently a manipulative type of thing and will be detrimental to your creditability. Once you have resigned, it is also necessary to leave that ministry behind. Ideally it would be best to sever connections in every way

possible to allow people to look to the new minister. When close friendships have been established, some of those may justifiably take longer to wean. You see, you can do everyone a disservice by cutting close ties abruptly. The majority of congregational ties can be severed immediately.

When a minister retires, it is ideal that he should even leave the community so as to enable the new minister to really take over the reins of leadership. In some cases it is not practical to leave, but certainly the retiring minister can stay away from the church for up to six months to allow the new minister to get established; then he can return only if the current minister is comfortable with his attendance or participation. No minister should ever return to a former ministry for weddings or funerals unless the current minister personally invites him to do so. If for any reason you return to a former community, it is only ethical to notify the present minister of your plans, even if they do not involve any participation with the ministry.

As the resigning minister, you want to be most careful not to use your influence in getting a minister of your choice selected for your church. Particularly a retiring minister often feels a certain maternal or paternal responsibility for the ministry: wanting very much to create in his own image a minister to take his place. Such paternalism only breeds confusion and sometimes really blocks the orderly flow of Spirit in drawing that right minister. If, as a resigning minister, you try to use your influence with the Board or congregation in their selection, you will find that if the new minister does not do well you then will be blamed. Also, people who are unhappy with you will automatically resist your choice, regard less of its appropriateness. It is better to let the Board work directly with the Field Services Coordinator and evolve its own selections. Then when the candidates are there, they should meet privately with the Board without your presence so that the decision is made without your influence.

When it comes to presenting your resignation, there are many ways to do it. Some ministers have had the Board President read the resignation, or they themselves have verbalized their resignation at some point in the services. Different ministers have different opinions about whether it should be read at the beginning or ending of the service. Experience has shown that whenever a resignation is given during a church service, the therapeutic and beneficial activity of that service is destroyed. People do not come to church to get bad news; they come to get the good news. Therefore, it is best for the resignation to be in letter form and mailed to the entire congregation after the minister has consulted personally with the Board of Directors and key lay leaders. Then, all of the congregation get the news in the privacy of their own hearts and are over their reactions by the time they are gathered in a group. Never underestimate the importance of a minister in the lives of the congregation. The resignation is a difficult time for many members.

Following the announcement of resignation, the congregation goes through definite stages of grief. These grief feelings need to be acknowledged and gently handled. Within four to six weeks, most of the people have gotten through those feelings and are really in tune with the idea of hearing a new candidate and appreciating the value in a new minister. Resignation is not a casual activity in the lives of anyone involved in the ministry. Give it serious thought and let it unfold only in a very love-full manner. ++


### AUC President's Letter

### NEWS FROM THE EDITORIAL AND PROMOTION DEPARTMENTS OF UNITY SCHOOL

The Promotion and Editorial Department of Unity School are working together to bring a new kind of service to youa preview into upcoming literature that may be helpful to your center ministry. We will use this space to point out articles in our three periodicals and books that we feel are of particular interest to you.

#### SPARKPLUGS -- A Summary of UNITY Magazine

If you are like most Unity field ministers, you are interested in material you can use in sermons or lessons to illustrate Truth principles.

You will want to read an article in the March, 1978, issue of UNITY Magazine, entitled "Never Be Ashamed," by Mildred M. Fredricks. This article contains two good examples of the way Truth principles can be used by individuals.

The first illustration involves a fledgling minister. People are gathered to hear this young man speak. After he gives a few words of greeting it is obvious he has a terrible cold. But, because the minister has some insight, knowledge, and a great deal of candor he doesn't ignore these embarrassingly apparent symptoms. He says, "Now don't attempt to be polite and pretend you hadn't noticed I have a cold. It is evident now, but tomorrow it will be gone—and I know what caused it." He shared with his audience the angry feelings he had experienced two days earlier when two vocal adversaries showed up at a talk he had given.

Belatedly he realized that these feelings had disrupted his internal harmony. He consciously rectified the situation, but

the incident took its toll -- his cold.

The author believes this illustrated that the more one knows of the law the greater is one's responsibility to act in accordance with it. She says such incidents happen, maybe most often, to those acquainted with this truth than to those who are unaware of it. And she believes that a person of a more simple nature, who does not know the law, may sometimes better demonstrate faith than a more sophisticated person, such as the minister in the first example.

She uses, as an illustration of the latter idea, a story about a domestic worker who left her employ to take care of her grandchildren left alone because of the hospitalization of her daughter. When the author reprimanded the domestic for neither visiting the daughter nor even thinking about her, the domestic voiced her faith. She said, "There's no time to run to the hospital....so I just put her in God's hands. He's taking care of her and I'm not about to go worrying, and poking around to see how He's doing." That's real faith at work.

# THINKING EXPANSIVELY with R. Scott Sherman

I have been asked by both Stan Hampson and Bill Fischer to include the information that I sent to them and Charles Roth recently concerning my findings in a very quick study I did using recent AUC Yearbooks. I think what I found will be of interest to you.

Here is a synopsis of the quick study I did using 1976 and 1977 Yearbooks. My goal was in response to the excellent article by Bill Fischer in the December CONTACT, simply to see what happens to our ministers. Why do we seem to be constantly short of ministers? What are they doing?

The results were quite interesting, so I thought I would pass them on to you. All of my figures are as of the 9th of December, 1977. My topic statement would be "In the last two years the following changes have occurred in the status of ministries or ministers which have affected their availability to accept leadership."

- 34 ministers filling new ministries
- 4 ministers filling new associate positions
- 2 left North America for overseas ministries
- 1 took new AUC position
- 20 retirements
- 14 left ministry
- 5 deceased while "active"
- 7 sabbaticals (may be available for placement later)
- 13 long-term "sabbaticals" (may not be available later)

58 ministers "lost" to

at this time

- 7 seriously seeking placement (as of December 1977)
- 3 ministries closed during this period (Note: Husband/wife teams count as "one minister" unless they fill more than one ministry.)

I was both surprised and a bit shocked by these figures. It is incredible to me that in a two-year period there have been 41 new positions created for ministers in our movement, while there have been 58 ministers, for one reason or another, not available for field work at this time. In short, it appears that our growth and loss rates run approximately 50 ministers per year. Even with three centers having closed during this period, we still would need 48 ministers per year to stay even with our growth and loss rate. While it is likely that some of the ministers on sabbatical will return for placement, it seems clear to me that we are in great need of more ministries as our field work is obviously growing much more rapidly than even those of us involved had anticipated.

These figures are provided to give you something to think about in your own evaluation of the rapid changes that are occurring within our field movement.

SOUTH CENTRAL REGIONAL NEWS with George Rieger:

Nearly 200 Unity students and friends attended the Thanksgiving Joyfest sponsored jointly by Unity Church of Dallas and Unity Church of Fort Worth at Lake Murray Lodge, Oklahoma, November 24, 25, and 26, 1977.

## Most Pastors Must Accept Great Burdens

"I just can't understand what our pastor does with all his time. I certainly don't see him very often."

Have you ever made or heard such a statement? It's hard to understand what many professional persons do because what is seen is just the "tip of the iceberg" of the total job.

How much time the minister spends in professional work depends on many factors: the size of the church, where people live, the availability of employed and volunteer assistance, the expectations of the congregation, work efficiency and the compulsion of the minister to work long hours.

Studies indicate ministers work from 54 to 66 hours a week. They often work seven days a week and are on call 24 hours a day. The Minister's Life and Casualty Union concluded from a recent study, "Your minister puts in the same long hours as a corporate chief executive... The average salaries of these executives are above \$200,000 a year. The average pastoral stipend—about \$10,000.

Long hours, however, do not guarantee a job will be done well or that the more important things will be done. Churches tend to place preaching, pastoral calling and counseling near the top as functions of the ministry. Administration is usually placed much lower in importance. Yet the average pastor spends fully

half of the work week in meetings and with administrative duties.

Why? Sometimes it is because the pastor is expected to be at every meeting, or the congregation says, "Let the pastor do it." Or it may be the minister feels nobody else can do the job as well as he or she can. It is amazing (sometimes shocking) how well members of the parish get along in administrative meetings without the minister. The congregation and the minister alike need to recognize the pastor cannot be everywhere at once and cannot do everything.

Both need to work at freeing time for the most essential work. What can be delegated to others should be, not to get out of work, but to improve the total service of the congregation.

How you can help? Before asking the pastor to attend every church committee meeting, ask yourself if his presence is essential. Perhaps he can present an item or issue and then leave. Help guard his or her time so there can be concentration on the more pastoral functions.

Doing bulletins and keeping membership or stewardship records should not occupy the time of the minister. This can be done well by volunteers or secretarial personnel.

The minister needs time for professional growth and spiritual renewal. If not, the congregation is robbed of quality of ministry. Time and money need to be provided by the congregation.

Remember, the minister is human. Time is needed for family and friends. Vacations are essential. Insist on your minister's taking adequate vacation time. No one can be at his best without getting away from the job. Jesus frequently went away from the crowds to find rest and renewal.

Ask your minister how you can help lighten the administration and organizational tasks. You will be loved for it!

#### UNITY PROSPERITY BANK

The following idea is from **John Tant**, minister of Unity in Baltimore, Maryland. John explains, "We encourage members to use the Unity Prosperity Bank with the following explanation:"

A Communication: PROSPERITY BANKS (Giving One's Self to God—the Good). Unity of Baltimore sponsors prosperity banks as part of its spiritual ministry. What is the purpose of prosperity banks in our ministry? Many new Truth students come into Unity with the desire to be prospered and the prosperity bank is "a method" whereby they break down the poverty consciousness within themselves. Poverty is but the fear of giving.

When the student seeks prosperity the soul is filled with fear of lack and limitation and, therefore, giving is a difficult thing to do. But the prosperity bank is designed with a prayer printed on its side and a small slot to accept a coin. Someone once asked why the prosperity bank did not have a larger slot to accept bills and checks without having to fold them. It was explained the purpose of the small opening was to assure the student the coin is just as effective in the beginning, and therefore will free him from the fear God will not answer his prayers because he has not given a large donation. Many Truth students break themselves free from the habit of poverty by the use of the prosperity bank. They ask the Father, in prayer, to provide them with sufficient coins and have them on hand for their daily prayer periods as a practice of giving.

The prosperity bank and its prayers on the side may seem a mechanical technique at first, not having any spiritual value. But if the student puts his faith in this simple act, demonstrated so successfully in the lives of others, he will rise out of the valley of poverty and start to grow in the consciousness of prosperity.

The prosperity bank gives you an opportunity to train your soul EVERY DAY, to remind it God is its supply and cannot fail. As you silently or audibly Speak The Word found printed on the side of the prosperity bank, you set into action the most dynamic power in the universe, The Spoken Word. The activity of giving the coin and Speaking The Word moves you into a conscious awareness of inner prosperity, where you enter into the financial security of life as success and prosperity through true tithing.

The students who tithe find many blessings pouring into their lives and their hearts well up in True Praise and Gratitude to The Father. Those who experience this testify they have a very strong desire to immediately give in some tangible way, in addition to their tithes. Therefore, they keep a prosperity bank on hand at home. No matter where they are, they take a coin in their hand, bless it, Speak The Word of Praise, and give the coin spiritually and mentally to The Father. They may have to get home and place the coin in the bank to complete this act of giving. But, having responded immediately to the desire to praise God, the conscious feeling of good remains with them and they experience improved health, greater success in their affairs and harmony in their relations within their world. ++

other member, with perhaps sixteen names on the list. When a person calls the minister or assistant for prayer, the prayer is given to the person. Then the minister calls the first person on the list and reads the prayer, repeating it slowly so it can be copied. The prayer is then read back, completing the "three-time reading" for the Father, Son, and Holy Spirit. Each person on the list calls the next, skipping one if there is no answer and going on to the next. So that the circle of Prayer can be completed quickly, members of the circle are encouraged not to visit. The last person on the list calls the minister back, completing the circle.

Each member of the circle includes the names called in when they have their prayer times. This unbroken chain of prayer can accomplish marvelous results, Marie says.

#### **CREDIT CARDS FOR LITERATURE**

James Lewis, minister of Unity Church of Denver, Colorado, takes the credit for the idea of accepting nationally recognized credit cards in his literature sales department.

Representatives of VISA and Mastercharge at the bank where Jim's church has its checking account handled the paperwork. Both bank card companies charge three per cent of the sales total, which means the church makes less from each sale, but Jim is waiting to see if the plan will increase overall sales.

#### **STAR WARS--TELL A FRIEND**

Jane Weber, minister of Unity on the High Plains, Amarillo, Texas, offers this creative idea in her recent bulletin. You may

want to adapt it for your next issue; titled: "Star Wars--Tell A Friend"

"So many have seen the movie 'Star Wars,' which is a beautiful fantasy trip with a deeper metaphysical meaning. The expression used in the movie, 'May the force be with you,' is exactly what Unity teaches! #### **NEW LAW**

Sig Paulson, minister of Unity Village Chapel would like to share the following: "The Missouri State Legislature recently changed the law regarding the necessity for ministers to testify in court regarding information given them in confidence during counseling. The new law, which went into effect in September, 1977, states: 'The following persons shall be incompetent to testify: Any person acting as a minister of the gospel, priest, rabbi or other person serving in a similar capacity for any organized religion concerning a communication made to him in his professional capacity for the purpose of obtaining spiritual counseling, or absolution in accordance with a religious requirement. Any minister of the gospel, priest or rabbi: concerning a communication made to him in his professional capacity as a spiritual advisor, confessor, counselor or comforter."

Since laws regarding court testimony vary from state to state, it would be advisable for a Unity minister to become familiar with his legal responsibility before finding himself in a situation where he might be asked to testify.

#### WHO'S WHO AT UNITY SCHOOL

Almost everyone who has visited, worked, or studied at Unity Village has remarked about how impressed they were with the acres of lawn, the rows of stately trees, the miles of hedges, and of course, the Rose Garden. The grounds at Unity Village are immaculate—the lawns are healthy and green, the trees are strong and well-shaped—the whole place exudes the feeling that somebody cares.

And somebody does care. Unity Village's 1400 acres are beautiful not by chance, but through planning and dedicated effort. One of the leaders of this team effort is **Bill Evans**, a man who has worked at Unity School for more than thirty years. Bill is supervisor of the Landscaping department, and with his crew of ten in winter and fourteen in summer, keeps to a never-ending schedule of mowing, pruning, cleaning, planting, harvesting, and snow removal.

It would be easy to take Bill's work for granted--you could just assume that the grass is not going to grow waist high in the summer, or that the sidewalks will not be covered with leaves in the fall and snow in the winter. You might think that the hedges simply stop growing at a certain height, that the roses bloom from March or April through October without any help, and that the potted geraniums mysteriously turn into Christmas lights right after Thanksgiving all by themselves.

All these things, and more, are the work of Bill's crew. His men work outside all year--through the hot, humid summers and cold, snowy winters, so that visitors and workers can enjoy one of the most beautiful environments in the Midwest.

Bill's work at Unity School began in the thirties, when he joined the "Unity Farm" crew for a time. After World War II, he worked in the Orchard department as assistant manager, and then became supervisor of the Landscaping department in the sixties. Bill and his wife, Nadine, live on the Village grounds. Their son and daughter are both married with one child each, and live in nearby communities. When they come to visit Bill and Nadine, the grandchildren have a huge yard to play in, and except for the golf course and orchard, it is all Bill's to tend.

One area that receives special attention is the Rose Garden, a favorite place for spring, summer, and autumn weddings. Almost everyone who has been to the Village has seen **Leo McCall**, who spends his day pouring out love on the 700 rose bushes, watering and tending them so that their blooms remain beautiful as long as possible.

Then there is the Lowell Fillmore Memorial Garden, dedicated last spring to the memory of Charles and Myrtle Fillmore's second son. The garden and the landscaping around

the new Activities Center are the handiwork of landscape architect **David Ackerman**. David has combined his knowledge of horticulture and architecture to produce two areas of functional and artistic beauty. Few persons realize the painstaking attention to detail with which David has selected and placed the many varieties of plants, trees, and shrubs, but the overall effect is appreciated by everyone who sees the garden.

Still another special area of Unity Village -- one that few persons actually see, but many enjoy -- is the vegetable garden. Totalling fifteen acres, the garden produces tomatoes, sweet corn, squash, peppers, green beans, and eggplant which are sold at the produce stand. Bill Evans' crew plows, plants, cultivates and harvests the bounty each year, maintaining Unity's traditional farming operation.

Bill's department also is responsible for a good-sized nursery, where replacement trees are grown. When any of the original trees have to be removed, they are replaced with hardy maples, oaks, hackberries, ashes, or gums that have been raised from seedlings at the nursery.

To list all the duties that the Landscaping department handles would fill many columns, and added to that, when any other maintenance department at Unity School needs extra help, men from Bill's crew often are called to fill in.

All in all, Bill's department stays busy year-round keeping the Village grounds looking its best, and that is a job which deserves a round of applause.
