Terms and Conditions

Gift Card Usage

- Buffalo Wild Wings® gift cards can be redeemed at any restaurant location in the U.S. We reserve the right to add or delete locations who participate at any time and without notice. Gift cards aren't redeemable online.
- Standard denominations are from \$5 to \$250 in any whole dollar increment.
- Buffalo Wild Wings gift card recipients may check their card balance/value at participating restaurants, online at www.buffalowildwings.com or by calling 1-888-689-4801.
- After the recipient is in possession of the Buffalo Wild Wings gift card and the card is then lost and/or stolen, the card can be cancelled and the remaining value replaced providing the participant has proof of purchase. Client must supply the proof of purchase if needed.
- There is not cash given back as change when using the Buffalo Wild Wings gift card for purchases unless required by law.
- The Buffalo Wild Wings gift card cannot be reissued in another denomination.
- The Buffalo Wild Wings gift card is not eligible for refunds.
- The Buffalo Wild Wings gift card is in US currency only.
- The purchase of Buffalo Wild Wings gift cards is for the intended use of corporate incentive, gift-giving programs and consumer loyalty programs. The Buffalo Wild Wings gift card cannot be resold without express written approval from Buffalo Wild Wings corporate office.

- Shipping options via FedEx include free standard Ground delivery or 2nd Day for \$9.95.
- Discounts, fees and procedures quoted are subject to change without notice at the discretion of Buffalo Wild Wings. We will make every effort to provide a 30-day notification period of any changes but do not guarantee such notice.
- Additional program or corporate use of the Buffalo Wild Wings gift card requires completion of a new Terms and Conditions form.

Payment Process

- Accepted payment methods include credit card (not to exceed \$2,500/order); company check; money order; certified check; or electronic funds transfer. Orders will not be fulfilled until payment has been verified.
 - All cards are activated by Buffalo Wild Wings or its affiliates upon confirmed receipt of payment.
