Director Ashley Morgan called the meeting of the Texas Water Development Board to order at 9:30 a.m. This meeting was held at 1601 Congress, Room 2.029, Austin, Texas, 78701. In addition to Director Morgan, Director Brady Franks was in attendance, and a quorum was present. The board may also meet in open meeting to take action on legal or personnel matters considered in the closed meeting as required by section 551.102 of the open meetings act, chapter 551 of the government code.
