



For United Financial Freedom Independent Agents: Affiliate Compensation Plan

When an Affiliate Partner is participating in a sale, the total commissionable volume is reduced by the Affiliate Partner commission amount (see Affiliate Commission Rates below).

UFF Agent Compensation is based on the Total Commissionable Volume.

Rank Advancement and Pool *Qualification* is still based on [Paid Volume](#).

For Full Price Activation with Affiliate Partner for Full Price \$3,995:

To find the Commissionable Volume on a sale amount of \$3995.00 through PayPal, in-house financing or any major credit card you must first subtract 5% off of the top of the sale amount, or multiply the sale amount by 95% and from there multiply again by 70% giving you the commissionable volume of \$2,656.68. Subtract the \$300 Affiliate Fee for Platinum for \$2,356.68 Another way to do this is: $95\% \times 70\% = 66.5\% \times \$3,995 - \$300 = \$2,356.68$.

Affiliate Compensation Plan

Compensation is paid for each Referral that activates the Money Max Account program*. The Money Max Account Program has different product levels depending on amount, and type of debt. The majority of activations are for the Platinum product group.

Platinum and Above: \$300 per activation

(Platinum is purchased for managing 1 or more mortgages)

Gold: \$200 per activation

(Gold may be purchased managing less than \$80,000 in debt)

In-House Financing or Subscription: \$100

Some clients may choose to take advantage of our In-house Financing program to pay for the Money Max Account. In this scenario, the Affiliate fee is \$100.

*Referrals must be made using the unique tracking link (Referral Website) provided to you upon acceptance into the program. It is your responsibility to ensure the link is used correctly. United Financial Freedom is not responsible for tracking issues resulting from incorrect use of the referral link and/or Referral website. Referrals made through your referral website will be assigned to Sponsoring Representatives (also known as an "Affiliate Sponsor").

Frequently Asked Questions

If I am the selling agent on a client referred from an Affiliate Partner, does the Affiliate commission come out of my portion?

The amount does not come directly from your portion of the commission. On each sale, we calculate the Commissionable Volume (*The amount of a sale that is eligible to be paid out to the field in the form of commissions, overrides, and Profit Pools.*) Once the Commissionable Volume is determined, we subtract the Affiliate Partner fee, and the remaining amount is paid out through the [UFF Compensation Plan](#). In short, your overall commission will be reduced, but your overall percentage will remain the same, based on your current Rank.

I am already a UFF Agent, can I sign up for the Affiliate Partner Program?

Yes, you can change your status to become an Affiliate Partner instead. However, at this time you cannot retain your status as an Independent Agent and become an Affiliate Partner at the same time. You can choose to remain an Independent Agent and participate in the career progression and fantastic compensation plan, or change your status to be an Affiliate Partner.

If you would like to become an Affiliate Partner, on May 8th you can fill out the form located in the Back Office, and submit a request to be changed to an Affiliate Partner. Any Active prospects will be moved to your sponsor, and you will be set as the Affiliate Partner. Your downline agents will be compressed to your upline sponsor. This cannot be undone.

Can Anyone become an Affiliate Partner?

To become an Affiliate Partner, each applicant must:

- Be at least 18 years of age;
- Reside in the United States or U.S. territories;
- Have a valid Social Security or Federal Tax ID number in the U.S.;
- Never have been convicted of a felony offense or crime involving fraud or deceit;
