

DISARMAMENT COMMISSION

NOTE BY THE SECRETARY-GENERAL

- 1. By resolution 43/78 A of 7 December 1988, the General Assembly, inter alia, took note of the special and annual reports of the Disarmament Commission $\underline{1}$ / and requested the Secretary-General to transmit to the Disarmament Commission the special and annual reports of the Conference on Disarmament, $\underline{2}$ / together with all the official records of the fifteenth special session and the forty-third session of the General Assembly relating to disarmament matters.
- 2. Pursuant to that request, the relevant documentation is listed below:
