SECOND REPORT OF THE SUB-COMMITTEE OF THE DISARMAMENT COMMISSION

- 1. The Sub-Committee of the Disarmament Commission, which is composed of representatives of Canada, France, the Union of Soviet Socialist Republics, the United Kingdom of Great Britain and Northern Ireland, and the United States of America, was established by the Commission at its 35th meeting on 19 April 1954, pursuant to General Assembly resolution 715 (VIII) of 28 November 1953. On 22 June 1954, the Sub-Committee submitted its first report (DC/53) to the Disarmament Commission. The Disarmament Commission, at its 44th meeting on 19 November 1954, decided, pursuant to General Assembly resolution 808 (IX) of 4 November 1954 to request the Sub-Committee to reconvene and resume its work.
- 2. The Sub-Committee held its 21st meeting at United Nations Headquarters in New York on 8 December 1954, considered administrative and procedural arrangements, and agreed to continue its discussions in London in the latter part of February 1955.
- 3. The Sub-Committee's discussions continued at Lancaster House in London for twenty-eight meetings (22nd to 49th inclusive) between 25 February and 18 May 1955.
- 4. During the course of these meetings, various proposals, draft resolutions, and memoranda were submitted to the Sub-Committee, as follows:

- 5. At its 49th meeting on 18 May 1955, the Sub-Committee agreed that its next meeting should be held at United Nations Headquarters in New York on 1 June 1955 "in order to give the five Governments represented on the Sub-Committee an opportunity to consider the situation now reached and the progress made since the talks began on 25 February". The 50th meeting of the Sub-Committee was accordingly held at New York, when the Sub-Committee discussed its future programme of work.
- 6. The Sub-Committee reconvened at United Nations Headquarters on 29 August 1955 to continue its work. It decided to take account of the directive issued by the four Heads of Government at the conclusion of their conference in Geneva on 25 July 1955. It continued its discussions for 18 meetings (51st to 68th meetings inclusive) between 29 August and 7 October 1955.

- 10. This report was approved by all members of the Sub-Committee at the 68th meeting on 7 October 1955, and is hereby submitted to the Disarmament Commission as a report of the Sub-Committee's work to date.
