AGREEMENT TO PROVIDE SERVICES TO VISUALLY IMPAIRED STUDENTS IN  
MID-OHIO EDUCATIONAL SERVICE CENTER**

The Mid-Ohio Educational Service Center hereby enters into a contract for services to student(s) listed below for remainder of school year 2019-20. Instruction will be in accordance with commonly accepted practices in the field of education of the blind and visually impaired.

The purposes of these services will be to fulfill the goals and objectives of the pupil's Individualized Education Plan (IEP) as submitted. Narrative reports will be submitted quarterly for each student, outlining the student's progress, along with any recommendations for further training.

Mid-Ohio Educational Service Center agrees to pay \$80.00 per hour for the instructional, evaluative, or consultative services provided, including attendance at IEP meetings.

Cleveland Sight Center agrees to provide the services required. The instructor and client will establish a mutually agreeable schedule. It is understood that less than a two-hour cancellation notice by the Mid-Ohio Educational Service Center will result in a fee of 50 percent of the normally anticipated fee for that appointment. Services will be billed monthly and payment will be expected within 30 days of receipt of invoice.


