

MODIFICATION NO. 1
TO OHIO COMMUNITY SCHOOL CONTRACT
BY and BETWEEN
Mid-Ohio Educational Service Center (“Sponsor” or “MOESC”)
AND
GOAL Digital Academy (“Governing Authority” or “School”)

WHEREAS, the MOESC and the Governing Authority entered into the 2018 Amended Second Successor Community School Sponsorship Contract (“Contract”); and

WHEREAS, the MOESC and the Governing Authority agree to the following modifications;

NOW THEREFORE, the parties modify the Contract as follows:

1. **Article II.** Insert the following as a new sentence at the end of the Article: “All members of the Board of Directors shall undergo a criminal records check pursuant to Revised Code Section 3319.39, the results of which shall be reviewed by and deemed satisfactory to the SPONSOR.”

The rest of Article II remains as originally written in the Contract.

2. **Article III, Section B.** Insert “conducted a high stakes review” before the word “determined” in the first sentence of the section.

The rest of Section B remains as originally written in the Contract.

3. **Article IV, Section D.** In part (2), division (i), remove “orientation activities that introduce enrolled students to the technology of internet-based instruction” and replace with “intentionally left blank.”

The rest of Section D remains as originally written in the Contract.

4. **Article IV, Sections F and G.**

- a. Combine the first sentences of Sections F and G into a single sentence. Renumber the sections accordingly.

- b. In Section G, remove “3313.603(J)(1) and (2)” and replace with “3313.603(J)(1) to (3).”

- c. In Section G, insert “3313.6024 [prevention programs]” and “3313.818 [breakfast program]” in correct numerical order.

- d. Remove “3319.074” from existing Section G.

- e. The rest of existing Sections F and G remain as originally written in the Contract.

5. **Article IV, Section K.** In the second sentence, insert “and all members of the Board of Directors” after the words “all staff.”

The rest of Section K remains as originally written in the Contract.

6. **Article IV, Section M.** In the first sentence of part (2), replace “Sections 3313.611 [adult education diploma], and 3313.614” with “Sections 3313.611 [adult education diploma], 3313.614 [alternative conditions for award of diploma], 3313.6114 [diploma seals], and 3313.618 [graduation requirements].”

The rest of Section M remains as originally written in the Contract.

7. **Article IV, Section O.** In part (5), insert “The names of the members of the Board of Directors shall be posted on the School’s website.”

The rest of Section O remains as originally written in the Contract.

8. **Article IV, Section U.**

- a. In the first sentence of the section, insert “which may include termination criteria established by the SPONSOR in its Sponsor Termination Policy” after “other good cause.”

- b. In the second sentence of the section, insert “absent circumstances unforeseen at the time of contracting,” before the word “termination.”

- c. The rest of Section U remains as originally written in the Contract.

9. **Article V, Section A.** In part (2), insert as a new sentence: “The SPONSOR’s analysis shall be based on the Education Plan in Exhibit 1 Part A and the Performance and Accountability Standards in Exhibit 3, state issued report cards, and any other analysis conducted by the Ohio Department of Education.”

The rest of Section A remains as originally written in the Contract.

10. **Article VI, Section A.**

- a. In the first sentence of the section, insert “, which shall be conducted at least once every five (5) years and prior to any renewal,” after “(B).”

- b. In the final sentence of the section, remove “(3314.03(A)(16))” and replace with “(R.C. 3314.03(A)(16)), which shall be specified in a procedure provided to the SPONSOR upon request.”

- c. The rest of Section A remains as originally written in the Contract.

11. **Exhibit 3** shall be replace in its entirety with the attached.

ALL OTHER SECTIONS, SUBSECTIONS, TERMS, OR PROVISIONS OF THE CONTRACT SHALL REMAIN IN FULL FORCE AND IN EFFECT UNLESS OTHERWISE SPECIFICALLY MODIFIED HEREIN.
