



Welcome to our hotel! We are delighted to have you and your pet as our guests. To ensure a comfortable stay for you and fellow guests, we ask you please observe the following guidelines:

- The hotel is prepared to accommodate your pet in the room, provided that the pet is a dog with a maximum weight of 25lbs (maximum of 2 pets), is fully trained and vaccinated, appropriately restrained by you at all times, and complies with all applicable laws and local legislation or requirements associated with or governing the presence of pets within the hotel. Other restrictions may apply. Please note that Emotional Support Animals (ESAs) are considered pets and are subject to the hotel's pet policies and applicable pet fees. Only trained Service Animals, as defined by applicable law, are exempt from pet fees and restrictions.
- Pets other than domesticated dogs are subject to the prior written review and approval of the hotel's general manager.
- Your pet must be kept on a leash or in a kennel, crate or similar travel carrier while in the hotel or on hotel property, unless in your room.
- Your pet vaccinations must be up-to-date, and your pet free of ticks and fleas. You agree not to bring any pet to the hotel in the event the pet becomes ill or contracts a disease.
- You are responsible for cleaning up after your pet both inside the hotel and throughout the hotel grounds.
- Your pet is not permitted to damage or mar any part of the hotel or hotel grounds.
- Any disturbances, such as barking, must be curtailed to ensure other guests are not disturbed. We recommend that your pet is not left alone in room. In the event that your pet is left unattended and is a disruption to other guests, please be advised that you will be contacted by the hotel for immediate action. If you require a pet sitter, please contact our concierge with as much advance notice as possible.
- California Law - Health & Safety Code section 114259 does not permit pets, including Emotional Support Animals inside any of the hotel's dining facilities, pools, spas or fitness centers at any time. Service Animals trained to perform specific work or tasks for a person with a disability are permitted throughout the hotel.
- Our pet fee is \$125 (non-refundable) per stay. The hotel will charge an additional cleaning fee should the room require excessive cleaning above its regular cleaning standards due to soiled bedspreads, furniture or carpeting. Or if additional cleaning costs arise from any damage caused by the pet in any part of the hotel or to the personal property of others.
- We reserve the right to ask guests to leave the hotel if their pets are deemed noisy, disruptive, or dangerous.

I understand that my pet's behavior is my responsibility.

I hereby acknowledge full responsibility for the action of my pet. In the event that my pet causes an injury regardless of circumstances or provocation, I assume all liability and agree to full responsibility for all related costs including, but not limited to medical expenses, pain and suffering, mental anguish, legal fees and any and all other damages. I hereby agree to indemnify, defend, protect and hold the hotel, its owners, operators and their respective partners, affiliates, subsidiaries, ground lessors, managers, directors, employees, agents, and contractors harmless from and against any and all claims and costs arising from, resulting from, or connected with the acts or presence of my pet in the hotel (including, without limitation, bodily injury to persons in the hotel or property damage to the personal property of the hotel or any occupant or invitee of the hotel). I agree that I may need to make a payment above the non-refundable charge of \$125 per stay to provide additional cleaning services as required. I further agree that I will pay for any damages. Such damages include, but are not limited to, damage to carpet and furniture, fixtures and bedding. I understand that my pet may disturb other guests of the hotel and agree to pay for any guest resolution compensation, their lodging, and other related charges, should such a disturbance occur.

I hereby authorize the hotel to charge the credit card I have on file for my hotel stay for any and all such damages.
