## Instructor Bio

Dr. Jessica Graning joined the Department of Physical Therapy at Western Carolina University in spring 2011 as the Director of Clinical Education (DCE) and assistant professor in pediatrics. In her role as the DCE, Dr. Graning coordinates all full-time clinical education experiences and supervises students in pediatric and simulated integrated clinical education experiences. As a clinical instructor for 13 years, she has experience in the 1:1 and team-based collaborative models. Prior to this appointment, she worked as a pediatric physical therapist at Mission Children's Hospital (2003-2011). Dr. Graning plays an active role in the Carolina Clinical Education Consortium serving on the organization's Executive Council. She also serves on the Mountain Area Probono Health Services (MAPHealth) Advisory Board, supervises students in the MAPHealthclinic, and provides consultation for pediatric clients (in collaboration with other faculty members). Dr. Graning most enjoys developing new clinical education programs and training clinical educators. Dr. Graning maintains membership in the APTA Academy of Physical Therapy Education and the Academy of Pediatric Physical Therapy. Together with Dr. Todd Watson, Dr. Graning has recently published a study demonstrating improved performance on measures of dance, balance and muscle performance following an intensive 9-week core stability program. They are currently conducting a study examining the effects of their core stability program on injury rates in competitive collegiate dancers, as well as examining the incidence and prevalence rates of injuries affecting marching band members.



Dr. Kara Lardinois serves as Academic Coordinator of DPT STEPs® (Student Team Experience in Practice) for the Duke Doctor of Physical Therapy program. She trains clinical educators to teach in this collaborative model and guides student development plans to improve foundational skills and professional behaviors. Her clinical practice is in the area of pediatrics for Duke Health. As a clinical instructor for 17 years, she has experience teaching in both the collaborative and 1:1 model. She is a co-director and mentor for the Duke Pediatric Physical Therapy Residency. Dr. Lardinois maintains membership in the APTA Academy of Physical Therapy Education, APTA Academy of Pediatric Physical Therapy, and the Neurodevelopmental Treatment Association (NDTA). Credentialed Clinical Instructor Program Level II (CCIP Level II) is the successor to APTA's former Advanced Credentialed Clinical Instructor Program (ACCIP). This voluntary program is designed for physical therapists and physical therapist assistants who have successfully completed the APTA Credentialed Clinical Instructor Level I Program (CCIP Level I), and want to further develop their clinical teaching skills and construct a clinical curriculum. The unique philosophy and design of CCIP Level II both applies and goes beyond the concepts of the structured learning environment of CCIP Level I to enable clinical educators to achieve the best outcomes for student learning. This voluntary program is designed for physical therapists and physical therapist assistants who have supervised or overseen the supervision of at least one student in clinical practice, or have been actively involved in student learning and education since receiving the APTA CCIP Level I credential. Program participants must complete prerequisites including completion of a CCIP Level II Participant Dossier, a series of 3 online professionalism modules, and review of 4 articles, in addition to completing a live 2-day program with an Assessment component.

## **Student Learning from a Neurologic Task Analysis Viewpoint**

**Instructor: Sara Migliarese**

Task analysis is a detailed observational analysis of total body movement patterns during task performance commonly used with neurologic patients. However, it can also be applied to a student's clinical performance. Task analysis will be discussed as an approach to determine where student problems occur and how to address them.

### **Instructor Bio**

Sara Migliarese has practiced as a physical therapist for over 33 years and is currently an associate professor in the Winston Salem State University Department of Physical Therapy. She teaches adult neuromuscular rehabilitation and conducts research in the areas of vestibular rehab, balance and fall prevention, and multiple sclerosis. Dr. Migliarese is the director of the WSSU-Novant Health Clinical Neurologic Residency Program and serves the community at the free MSFit Clinic, the REAHCE Star Clinic, and the Community Care clinic, while mentoring DPT students as they assess and treat adults with neurologic conditions.

## **Health Equity**

**Instructor: Emma White**

This presentation will begin to connect the dots between population health and the management of common musculoskeletal conditions. Musculoskeletal pain is our wheelhouse! But what we don't know is whether there is a relationship between poorly controlled diabetes and chronic LBP or will poor nutritional habits contribute in the persistence of knee pain or shoulder dysfunction for that matter. These are the questions we should be asking. We need to widen our gaze in terms of looking beyond just treating the condition but rather prevention of musculoskeletal conditions at the population level. This approach is a new way of thinking and thus will impact how we practice. Change is difficult and when integrating any new principle the biggest hurdle is how to start the conversation and actually apply principles and techniques into clinical practice settings. Integrating population health is truly a massive undertaking but one that can no longer be ignored, our health care system can no longer bear the exorbitant costs of health care that continue to rise. Musculoskeletal pain and injuries are now more common in terms of prevalence than chronic diseases such as cancer, diabetes, and hypertension. As physical therapists we are in prime position to effectively and positively impact this aspect of patient care.

### **Instructor Bio**

Dr. White graduated from the Medical College of Virginia with a BS degree in physical therapy and later went on to receive the tDPT from the University of North Carolina- Chapel Hill in 2008. She has over 25 years of clinical experience working predominantly in an outpatient orthopedic setting; she owned an orthopedic private practice for 16 of those years. While in this orthopedic setting her primary focus was on managing patients with spine, both cervical and lumbar, and general orthopedics (surgical and non-surgical), as well as sports rehab and sports enhancement. She joined the faculty at Winston Salem State University's Department of Physical Therapy in May 2011 as a part of the orthopedic team. Her content area is management of musculoskeletal conditions affecting the upper extremity, therapeutic exercise, and musculoskeletal management of complex conditions. She is very active with the APTA and NCPTA working with insurers on reimbursement.

## **Strategies for Management of Different Learning Styles**

This session will discuss some of the different learning and performance styles PT and PTA students tend to demonstrate (exceptional to lower performing) and provide strategies for enhancing engagement in learning and performance. There will be lecture and small group activities.

## **Pharmacology in Rehabilitation**

**Instructor: Doris Molina-Henry**

### **Instructor Bio**

Dr. Molina-Henry completed her PhD in the department of Neurobiology and Anatomy at Wake Forest University, Health Sciences. Her doctoral studies focused on the effect of trophic factors on age-related changes in the brain. Specifically, she published studies of the effect of growth hormone on age-related changes in synaptic transmission. Upon completion of her studies she was awarded the RJR Leon Goldberg Post-Doctoral Fellowship which enabled her to study the role of proton sensing receptors in renal function. She then became a PRIME-IRACDA scholar at Wake Forest University, Health Sciences, where she performed research on the mechanisms underlying alcohol withdrawal-induced seizures. As a PRIME-IRACDA scholar, she taught as a guest lecturer for the Doctor of Physical Therapy Program at WSSU, an opportunity which led her to join the Physical Therapy Department at WSSU as a full-time assistant professor.

## **Communicate in Your True Color**

This session introduces clinical instructors to personality preferences using True Colors method, an iteration of the Myers Briggs Personality Inventory, to identify personal and student styles of communication. Emphasis is on giving and receiving feedback in a most effective manner to maximize student performance in clinical settings.

# Legal and Ethical Considerations in Clinical Education

The legal requirements and ethical considerations of physical therapy education are often not clearly stated by academic programs to our clinical partners. Understanding how these regulations and standards impact Clinical Instructor/Site Coordinator of Clinical Education interactions with student and academic representatives is critical for success. If you are unsure of what supervision is required in your setting, or if you have every asked why a DCE/ACCE did not discuss prior student performance, this session will be beneficial.

The CPI is currently commonly used as a student performance tool in physical therapist education. Despite its wide use, the rating scale is often described as rigid, complicated and a barrier to participation as a clinical instructor. This session will discuss practical application of the tool for use in both short and long-term clinical placements, as well as its value in self-assessment for student growth.

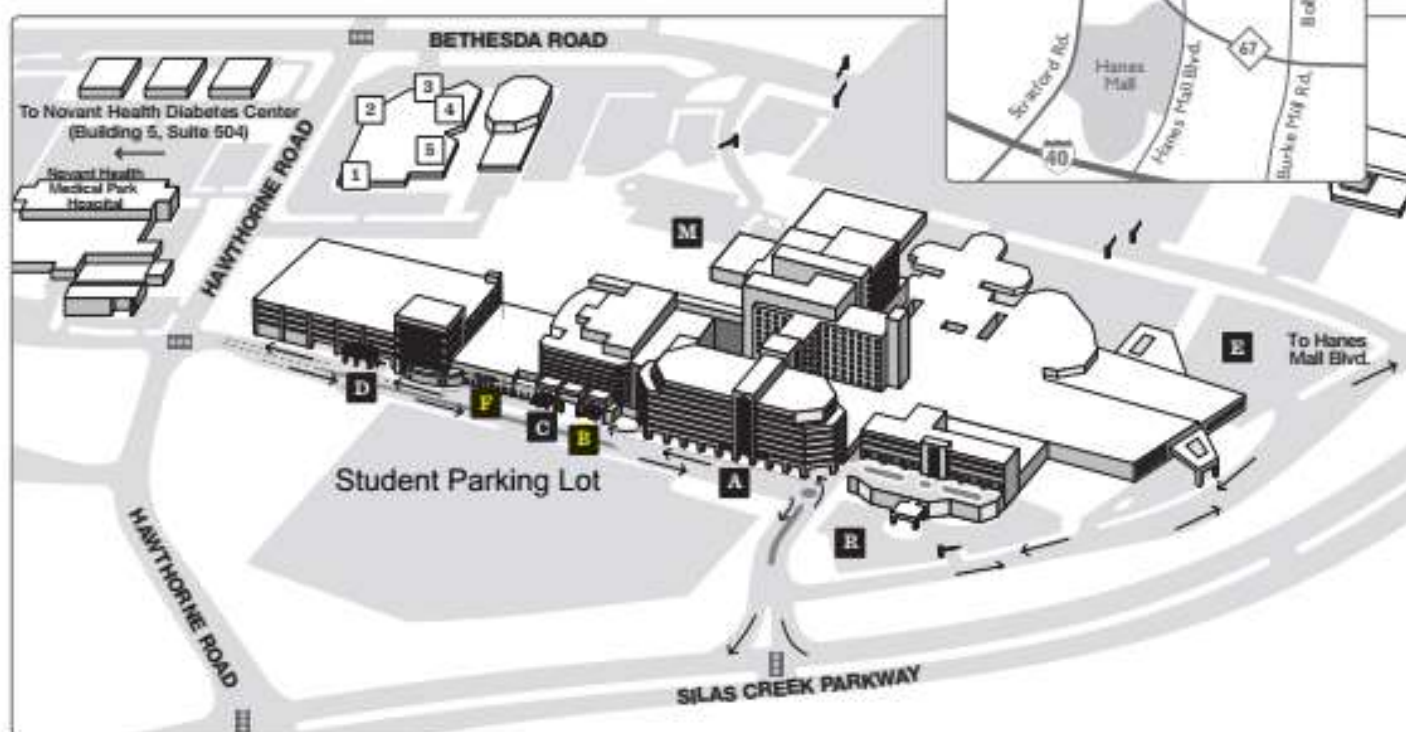

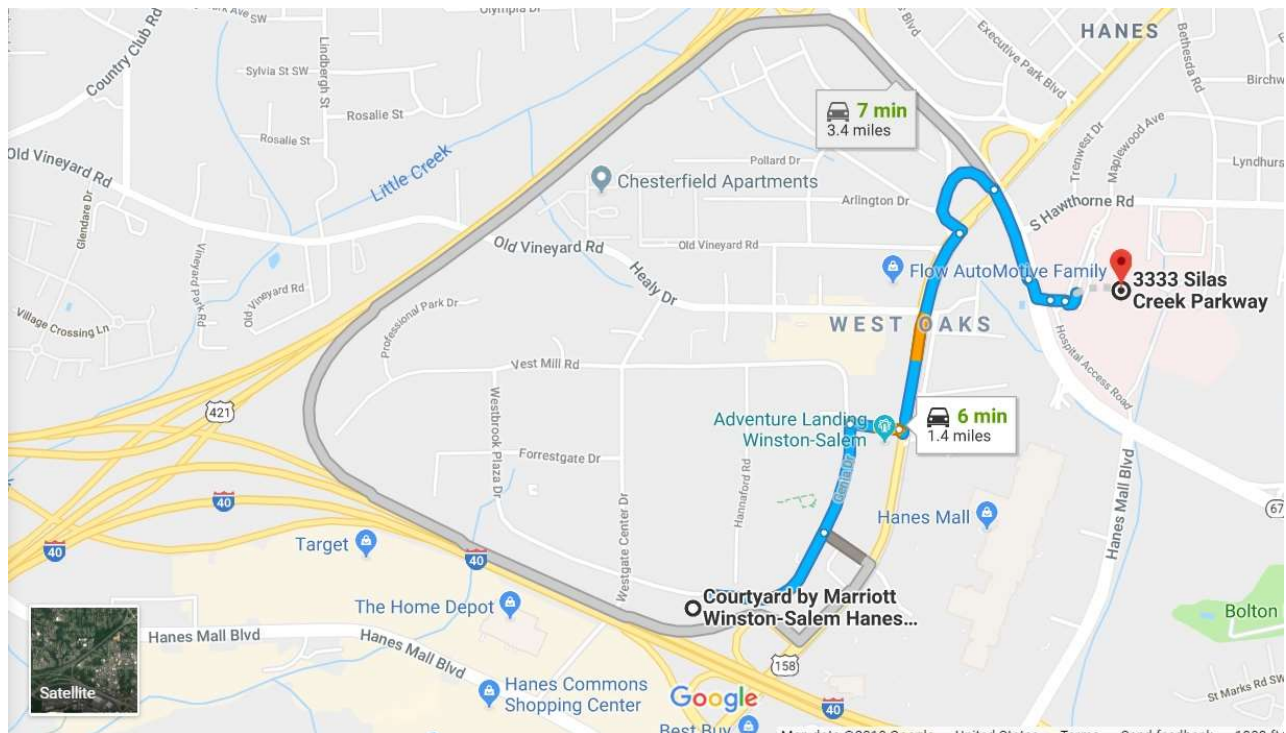
