

## **EVENT TERMS AND CANCELLATION:**

Cancellation Policy for ALL Events

Cancellations on or before June 1, 2020, 25% event fee + admin fee (25.00USD).

Cancellation after June 1st, 2020 - 50% event fee + admin fee (25.00USD).

Cancellations after Aug 30<sup>th</sup>, 2020 no refunds.

## **CONTRACTING COVID-19 CANCELLATION POLICY FULL REFUND**

- **Participants seeking refunds due contracting COVID 19** consent to the disclosure of private, confidential medical information/records to process a refund claim due to contracting COVID 19, and further agree that the documents/information submitted complies with HIPAA's rules and regulations.
- **Documents required for refund claim** a letter, declaration or affidavit from a licensed medical provider.

## **HIGH RISK COVID-19 CANCELLATION POLICY**

This includes:

- Older adults
- People who have serious chronic medical conditions like: Heart disease, Diabetes, Lung disease

If you are at higher risk for serious illness from COVID-19 because of your age or because you have a serious long-term health problem, it is extra important for you to take actions to reduce your risk of getting sick with the disease.

HIGH RISK PARTICIPANT cancel by *August 1st* we will be able to refund almost your full payment minus 5% cancellation.

HIGH RISK PARTICIPANT cancel by *September 1st* we will be able to refund almost your full payment minus 10% cancellation.

HIGH RISK PARTICIPANT If you cancel after September 1<sup>st</sup> and other people can take your place from the waiting list we will be able to refund almost your full payment minus 10% cancellation.

- **Documents required for refund claim** a letter, declaration or affidavit from a licensed medical provider.

## **EXTRAORDINARY CONDITIONS CANCELLATION POLICY FULL REFUNDS**

• Sudden injury; a pregnancy emergency; an emergency surgery, or similar unplanned medical procedure within the seven (7) days prior to the event, death in immediate family.

- Consent to the disclosure of private, confidential medical information/records to process of a refund claim due to Sudden injury; a pregnancy emergency; an emergency surgery, or similar unplanned medical procedure within the seven (7) days prior to the event, and further agree that the documents/information submitted complies with HIPAA's rules and regulations.

- **Documents required for claim:** In the case of an emergency medical procedure, a letter, declaration or affidavit from a licensed medical provider, or a treatment record from the procedure itself. In the case of death, a copy of the death certificate or other official documentation confirming the date and time of death.
