- 3. I understand that taking photos/videos in the audience is STRICTLY PROHIBITED!! If I or any family member/friend is caught taking pictures, my student will be banned from the program.
- 4. I understand that any absences during tech week and/or performances will result in my student losing a performance and/or being dismissed from the production.
- 5. I understand that my student may need to be excused from school for 1-2 days for school performances. I acknowledge that if I do not agree to this that my student will not be considered for a large role.
- 6. I will volunteer the minimum requirement for each production. I will pay \$20 per hour for every hour not volunteered which must be paid by tech week. I understand I can pay an opt out fee for volunteer hours.
- 7. I understand that my student may be dismissed from the program due to failure to comply with Starbound Theatre policies. I understand this is at the discretion of Starbound Staff.
