

WAIVER AND RELEASE OF LIABILITY FORM FOR THE ACAPPELLA COMPANY, PRAISE AND HARMONY, AND THE Memorial Road CHURCH OF CHRIST

I am or will be attending the Praise and Harmony recording in Edmond, OK, which is conducted by The Acappella Company and Praise and Harmony in conjunction with the Memorial Road Church of Christ. **In consideration of my registration for this 2027 Praise and Harmony Recording (and associated events and activities) conducted by The Acappella Company, Praise and Harmony, and the Memorial Road Church of Christ and my attendance at this Praise and Harmony Recording and associated events, I hereby assume all of the risks of participating in the recording and any and all events and activities associated with the Praise and Harmony Recording and associated events,** including by way of example and not limitations, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained, or controlled by them, my participation in any activities in connection with the Praise and Harmony recording which may expose me to an infection, illness, or disease of any type, or because of their possible liability without fault. This assumption of the risk includes but is not limited to any personal injury, death, disability, illness, or disease which I may suffer, incur, or sustain while in attendance at the Praise and Harmony Recording.

I certify that I have no health-related reasons or problems that preclude my participation in the Praise and Harmony Recording, and/or I have assessed the risks attendant to attendance and participation in the Praise and Harmony Recording given my age, physical condition, and health. I acknowledge that this Waiver and Release of Liability Form will be used by the event holders, sponsors, and organizers of the activity in connection with the Praise and Harmony Recording in which I participate or attend, and that it will govern my actions and responsibilities at the Praise and Harmony Recording and associated events.

In consideration of my application and permitting me to attend and participate in the Praise and Harmony Recording and associated events and activities, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

- (A) I waive, release, and discharge from any and all liability, including but not limited to liability arising from the negligence or fault of the Entities and/or persons herein released, for my death, disease, infection, illness, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from this activity, the following Entities and/or persons: The Acappella Company, Praise and Harmony, and the Memorial Road Church of Christ, and their directors, officers, employees, volunteers, representatives, agents, servants, and independent contractors, sponsors, and volunteers; and
- (B) I hereby indemnify, hold harmless, and promise not to sue the entities or persons mentioned in this paragraph and all of its subparts from any and all liabilities or claims made as a result of attendance or participation in this activity and/or

associated events, whether caused by the negligence of release or otherwise caused in connection with or by The Acappella Company, Praise and Harmony, the Memorial Road Church of Christ, and their directors, officers, employees, volunteers, representatives, agents, servants, and independent contractors, and sponsors and volunteers.

- (C) I hereby agree and covenant to adhere to and follow all guidelines and instructions for safety, good health, disease prevention, and accident prevention given or promulgated by The Acappella Company, Praise and Harmony, and the Memorial Road Church of Christ. I understand that any failure or refusal to adhere to and follow such guidelines may result in my being barred from further participation and attendance at The Acappella Company, Praise and Harmony, and the Memorial Road Church of Christ, which shall be at the sole discretion of The Acappella Company, Praise and Harmony, and the Memorial Road Church of Christ.

I acknowledge that The Acappella Company, Praise and Harmony, and the Memorial Road Church of Christ, and their directors, officers, employees, volunteers, representatives, agents, servants, and independent contractors are NOT responsible for the damages, errors, omissions, acts, or failures to act of any party or entity released herein conducting a specific activity on their behalf.

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during the Praise and Harmony Recording and any and all activities and events in connection with the recording event.

The Accident Waiver and Release of Liability Form shall be construed broadly to provide a release and waiver to the maximum extent under applicable law.

I CERTIFY THAT I HAVE READ THIS DOCUMENT AND I FULLY UNDERSTAND ITS CONTENT. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT, AND I SIGN IT OF MY OWN FREE WILL.
