## Casino Marketing Boot Camp 2022

## Terms & Conditions

PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY AS THEY CONTAIN IMPORTANT INFORMATION REGARDING YOUR LEGAL RIGHTS, REMEDIES, AND OBLIGATIONS. THESE TERMS AND CONDITIONS INCLUDE VARIOUS LIMITATIONS AND EXCLUSIONS AND A CLAUSE THAT GOVERNS THE JURISDICTION AND VENUE OF DISPUTES.

- 1. These are the terms and conditions which apply to Casino Marketing Boot Camp and form an agreement between you ("you" and when used in the possessive form herein "your") and J Carcamo & Associates, LLC, a Louisiana limited liability company ("we" or "us" and when used in the possessive form herein "our"). If you accept or agree to these terms and conditions on behalf of a company or other legal entity, you represent and warrant that you have the authority to bind that company or other legal entity to these terms and conditions, and in such event, "you" and "your" will refer and apply to that company or other legal entity. We will not file a copy of our agreement with you.
- 2. By booking Casino Marketing Boot Camp, you accept these terms and conditions. You should read them carefully before making a booking. We recommend you save a copy of them for your future reference.
- 3. You acknowledge that the venue, technology, timings, speakers, and programing for Casino Marketing Boot Camp are subject to reasonable changes as determined in our sole discretion, including but not limited to the changes of the type described in section 14 of these terms and conditions.
- 4. Casino Marketing Boot Camp is designed for property casino marketers. Casino marketing vendors may attend with a sponsored casino marketer by registering as such. Sponsored casino marketers must be employees of an operating casino company. Any violation of this is subject to cancellation. A cancellation fee of 35% will be assessed. Online convenience fees are not refundable.
- 5. For the health and safety of all participants and coaches, proof of COVID vaccination or negative PCR test result administered no earlier than April 30, 2022, may be required and if so required, must be submitted no later than 12:00 noon (CST) on May 2, 2022. Participants will be required to follow all current COVID protocols established by the host hotel and local government while attending Casino Marketing Boot Camp. Failure to do so will result in expulsion with no refund of fees.
- 6. If you cancel your properly registered Casino Marketing Boot Camp booking prior to March 31, 2022, a 20% fee will be assessed on the registration fee, and your registration fee balance will be refunded. If you cancel after March 31, 2022, or do not attend the event, the registration fee will not be refunded but may be applied to other programs at the discretion of J Carcamo & Associates. FAILURE TO COMPLY WITH COVID REQUIREMENTS WILL DISQUALIFY YOU FROM A REFUND OF ANY AND ALL FEES. Online convenience fees are not refundable.
- 7. Please ensure you take care of your personal possessions and privacy during any Casino Marketing Boot Camp program as we cannot accept responsibility or liability for them.
- 8. Filming and photography may take place during Casino Marketing Boot Camp. You consent to your image and likeness being used in marketing and any media without any payment to you.
- 9. For the safety of all attendees, Casino Marketing Boot Camp is 'weapons free' and all conference participants, including staff, volunteers, and attendees, are banned from possessing any object or substance intended to cause injury to others, including but not limited to firearms. Any violation of the safety of our participants by you will result in your expulsion from Casino Marketing Boot Camp and registration fees will not be refunded.
- 10. Casino Marketing Boot Camp is committed to creating an environment where everyone can participate without harassment, discrimination, or violence of any kind. All meeting participants must be treated with respect and consideration. Your registration for the conference is considered an agreement by you to abide by this code of conduct. Any violation by you will result in your expulsion from Casino Marketing Boot Camp and registration fees will not be refunded.
- 11. Vendor participants may network but not sell their products or services during this event unless classified as a sponsor participant.
- 12. Harassment of any participant (attendee, speaker, volunteer, exhibitor, staff member, service provider, organizer, or meeting guest) will not be tolerated. Unacceptable behavior includes (but is not limited to) unwanted verbal attention, unwanted touching, intimidation, stalking, shaming, or bullying. Any violation by you will result in your expulsion from Casino Marketing Boot Camp and your registration fees will not be refunded.

- 13. Discrimination on the basis of gender or gender identity, sexual orientation, age, disability, physical appearance, race, religion, national origin, or ethnicity will not be tolerated. Harassment presented in a joking manner is still harassment and constitutes unacceptable behavior. Retaliation for reporting harassment is also unacceptable, as is reporting an incident in bad faith. Any violation by you will result in your expulsion from Casino Marketing Boot Camp and registration fees will not be refunded.
- 14. In order to comply with sanctions imposed by the UN, EU, US, and any local authorities, we cannot accept payments or registrations from the Crimea region of Ukraine, Cuba, Iran, North Korea, Syria, Iraq, Sudan, Belarus, Lebanon, and Yemen.
- 15. We shall not be considered in default in the performance of our obligations to you in connection with Casino Marketing Boot Camp or these terms and conditions to the extent our performance of an obligation is prevented, hindered, or delayed by any cause that is beyond our reasonable control, including but not limited to acts of God, war, government regulation (including governmental advisories, quarantines and curfews) natural disaster, fire, strikes or other labor disputes, curtailment or disruption of transportation, civil disorder, terrorism and responses thereto, epidemics and pandemics, an act or occurrence creating a significant risk to your health or safety (as determined by us), or affecting our performance (each, a "Force Majeure Event"). In the event of a Force Majeure Event, we may in our sole discretion re-schedule Casino Marketing Boot Camp to a different date or host Casino Marketing Boot Camp virtually by providing you and other participants with remote access, in which event we will notify you by email (to the email address that you provided in your registration) of such changes. In the event of a Force Majeure Event and Casino Marketing Boot Camp is re-scheduled or held virtually, your registration fee will be applied to the Casino Marketing Boot Camp as re-scheduled or held virtually and you shall not be entitled to any refund. In the event of a Force Majeure Event and Casino Marketing Boot Camp is re-scheduled, you shall be permitted to substitute another of your employees to attend Casino Marketing Boot Camp on the re-scheduled date.
- 16. You are responsible for yourself and your employees and agents, and agree to indemnify, defend and hold harmless us and our officers, managers, employees, affiliates and representatives (collectively, the "Indemnified Parties") from and against any and all claims, demands, liabilities, damages, loss (including theft) or destruction of any real property or tangible personal property, personal injury or death, expenses (including without limitation attorneys' fees, court costs, expert witness fees and other expenses), and causes of action arising out of or relating in any way to the Casino Marketing Boot Camp, except to the extent caused by our breach of these terms and conditions, our gross negligence or willful misconduct.
- 17. We may revise these terms and conditions from time to time, for example to reflect changes in relevant laws or regulatory requirements or improvements we make to the Casino Marketing Boot Camp, in which event we will notify you by email (to the email address that you provided in your registration) of such changes.
- 18. These terms and conditions shall be governed by and construed in accordance with the laws of the State of Louisiana. You agree that any action brought by us or you under or in relation to Casino Marketing Boot Camp or these terms and conditions shall be brought in, and you agree to and do hereby submit to the jurisdiction and venue of, any state or federal court located in the Parish of Orleans, Louisiana.
- 19. If any legal action is brought by either party relating to these terms and conditions or the Casino Marketing Boot Camp, the prevailing party will be entitled to reimbursement by the other party of its reasonable attorneys' fees and expenses.
- 20. These terms and conditions are a contract between you and us. No other person shall have any right to enforce any of the terms.
