

# **Santa Maria Fairpark – West Coast Kustoms RV Camping /Trailer Parking– Terms & Conditions**

## **Fees:**

- 1) RV Camping = \$150 2) Trailer Parking = \$75 3) RV Camping & Trailer Parking \$225 (Friday & Saturday)
- Reservations: \$10 per transaction.
- All reservations must be made online at [SantaMariaFairpark.com](http://SantaMariaFairpark.com).

## **Check-In & Check Out Time:**

- Check-In Friday 10AM – 4PM at Gate 5. NO EARLY CHECK INS
- You MUST display reservation confirmation on dashboard on drivers' side of RV/Trailer or vehicles.
- Check in process is included in email confirmation.
- Check-Out Sunday by 5PM. PLEASE cleanup & remove all debris from your camp site.

## **Occupancy Guidelines:**

- Campers: Maximum of 6 guests per site. Please enter all campers name on registration form.
- Visitors are welcome during the car show hours, Saturday 8AM – 5PM and Sunday 7AM – 2PM. For the safety of the show and all campers please NO visitors outside of show hours.

## **Pet Guidelines:**

- Service pets are welcome & must have current registration & vaccinations.
- All pets must be cleaned up after and droppings must be properly disposed of in a trash receptacle.
- All pets must be kept on a leash (maximum 10 ft.) and are not permitted inside buildings.

## **Parking Policy:**

- All RV's, vehicles and trailers must have current license and registration.
- Upon check-in you will be directed to the assigned area for RV Camping & Trailer Parking.
- If you are RV Camping and bringing in a trailer you must pay for both RV Camping and Trailer Parking.
- There are NO utilities/hookups available. There are showers and restrooms available for use on site.
- All RV'S must be fully self - contained, NO tent camping. NO sleeping in cars or trucks.
- Trailers parked in Trailer Parking area are permitted for parking use only.
- RV Camping area is the ONLY area permitted for staying overnight.

## **Quiet Hours:**

- Quiet hours are from 10PM to 8AM - Generators may not be used during these hours.
- Please be courteous to other guests around you. Inconsiderate guests will be asked to leave.
- Loud, objectionable music or noise is not allowed at any time.

## Things to Keep in Mind:

- The upkeep of our facility and grounds is important, so we ask that you keep a clean camp area. If your camp site looks cluttered or unkept you will be asked to clean up or vacate the premises. NO dumping of excessive materials, liquids, or trash at any time.
- Management is not responsible for lost, stolen, or damaged articles. Keep valuables locked up.

## Park Policies:

- Observe the speed limit of 5 MPH. Reckless driving is not permitted at any time.
- No fires allowed. Fully contained BBQ grills and camping stoves are permitted.
- Drugs, weapons, fighting, lewd conduct are not permitted at any time.
- Alcohol not purchased at event MUST be kept within your RV Camping site or area. Public Intoxication is strictly prohibited pursuant to CA Penal Code 647 f.
- Smoking is prohibited in all indoor facilities and within 25 feet of any building.
- Motorized/non-motorized scooters and skateboards are not permitted.
- Profanity or violence towards others and the park team will not be tolerated.
- Report any problems with your site to the Fairpark immediately. Call 805-925-8824.

## Fairgrounds & Gate Access:

- When arriving you will be entering thru Gate 5.
- Should an emergency come up outside of car show hours please use Gate 1 for entry and exit. There will be a security guard posted at Gate 1.
- If you decide to cruise on Friday night with your show car, you will not be allowed to park back inside of the Fairgrounds until Saturday when the car show opens. NO EXCEPTIONS will be made.

## Cancellations/Refunds:

- Requests for cancellations are made on a case-by-case basis and must be in writing.

- All cancellations/refunds are subject to a \$35 Administration Fee.

## Adhering to Terms & Conditions:

- The Terms & Conditions must be adhered to, as well as any other directions given by the Santa Maria Fairpark. Any violators of the above policies will be asked to leave the property without refund of fees. Fairpark Management reserves the right to close the campground, either partially or entirely without notice.
- Pursuant to the CA Recreational Vehicle Occupancy Law, A "RECREATIONAL VEHICLE MAY BE REMOVED AS SPECIFIED IN SECTION 799.99 FOR FAILURE TO PAY OR FAILURE TO COMPLY WITH PARK CAMPING POLICY." CA Civil Code Sections 799.22, 799.43 and 799.58.
