



Terms and Conditions --- Drawing Rules

Each ticket will be given in return for a \$200.00 (Two Hundred Dollar) donation. Your ticket is a receipt for the drawing and represents one opportunity to win a 2017 Grand Sport Corvette or \$50,000 in cash. The winner will assume all responsibility for any applicable tag, title and sales tax. Donations for tickets are tax deductible.

Winning ticket holder does not need to be present to win.

Ticket entries will end approximately around 6:30 pm on September 28, 2017 or when all tickets are gone.

By participating in the drawing and receiving a ticket, winners agree to allow Vettes-4-Vets to release their names and use their likeness to promote the Corvette drawing, or to announce the winner. No compensation will be given for the use of photos and/or testimonials. Winners will also be listed on the website within 10 days of the drawing.

The Drawing is conducted by Vettes-4-Vets with the address of 1678 Montgomery Highway, Hoover, AL 35216. The Official Rules of the Drawing are set forth herein.
