Appearance Release, Authorization and Waiver of Rights

3. I hereby represent that any statements made by me during my Appearance are true, to the best of my knowledge, and that neither such statements nor my Appearance will violate or infringe upon the rights of any third party.

I hereby waive any right of inspection or approval of the Works, of my Appearance in the Works, of the uses to which my Appearance may be put in the Works, or of the Producers' use of my Appearance in connection with the promotion, sale or marketing of the Works. I acknowledge that the Producers will rely on this permission, potentially at substantial cost to the Producers, and hereby agree not to assert any claim of any nature whatsoever against anyone relating to the exercise of the permissions granted hereunder.

I understand that I shall not be entitled to nor shall I receive any compensation for the rights granted by me in this Appearance Release and that no compensation shall be payable to me at any time in connection with my Appearance in the Works or in any advertising, promotional or publicity materials used in connection with promoting the Works, or which are otherwise produced pursuant to this Appearance Release or the rights granted to the Producers by the undersigned in this Appearance Release.

6. I hereby assign and license to the Producers any and all copyright, literary or other rights that I may have in and to the Works or my Appearance in the Works. Such assignment and license shall be without reservation of any rights on my part, and I hereby waive all personal or proprietary rights with respect to the Works and my Appearance, and agree to hold the Producers harmless for any unauthorized use of my voice, name, physical likeness, or Appearance acquired by any third parties as the result of the distribution, promotion, or other use made of the Works (or my Appearance) by the Producers.

I hereby acknowledge that Producers have made no representations or warranties of any kind with respect to any medical or other advice or information that I may receive in connection with my appearance in the Works, and that I have not relied on any such representations or warranties in agreeing to participate in the Works or to execute this Appearance Release, Authorization and Waiver of Rights.
