

## Ticket Purchase Terms & Conditions

By purchasing a ticket to an event (each, an “**Event**”) organized, produced and/or hosted by Barstool Sports (“**Barstool**”, “**we**” or “**us**”), you unconditionally and irrevocably agree to the following terms and conditions, including the Event Guidelines below:

Your ticket is a revocable license for the listed date and time (unless rescheduled by us). Entry into the Event is strictly limited to people who are over such age we designate. We reserve the right, without the refund of any portion of the ticket purchase price, to refuse admission or to eject any person whose conduct is deemed by us to be disorderly or a risk to others’ health and safety, who uses vulgar or abusive language, or who fails to comply with the rules of the Event.

Unauthorized resale or attempted resale of an Event ticket is grounds for seizure and cancellation without compensation. Tickets obtained from unauthorized sources may be lost, stolen or counterfeit, and if so, are void.

Recording and transmitting any report, picture or reproduction of the Event is unauthorized, except for limited non-commercial purposes on your personal social media channels only provided that you are solely responsible for and required to obtain any and all permissions required prior to posting, including but not limited to music clearances, and that recording or transmitting any video in excess of fifteen (15) seconds long (regardless of whether it is a single video or series) is strictly prohibited.

You acknowledge that the Event may be broadcast or otherwise publicized, and hereby grant permission to us to use your image and/or likeness in connection with any live or recorded transmission or reproduction of the Event.

You may not bring alcoholic beverages, illegal drugs, controlled substances, cameras, recording devices, laser pointers, strobe lights, irritants (e.g., artificial noisemakers), bundles and containers of any kind into the Event.

This ticket cannot be replaced if lost, stolen or destroyed, and is valid only for the event for which it is issued. This ticket is not transferable or redeemable for cash. It is unlawful to reproduce this ticket in any form. The ticket price includes all applicable taxes.

**You hereby assume all risks and danger incidental to the Event whether occurring prior to, during, or after the Event, and you voluntarily agree that we and our affiliates, officers, directors, owners, employees, agents and representatives are expressly released from any claim(s) arising from such causes.**

Please respect the Event venue and avoid litter. The use of a ticket for advertising, promotions, contests, sweepstakes, giveaways, etc. without our prior, express written consent is expressly prohibited.

You bear all risks of inclement weather. Event date, time, location and talent subject to change.

All orders are subject to ticket availability and are not confirmed or accepted until we have collected and accepted payment and issued an order confirmation email. We reserve the right to cancel an order at any time if tickets are no longer available at the price advertised when an order is placed or the seats were mapped incorrectly. There are no refunds, exchanges, or cancelations on any ticket order for any reason. All sales are final.

All deliveries require a signature. You agree to provide us with a secure delivery location and authorize someone at that address to act as your agent in your absence to accept delivery of the package. You agree that we will have fulfilled our contractual obligation when tickets are shipped to the address provided by you. Your refusal to accept a delivery does not constitute a refusal of payment. You agree to be fully responsible for payment even if you refuse delivery or fail to pick up a ticket if alternative delivery is provided.

You agree that any dispute arising out of or concerning a purchased ticket or the Event, whether in contract, tort, or otherwise at law or in equity for damages or any other relief, shall be resolved only by final and binding arbitration pursuant to the Federal Arbitration Act, conducted by a single neutral arbitrator and administered by the American Arbitration Association in New York, NY. The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. The prevailing party shall be entitled to recover costs and reasonable attorney's fees. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the arbitrator.

Any arbitration will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. YOU AGREE THAT YOU MAY ONLY BRING CLAIMS AGAINST BARSTOOL OR ANY AFFILIATED PARTY IN YOUR INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING. Further, unless both you and we agree otherwise, an arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.

You agree to indemnify, defend, and hold Barstool and our officers, directors, employees, agents and contractors harmless from and against any losses, costs, liabilities and expenses (including reasonable attorney's fees) arising from your acts or omissions at or incidental to the Event. We reserve the right, at our own cost, to assume the exclusive defense and control of any matter otherwise subject to indemnification by you, in which event you will fully cooperate with us in asserting any available defenses.

In the event of any inconsistency or conflict between the terms stated herein and the terms contained in any applicable ticketing agency's terms of use/sale, the terms stated herein shall control. New York law shall govern these terms and any dispute arising hereunder or in connection with the Event.

## **ADDITIONAL EVENT GUIDELINES**

### What to Bring to the Event

- Your ticket
- Photo ID (see acceptable forms below)
- Festive yet comfortable clothing and shoes
- Smiles and good vibes!

### Prohibited Items

- Illegal substances
- Drugs or drug paraphernalia
- Glass, cans, cups or coolers
- Outside food or beverages (including alcohol and candy)
- Markers, pens or spray paint
- Weapons of any kind (includes pocket knives, pepper spray, fireworks, etc.)
- Balls or Frisbees
- Large purses, bags or backpacks (over 12"×12")
- Professional photo, video, or audio recording equipment (no detachable lenses, tripods, big zooms or commercial-use rigs)
- Pets

## Event Policies

- NO re-entry/ins & outs per day
- NO refunds or exchanges
- NO unauthorized/unlicensed vendors
- NO unauthorized solicitations, handbills, sampling, giveaways, etc.
- NO tailgating

## Acceptable Forms of Identification for Entry

- US government-issued driver's license or ID card containing a photograph and date of birth
- US or foreign government-issued passport containing a photograph and date of birth
- Foreign government-issued driver's license/ID with color photocopy of passport (not valid for 21+ wristband. To purchase alcohol or enter VIP areas (if any), a physical passport or US ID will be required.)
- Temporary DMV documents proving you are currently renewing a license — ONLY if accompanied by passport or expired license

## Unacceptable Forms of Identification for Entry

- NO school ID
- NO consular ID
- NO birth certificate
- NO expired ID of any kind
- NO photocopy of any ID (except as noted above)
- NO temporary DMV license without passport or expired license

## Security & Entry

Every attendee (including media) will be searched prior to entry. By purchasing a ticket, you agree to submit to a thorough, TSA-style search, including emptying your pockets and bags, a full pat-down, having all of your items examined, and possibly removing your shoes. Police and/or security officers may work both inside and outside the Event. All narcotics laws are strictly enforced. We reserve the right to refuse entry to anyone for any reason whatsoever.

## Zero Tolerance for Drug Use or Possession

The use or possession of any illegal drugs will not be tolerated anywhere inside or outside the venue. Do not bring any illegal substance to the Event; violators will be prosecuted to the fullest extent of the law. If you are found intoxicated at entry, security will not allow you to enter. Event staff reserves the right to refuse entry to anyone. Be responsible, and make smart choices.
