Dear Pastor,

Thank you for taking the time to read through the following information on Candidate Assessment. Communication is the key in assisting your young men and women in these beginning steps toward ordination. In the following pages you will find information that we hope will strengthen the process of giving and receiving a Local license, moving then to a District license, and ultimately to Ordination.

The Assessment Weekend is set for October 29 - 31, 2010, and is a requirement for each Local licensed minister who desires to apply for a District license this year.

For an applicant to attend the Assessment Weekend they will need to participate in the pre-testing available on Saturday afternoon, immediately following the closing session of District Assembly. The inventories they take that day include: Spiritual Gifts, Personality Profile, Pastoral Perceiver, and the Myers-Briggs Temperament Analysis. There is also a Spiritual Formation paper, a Praxis Inventory and Recommendations, which are to be completed **PRIOR** to and **SUBMITTED** on the day of testing.

Statement of Purpose

The purpose of the Assessment Center is to aid the Reynolds Institute and the Ministerial Credentials Board in identifying the process needed for a ministerial candidate to prepare for pastoral ministry. It is also to aid the candidate in their self awareness and preparedness for pastoral ministry.

The Assessment Center will implement testing, evaluations and interviews with each candidate. This information will be used to help the institute formulate the steps for ministry preparedness for each candidate.

- ! Spiritual Gifts
- ! Myers Briggs
- ! Pastoral Perceiver
- ! Personal References
- ! Recommendation of the local church

The areas of self awareness and preparedness that the Assessment Center will focus on are:

- ! The spiritual formation of the candidate.
- ! The emotional health of the candidate.
- ! The candidate*s understanding and acceptance of the seriousness and responsibility of the call of God to the pastoral ministry.
- ! The areas of ministerial skills that a candidate must have and continue to develop.
- ! The expectations of the Church of the Nazarene for those called to pastoral ministry in the Church of the Nazarene.

The perpetuity and efficiency of the Church of the Nazarene depend largely upon the spiritual qualifications, the character, and the manner of life of its ministers. (MANUAL, P. 401)

Board of Ministerial Credentials

Policy Statement

Assessment Center

1. All persons who apply the first time for a District Minister's License will be required to attend the Assessment Center prior to their interview by the board of Ministerial Credentials for consideration of their request for a District Minister's License.
2. District Licensed Ministers who transfer to New England will be required to attend the Assessment Center. Persons who have attended an Assessment Center on another District will not need to attend the NED Assessment Center.
3. Individuals who choose not to renew their District Minister's License and later request reinstatement of their License shall be required to attend the Assessment Center prior to the issuing of a new License.
4. Any person whose District Minister's License is not renewed due to failure to meet the Manual requirements for renewal and who in a succeeding year applies for a District Minister's License shall be required to attend the Assessment Center.
5. The Board of Ministerial Credentials reserves the right to request any individual to attend the Assessment Center, although prior Assessment experience may exempt a person from New England District's requirement.

- ★ All applicants for a district license **must attend** the Assessment Weekend.

The Candidate:

- ! Verifies the call of God - has reviewed self-examination questions in the “Handbook for Those Exploring a Call to Ordained Ministry.”
- ! Has a supportive relationship with his/her Pastor.
- ! Currently holds a Local License and has been licensed for at minimum of one year with annual renewal(s) of license by the Church Board.
- ! Has been recommended by vote of the Church Board for Assessment and for a District License.
- ! Has read and understands the sections of the *Manual* pertaining to Ordination - “Call and Qualifications of the Minister” (400-401.5) and “The Licensed Minister” (427-427.10).
- ! Submitted the Registration for the Assessment Week end by May 21, 2010, with a deposit of \$165.00, check made payable to Reynolds Institute.

Preparation for the Assessment Week end:

- ! Attend the district testing day [with spouse attending as well, if at all possible] on the Saturday afternoon following the District Assembly, at 1:00.
- ! All of the following **must be completed** and submitted by the district test day (the Saturday afternoon following the District Assembly):
 - < Praxis Inventories (pp. 7-12)
 - < Spiritual Autobiography (p.14)
 - < Spiritual Disciplines and Practices Inventory (p. 15)
 - < Two personal references
- ! Take Myers Briggs, Spiritual Gifts, Pastoral Perceiver on the test day.

The spiritual formation component of the assessment process provides ministerial candidates with the opportunity to:

1. Articulate an understanding of and response to the call to be conformed to the image of Christ.
2. Take inventory of and evaluate specific spiritual disciplines and practices.
3. Discuss with Center staff spiritual challenges, obstacles, and resistances.
4. Receive spiritual guidance.

To be Completed by and Submitted on the District Assembly Test Day

In order to take advantage of the opportunities described above, candidates must bring the following items with them to the Reynolds Institute Test Day at District Assembly:

- 9 1. Spiritual Autobiography (directions below)
- 9 2. Spiritual Formation Ministry Philosophy Statement (directions on p. 18)
- 9 3. Checklist of Spiritual Disciplines and Practices (directions & form on p. 18)
- 9 4. References (directions and form on p. 19)

1. Spiritual Autobiography

Write a personal narrative of your spiritual journey by responding to the following questions in a typewritten document. These questions are designed to guide your writing, but should not preclude you from including other relevant material. A spiritual autobiography should demonstrate careful reflection on your own faith development process.

- 1 Write about your earliest memories on your faith journey. Did you come from a Christian home? What contributions and/or hindrances did your family members make on your spiritual development? Who first helped shaped your view of God?

- t Write about other significant influences, e.g., church people, church life itself. Have you experienced a variety of religious traditions or have you always been in the Church of the Nazarene? Who have been the important spiritual role models in your life as you have matured? What authors have influenced you the most and what do you read for spiritual nurture?
- t How has your faith changed/grown? With what issues or in what areas have you struggled? Discuss ways in which the church has been helpful and/or hurtful to you in your Christian journey. What have been important experiences and/or crises?
- t How have you learned to incorporate discipline and accountability into your life (e.g., in your finances, your education, your professional work, your physical health)? What spiritual practices shape your spiritual life and how do you connect with others in these disciplines? If married, how would you characterize the spiritual relationship (including the shared practices) you have with your spouse?
- t What areas of your life do you sense God leading you to work on this next year? What resources would be helpful?

2. Spiritual Formation Ministry Philosophy Statement

Write a brief essay (2-3 typewritten pages) in response to the following question: *Spiritual formation is the process by which a person is 'conformed into the image of Christ.' As a pastor or staff member of a congregation, how would you develop this process in the lives of your people?*

3. Checklist of Spiritual Disciplines and Practices (submit a photocopy of completed pp. 16-17 on the Test Day)

Spiritual formation, like any other area of our lives, requires intentional effort on our part to achieve strength and maturity. The athlete exercises, the musician rehearses, and the student studies. Likewise, the Christian must practice spiritual disciplines if he or she expects to be “rooted and established in love...and filled to the measure of all the fullness of God.” (Eph. 3:17-19) Different Christians may practice spiritual disciplines to different degrees and in different combinations at different points in their lives but conscientious, intentional participation in these disciplines on an ongoing basis is essential for our spiritual growth. Many of the classic spiritual disciplines are listed below.

Please check the boxes that most accurately represent your current practice of each of the disciplines. As is the case with athletes, musicians and students who require a teacher or coach to reach their maximum potential so the Assessment process is one way in the area of spiritual formation for you to receive this kind of mentoring. Dialogue with the Center for Spiritual Formation Staff will help you to assess the strengths and weaknesses of your practice of the spiritual disciplines so that you can continue to be equipped spiritually for the work to which God has called you.

Historically Christians have believed that it is God who calls men and women into ministry and it is obedience to that call that leads people to make personal commitments to the pastoral office. We affirm that the call to ministry is of God and not of man. We affirm that the church is God's creation and that the call to ministry is God's call. The invitation is of God and from God. Ministry is response to God's divine call upon the life of one who is fully committed to Him.

The church is God's creation and the avenue through which the office of pastoral ministry is conducted. The church is charged with the responsibility of affirming and confirming the call that God places upon the lives of men and women. It is the church which provides opportunities for those who are called to use their gifts to extend the borders of the Kingdom.

Today you begin the long journey of preparation to answer the call that God has placed upon your life. There will be times when the call to ministry is very strong and pulses within you heart and there will be times when the call seems distant. Be encouraged that God has called you. Never fail to respond to His divine initiatives.

As a "steward of the divine mysteries" you are being called to be a shepherd of the souls for whom Christ died. With ingleness of purpose you must glorify God in your conduct and character. Ministry properly conducted is an outward sign of an inward grace. As you prepare for ministry consider the privileges and responsibilities associated with shepherding. You must be presently convinced that the ordained ministry is the best way to fulfill your call from God. Consider the following:

Ministry goes beyond the *Transference of Knowledge* it is *Teaching*. One must be able to communicate Christian teaching in a "tolerant and gentle" yet disciplined way. H Timothy 2:23. Yours is not to simply communicate facts, you are to incarnate the truth of the Gospel. People will look to you for answers, resist the temptation to answer them in your own strength. Learn to point them to Jesus as the hope of glory. You will have the privilege of instructing men and women in the faith. Be responsible.

Ministry goes beyond the *Retelling of the Story* it is *Preaching*. "I give you this charge: Preach the Word; be prepared in season and out of season; correct, rebuke and encourage-with great patience and careful instruction." You must learn to plumb the depths of God's Word so that you can preach the Word of God with conviction. Today's culture does not need another voice, the Church of the Nazarene needs to hear the voice of

God. Preaching will be a significant component of your ministry. Don't be tempted to take shortcuts in your preparation. People are hungry for the Word. Prepare it well, serve it well and call for people to make decisions for Christ. Remember, you are handling the Word of God. Be responsible.

Ministry goes beyond the *Skilful Response It is Individual Pastoral Care*. Be to be an example to believers "In speech and behavior, in love, fidelity, and purity" R Timothy 4:12. God will entrust sheep to your care in the days ahead. Learn to be a good shepherd by spending time with the shepherd of your soul. Learn to take your flock to places of nourishment and strength. You are called to be an "ambassador of Christ, and envoy from the King of heaven. Take the role of a servant and learn to wash peoples feet. Be an encouragement to those who grieve, share words of joy with those who celebrate and offer hope to those in despair. From the cradle to the grave you will have the responsibility to care for the souls of men and women. Be responsible.

Ministry is beyond the *Manipulation of Structures it is Organization*. The Scripture says, to be "ready for any honorable form of worle' Titus 3:1 Organization is a significant component of any effective ministry. it will require you to hone your skills and to recognize the high trust placed in you. You will be required to discharge your duties with a sense of deconmi and expertise. Allow this to be an area that reflects your complete dependence upon God. You are an overseer of the church of God. The church was bought with the blood of Jesus. Be responsible.

Ministry goes beyond the *Protective Ritual it is Celebrating*. You will be called upon to "Make full proof of thy ministry." Celebrating the completed work of Christ will bring joy to both you and the congregation that you serve. Spend adequate times in personal preparation before you attempt to lead.

Church Board Interview Guidelines for Local Ministers License

(To be used also for recommendation for a district license.)

One of the more serious considerations for a local church board is the interview of a man or woman who senses a call to pastoral ministry. Your interview should be prayerful, careful and thorough. It is your responsibility to only license those who meet the requirements of the manual.

426.1 "The candidate must first be examined as to his or her personal experience of salvation, knowledge of the doctrines of the Bible, and the order of the church; he or she must also demonstrate that the call is evidenced by grace, gifts and usefulness."

The local church pastor should work closely with the candidate mentoring him or her toward a thorough understanding of the call and qualifications of pastoral ministry in the Church of the Nazarene.

I. SALVATION AND LIFE OF HOLINESS

1. Please share briefly and specifically how and when you became a Christian.
2. Describe for the committee what your spiritual growth has been since you became a Christian; what has the process been like for you?
3. What is your experience of entire sanctification?
4. What evidence have you and others seen in your life of this experience?

II. SPIRITUAL FORMATION

1. Share with us your spiritual disciplines in the following areas:

! devotional time with God	! fasting	! prayer life
! worship	! mentoring	
! bible study practices	! examining the motives and attitudes of your heart	
2. Do you believe the bible to be the inspired word of God; that it is our ultimate authority in what we believe and how we are to live? How would you defend this belief? What scriptures speak to this belief?
3. Credibility demands that we live what we preach. Where is God at work in transforming you to Christlikeness right now?
4. Comment on the challenges you face as you seek to be Christlike.

III. CALL

1. Share with us how God called you to the pastoral-preaching ministry or full-time service.

4. Do you willingly respect and submit to authority?
5. Do others view you as relating in socially mature and appropriate ways?
6. Have you been in a relationship with a spiritual mentor? What are the benefits? What are the frustrations?
7. Are you willing to be in a mutual accountability relationship as part of your spiritual formation process? Will you make an effort to be accountable to someone?

V. CHURCHMANSHIP

1. Why do you believe God has called you to pastor in the Church of the Nazarene?
2. Have you studied, understood and accepted the beliefs and polity of the Church of the Nazarene as found within our Church Manual; in particular, the Articles of Faith; General and Special Rules; the Call and Qualifications of the Ministry (p. 400-401.5) and the Duties of a Pastor (p. 413-419)?
3. Are there areas in which you are struggling with acceptance?
4. Do you find biblical support for, and do you practice the faithful giving of tithes and offerings?
5. What areas of ministry are you involved in? What do you feel is the positive impact on your church and community?

Note: If the candidate is given a local license the senior pastor needs to enroll them by sending a letter to the secretary of the district board of ministerial studies.

“The minister of Christ is to be in all things a pattern to the flock - in punctuality, discretion, diligence, earnestness; in purity, understanding, patience and kindness; in the Holy Spirit and in sincere love; in truthful speech and in the power of God; with weapons of righteousness in the right hand and in the left” (2 Corinthians 6:6-7).

The minister of the gospel in the church of the Nazarene must have peace with God through our Lord Jesus Christ, and be sanctified wholly by the baptism with the Holy Spirit. The minister must have a deep sense of the fact that souls for whom Christ died are perishing, and that he or she is called of God to proclaim or make known to them the glad tidings of salvation.

The minister must likewise have a deep sense of the necessity of believers going on to perfection and developing the Christian graces in practical living, that their “love may abound more and more in knowledge and depth of insight” (Philippians 1:9). One who would minister in the church of the Nazarene must have a strong appreciation of both salvation and Christian ethics.

The minister must have gifts as well as graces, for the work. He or she will have a thirst for knowledge, especially of the Word of God, and must have sound judgment, good understanding, and clear views concerning the plan of redemption and salvation as revealed in the Scriptures. Saints will be edified and sinners converted through his or her ministry. Further, the minister of the gospel in the Church of the Nazarene must be an example in prayer” (Manual 401 - 401.4).






