ALL WRESTLERS WITH BRACES ON THEIR TEETH MUST HAVE PROTECTIVE MOUTH GUARDS

All wrestlers will be grouped by both age category and weight into **4-man brackets**. Each wrestler will wrestle one-another giving each wrestler a total of **3 matches (round-robin format)**. There are many advantages to doing this. Medals will be awarded for 1st, 2nd and 3rd place wrestlers.

Age Groups-

Age Categories, Start Times & Period Length: **A minimum of 20 minutes must be allowed - between wrestlers matches, unless agreed upon by the coaches for a shorter time.**

TECH FALLS will occur when a 12 point margin is achieved, this rule applies to all age groups

- A wrestler can move up one age group with the permission of the tournament director, provided this request is made before bracketing is completed. A wrestler can only compete in one bracket for each session, either the morning or afternoon session. The only division that can wrestle in both morning and afternoon is the Intermediate 10U division, because the wrestler can wrestle in the morning session as an Intermediate 10U and move up one division to Novice 12U for the afternoon session The coach requesting the division change must show their current coaches card. Therefore, this request cannot be made by anyone without a coach's card.

- Club's director or designated person for that club will check in with the Tournament Director, inform the Director of any known NO SHOW wrestlers and pay for their team's entry. Note: There are no refunds for no-shows – each club is responsible for full payment.
- All wrestlers must check in by the end of the Weigh-In and Skin Check time period to verify they do not have any contagious skin conditions. Wrestlers will not be admitted into the tournament if they are not checked in on time.
- It is the responsibility of the Club Directors, or the designated person for that club, to check with the head person running the Weigh-in area to see if any of their wrestlers have not checked in by 8:30am for the morning session and 12:30 pm for the afternoon session.

Notice:

Head gear Will be required for all age groups this is a USA Wrestling rule.

If an individual has hair longer than allowed by rule, it shall be contained in a cover so that the hair rule is satisfied. (Photo 4) and a legal hair cover shall be attached to the ear guards. Physical hair treatment items that are hard and /or abrasive such as (beads, bobby pins, barrettes, pins, hair clips, etc. or any other hair-control devise) shall not be permitted, A legal hair-controlled devise such as rubber band(s) shall be secured so as not to come out readily during wrestling.

Registration-

- **Pre-registration-**
- Only Sanctioned USA Clubs may submit tournament registrations
 - Wrestlers who are not attached to a sanctioned club are requested to contact the nearest sanctioned club to register with or the Tournament Director.
 - **Last-minute USA Wrestling cards must be purchased at www.usawmembership.com PRIOR to the Wednesday before the tournament.**
 - Pre-registered wrestlers who do not show up for the tournament will be charged the full registration fee. The submitting club is responsible for this fee to be paid the morning of the tournament along with all the other registered wrestlers on the registration form.
 - All registrations must be accompanied with a valid USA Wrestling card number for each listed wrestler

Out-of-state wrestlers-

- *May pre-register with the condition that they follow the same rules that USAWCT Clubs follow.*
- *Out-of-state wrestlers must contact the tournament director to register their team. Each Wrestler must have a current USA Wrestling Card. The Out-of State Club must provide the following to the Tournament Director to pre-register.... Name, USAW#, Date of Birth, Club Name.*
- The Tournament Director will reply to your email confirming receipt of your registration.

- All registrations must be accompanied with a valid USA Wrestling card number for each listed wrestler.
 - **Walk-ins**
- Absolutely NO Walk-ins permitted.
 - **Registration Fee's**
 - \$20/wrestler
 - 1st wrestler = \$ 20
 - 2nd wrestler = \$14
 - 3rd & 4th & 5th wrestler = \$ 8
 - **Spectator admission**
 - **\$3.00 admission fee / Free age 12 and under, or if you hold a current USA Coaches card.**

Weigh-ins-

- *All Wrestlers will report for skin check and be weighed in before Tournament starts. Weights reported by Coaches will be corrected in the system, if there is more than a 2 lb. difference. This Rule applies to all Tournaments. Brackets will be made off of the adjusted weights.*
- ✓ The tournament director must notify Dave Kanute d.kanute@cox.net within 2 days of any excessive weight registration issues or challenges.
- ✓ When weighing-in, each wrestler must weigh-in wearing a competition singlet or shorts.
- **A Madison weight class system will be followed. All wrestlers will be grouped relative to both their age and weight. There are no published and strict weight classes to follow during the regular season. The maximum weight distribution will be no more than 10%, without coaches' approval.**

The Code of Conduct Rules will be strictly enforced.

Coaches and Spectators Conduct--- This code of conduct has been established to ensure that there is a defined method for the handling of unacceptable conduct by coaches at USAWCT sanctioned wrestling events. The responsibility of the assigned officials and the USAWCT Board of Directors is described in the document posted on the website (www.usawct.org)
