FROM THE DESK OF:





Dear Friends,

In the days of the horse and buggy, the founder of The Salvation Army, William Booth, saw the plight of the poor and the needy. The people were living in poverty in the slums of London, and many were left to die, destitute on those streets. He believed humans were infinitely valuable and deserving of care. He noted that "When the cab horse is down, he is helped up; while he lives, he has food, shelter, and work. The men and women of the slums were not treated half as nice." So, into action he went to help up those who were hungry, homeless, and overlooked by society.

The same actions taken by Booth in 1890, echo into the action we have taken since, including today. In 2024, The Salvation Army of La Crosse provides shelter for men, women, and children - we serve all - with compassion, expertise, professionalism, and purpose. Helping people move from homelessness into permanent housing is our goal. Additionally, our public lunch meal program doubles as a thermometer for public need, and, based on the steady growth of the free meals we provide, the need is increasing.

Homelessness is a complicated problem and is difficult to solve. There are those that have a myriad of obstacles to overcome, and we are blessed for the steady, hard work of our staff and of our volunteers. Innovation, problem solving, and grit are used to bring about the achievements by the individuals we care for each day.

We are blessed to partner with the City of La Crosse and La Crosse County for Pathways Home. The plan is ambitious and demonstrates the reality of poverty. We continue to work alongside our many partners to bring about the possibility of accomplishment. Our role is vital to the plan and will continue to serve those in crisis.

We are happy to present to you this annual report. Our dedication remains helping those in need, stewarding resources, promoting personal growth, and moving souls closer to relationship with God.



FROM THE DESK OF:





After seeing all that has been accomplished by The Salvation Army of La Crosse in 2024, I am excited to see what will happen in 2025 and beyond.

There is much that can be said about our work in 2024. We saw greater than a 30% increase in the meals we serve to the public. To meet this need, we thank both the public and private organizations for their food donations. We continue to serve 64 individuals each day and each night. There has been a larger, more concerted effort to help those who come to stay at The Salvation Army, with far more than (just) shelter. We have expanded our offerings of classes, including Eight Dimensions of Wellness and Rent Smart. Additionally, there are weekly Bible Studies, Alcoholics Anonymous, and Narcotics Anonymous (AA/NA) meetings. 2024 has also been marked with an increase in partnerships. One example is the participation with Pathways Home, coordinated by the City of La Crosse and La Crosse County. In many ways, 2024 built upon 2023 and both were foundational building years for what is to come in 2025.

What will 2025 look like? A year of Doing the Most Good. This continues the call to action for the "Why" and the "How" to guide The Salvation Army of La Crosse, including the staff, the Advisory Board, and the volunteers, in its practice. Noting an increasing need, we are looking for community members to raise their hand and join us and speak into the decisions of The Salvation Army in La Crosse. We are looking for additional Advisory Board and Committee members who exemplify what it is to Do the Most Good for our neighbors in need. Our primary focus continues to shelter, even while looking at the gaps of need in our community and finding those who value collaboration. When compassion meets resources, we can fill the hearts of those who are in need.
