

partnerships in the Philadelphia Anti-Trafficking Coalition and

# Education & Prevention





Crucial to the fight against trafficking is prevention and education. After four years as an advocate, Molly Ferris began as the first Prevention Education Specialist for New Day. She has updated and created new trainings and facilitated the completion of our 45-Hour Human Trafficking (HT) Advocate training, a comprehensive awareness & prevention training for advocates. This equips staff with the skills needed to support survivors.

## **Drop-In Center**

The Drop-In Center began new partnerships this year with Mural Arts and Philadelphia Legal Assistance. Survivors have covered a wall in bold colors, honest reflections and encouraging messages, becoming a **symbol of hope**.

Philadelphia Legal Assistance has run a bi-weekly legal clinic for survivors. Survivors have been able to have their legal barriers removed allowing them to access safety and self-sufficiency.

# Police Assisted Diversion (PAD)



PAD has increased engagement with law enforcement through VICE and FBI human trafficking operations. Prior to New Day's involvement survivors of exploitation were arrested. Through advocacy these individuals are **now connected to life-saving services** rather than a criminal justice response.

### New Day New Home

New Day New Home completed its first year in our new space and of HUD funding. This included the **launch of our Rapid Rehousing Program** where we can move individuals into their own apartment and support with rent for up to 2 years! New partnerships were created to offer **more therapeutic** services through equine therapy, herb therapy, a recovery group, and an onsite therapist.
