Additional Information:

- Groups cannot exceed 100 people in total.
- Groups must maintain a ratio of 1 Adult: 10 Children (7 years and older).
- Groups must maintain a ratio of 1 Adult: 6 Children (6 years and younger).
- If there are extra guests (more than the amount of reserved, prepaid guests) that arrive to use the Aquatics Center with your group on the day of your event, **they will be charged the peak rate of \$7/ child and \$13/ adult.**
- No refund will be issued if your party arrives short of the expected number of guests.
- Groups are limited to one visit per week.
- Please arrive no earlier than 15 minutes prior to your reservation time.
- Renters will be charged \$25 per 15 minutes that their party stays after the allotted rental time ends.
- In the event of inclement weather, renters may not have access to a space in which to eat meals.

KROC POOL RULES

- Children under 5 years must be accompanied by an adult that is also swimming.
- Children under 12 years must be supervised by an adult.
- All swimmers must shower before entering the pool.
- No shoes are allowed on the pool deck.
- No cotton clothing is allowed in the pool.
- Children who are not potty-trained must wear swim diapers (see a lifeguard for assistance).
- The minimum height to use the waterslide is 48 inches (4 feet).
- No food or beverages are allowed in the Aquatics area.
- No outside toys or water accessories are allowed in the pool.
- Everyone must change in the locker rooms during the allotted swim time.
- **Violation of pool rules or rental conditions will result in the forfeiture of your security deposit.**

RENTAL CONDITIONS

- Renters may not move furniture or fixtures.
- No confetti, glitter, or tape on the walls or floors. Poster putty is permitted.
- Parties must be booked and paid in full a minimum of 14 days in advance.
- Please arrive no more than 15 minutes prior to your party’s start time and depart no later than 15 minutes after.
- The Salvation Army is not responsible for the loss or damage of any equipment, supplies, or property belonging to the renter or party attendees.
- Organizations/ Individuals are required to clean up after all events. Garbage must find its way to the proper containers.
- Renters are responsible for having the space(s) cleaned and vacated no later than 15 minutes after the specified time on your rental contract.
- Alcohol, smoking, and drug use is prohibited on The Salvation Army property.
- If you cancel your event 7 or more days prior to the event date, you will receive credit towards a future party/ event, minus a \$25 booking fee.
- Cancellation of your event less than 7 days prior to the event date will void your payment and you will not receive any refunds.
- **No refunds are given unless the event is cancelled by the Kroc Center. Any refunds will be given in the form of a check.**
